The Master asked the Guardians for directions regarding the Infirmary Kitchen in which there is occasionally a blow down

Referred to Mr. B. W. Laughlin.

The Master further reported that the police at Fressroad had a child, about 4 months old, which was deserted by its mother, conveyed to the Workhouse.

In connection with this matter, Mrs. W. Bonnell, Promote, asked the Guardians to allow her some payment for all her trouble in keeping the child for 3 days when she got no sleep, and she lost another day bringing the child to the Workhouse.

On the motion of the Chairman it was unanimously decided to allow this woman 10/- for her trouble. The L.G.B. will please pay

The Report of the Visiting Committee was read, and Orders given them as follows:—

If the Guardians can legally pay this amount— If this woman had not brought the child a car would have had to be obtained by the Police.

Ordered "that in the absence of the Master, the Porter sees that the cows are properly feed"

Letter no 8587 date 22nd July 1916 sanctioning the payment of 3/6 a day to the person employed as Shoemaker at the workhouse, 4/6 to the mason, and 6^d an hour to the carpenter.

Letter no 7422 date 16th July 1916 requesting that they may be furnished with duplicate copies of the Requisition for supplies of medicine, etc. for use in the Phanorlas Dispensary.

The clerk stated that he had complied with this request on the 14th inst.

Letter no 8, 958, date 26th July 16 returning the Requisitions and stating that they consider the quantities of drugs ordered are somewhat large and that the items marked might be reduced if the goods have not already been supplied.

The clerk stated that he had acquainted the Medical Officer, Dr. Johnston, with the contents of foregoing letter, and a reply was received from him which the Guardians considered satisfactory. Ordered that Dr. Johnston's letter be sent to the L.G. Board and it is herewith transmitted.

Letter from L.G.B. no 2085 date 2nd March 1916 stating that they approve of the alterations proposed to be made in the dietary of the inmates. They also approve of the elimination of the "additional" meal except in the case of attendants and children.

Letter from L.G.B. no 10247, date 29th July 16 forwarding the accompanying enclosures to a communication which they have received from the Commissioners of National Education relating to their district Inspector's last report on the Workhouse School.

The following is a copy of the Inspector's Minute of the result of the inspection.

The teacher is attentive and careful; and the school is, on the whole, making fair progress. Some of the writing is good, but arithmetic needs improvement. The children are clean and tidy; and the school is well kept.

The Guardians considered the report satisfactory and ordered a copy of it to be sent to the teacher.

Circular letter from L.G.B. date 29th July 16 forwarding their Prescribed Lists of Medicines and Medical Appliances for the year commencing on the 1st April next and describing the procedure to be followed when making orders which the Clerk stated that he had followed.

relating to the proposal to grant a sum of £4 a year to the porter of the Workhouse in lieu of a sack of clothes and stating that having regard to the concession made to Mr Quinn's predecessor the Board will raise no further objection in the matter.

The Clerk submitted the letters from Doctors Johnston and Merrigan declining to accept the reduced fee of £1.1.0 for consultation in dispensary cases, as proposed by the guardians.

In connection with this matter Mr G. B. wrote under date 19th May no 22249, pointing out that a proposal to alter the scale of fees for extra professional assistance rendered to the medical officers, should be considered after notice of motion, and also after consultation with the medical officers.

No action was taken in the matter.

The resolution of the Athlone Union, advocating the holding of 'yearly' instead of half yearly audits, was left with the L.G.B. to deal with.

Read Letter from L.G.B. date 14th May 1916, respecting the Daylight Saving Scheme and the Summer Time Bill which has now received the Royal assent.

The Clerk stated that he had got the printed notices, which accompanied this letter prominently displayed in the terms of the letter, regarding the clocks of the Workhouse, have been complied with.

Mr James W. Blay⁹ contractor for Sugar, wrote requesting to be allowed the extra duty of 4/8 per cent in this article.

Similar applications have arisen in other Unions and the L.G.B. have referred the matter to the Law Officers of the Crown, who have now given the following opinion:
(1) that the contractor is entitled to charge the full duty
(2) that he is so entitled when his contract binds him to deliver (though it does not bind the other party to receive) the sugar.
The increased price made by the Sugar Commission need be regarded as ordinary market fluctuations and the contractor is not entitled to any additional payment in respect of them.

It was agreed to allow Mr W. Blay the extra duty claimed.

Letter from L.G.B. no 18,009, date 30th May 1916 stating that the inmates of the Workhouse, including those acting as attendants, must be dieted as set forth in the prescribed dietary table and in no other manner.

The Board are surprised to learn that all the healthy inmates, with the exception of the children, are now classed as attendants. The inmates should be properly classed under the headings set out in the dietary table and only those whose whole time is occupied in some particular duty should be classed as attendants.

Resolved " that the additional meal be allowed the aged and infirm classes, as these people as engaged in useful works and complaints have been made by them that a quantity of bread for the dinner meal is not sufficient.
that the classification be revised under the proper headings, this has now been done.
The Guardians regret not having given the new dietary

The Medical Officer of the Whouse, Dr Johnston reported "that during the past week I had to have 11 children from the Whouse School removed to the Fever Hospital suffering from mild scarlatina. There is an objectionable drain coming from the laundry to which I have directed the master's attention, which probably caused the outbreak.

The master stated that he got this drain cleaned and asked the Guardians to inspect it as it gets often stopped and a larger pipe might be required.

The Guardians inspected the drain and ordered a new gully trap and the trap leading from Hall to yard to be reset.

The Board accepted the proposal of James Boulstone to supply a ton of straw at £4:0:0. The Tender of Maxwell, Quers for the best white lead at 48/- per cwt delivered at Stranorlar Station, was accepted.
