The Master reported that Lady Hayes, Drumboe gave the inmates a sumptuous treat on the 2nd of the year consisting of tea, cake, pastry, fruit &c also Toys for the children and Tea, sugar, Snuff & Tobacco for the adults.

Ordered "that the Clerk convey to Lady Hayes the thanks of the Guardians for her generosity to the inmates."

The Master also reported that owing to the high horse being ill he was obliged, on the requisition of the medical officer to employ a temporary high horse, at £1.5.0 a week and 4/- a week in lieu of rations approved.

The Report of the Visiting Committee was read, and Orders given them as follows:—

The following Letters from the Local Government Board for Ireland and others, were read by the Clerk, and directions given him to answer them respectively, to the following effect (or, orders made on them respectively), as follows:—

The Clerk submitted the annual Estimate and demand of the Guardians to meet the probable liabilities of the Union during ensuing financial year.

The Estimate was approved of. Letter from Local Govt Board date 3rd Jan 1917 drawing the attention of the Guardians to the great necessity of making full use of the production of food, of the lands held by them as appurtenances to the Workhouse.

The Guardians wish to point out that all the available lands attached to the Workhouse are under cultivation.

The Clerk laid before the meeting the LG Board's letter of the 15th ultimo, no 59,747, as recorded on the Minutes of the proceedings of the Guardians at their meeting on the 18th ultimo, together with Dr Johnston's letter which accompanied it asking the Board to call upon the Guardians to pay his substitutes' fee of £44.0 during his absence at Belfast assizes.

The Clerk having read the foregoing correspondence

a letter was read from Dr Johnston stating that by arrangement with Dr Kerrigan they are willing on the present occasion to allow the matter to lapse.

The Matron applied for and was granted two weeks leave owing to illness.

(Mrs McMenamin, Foster Parent of the boarded out boy, Samuel Pwery, appeared before the Guardians asking to be allowed to adopt the boy as he had now reached the age of 15 years.)

James McGranaghan applied for a further instalment of £6 for furnishing the Workhouse.

Referred to Committee

The Medical Officers of the Union, Dr Johnston, Gormley and Kerrigan, applied to the Guardians to fix a scale of salaries applicable to their offices.

The Doctors point out that for the last 40 years their salaries remained at the minimum of £100 a year while their duties have become greater and involved increased expenditure. That a graded scale of salaries at present exists in 105 out of 158 Unions in Ireland, that their salaries are paid almost entirely out of Government and Estate Duty Grants, and works out at one fifth of a penny in the £ on the rates of the Union. The Doctors suggest that the following scale of salaries be fixed viz an initial salary of £120 a year with quinquennial increments of £10 till a maximum salary of £180 per annum be reached. This is less than is granted by most Unions financially and economically less strong than this Union.

The Medical Officer of the Workhouse also applied to the Guardians asking them to fix a graded scale of salaries applicable to his office.

Mr Kelly gave notice that at the meeting of the Guardians to be held on Monday, the 22nd day of Jan I will move that all resolutions fixing the salaries.

of medical officers of the Union including the M. O. of the Workhouse be rescinded and that the question of fixing a graded scale of salaries for the medical officer be considered.

Resolved that the B of Board be requested to inform the Guardians if in the event of the salaries of the medical officers being increased will the Government's grants in aid of the rates be proportionally increased or will the whole increase of the salaries be borne by the rates.
