TERMS & CONDITIONS FOR PARKING PERMIT HOLDERS

- Donegal County Council has transferred its physical permit system to a virtual permit system and as such you will no longer be issued with a physical permit. Our system will store your vehicle registration and our Traffic Wardens will scan your number plate to establish if you have a valid permit.
- Whilst the Council issues renewal notices to all permit holders, the responsibility for the renewal of each Car Parking Permits rests solely with the permit holder. Fixed penalty notices will not be waived by presenting a permit at a later date.
- Permits are only for **LETTERKENNY TOWN Long Stay Car Parks** and are not valid on-street or in any other car park.

LONG STAY CAR PARKS

1. **Port Road / Grill Car Park** – small Car Park which lies on the southerly side of the Ramelton (Port Road) and opposite the old cinema.
 2. **Justice Walsh Coach Car Park** – located just above and to the East of McGinleys carpark (Lower) and accessed from Justice Walsh Road.
 3. **Courtyard Middle Deck** – middle deck of the Car Park behind the Courtyard Shopping Centre and West of the Pearse Road.
 4. **Skittle Alley Car Park** – opposite the Convent Road / R250 (Slate Row) junction.
 5. **Manderley Car Park** – Accessed from Lower Oliver Plunkett Road
 6. **Mart Site Car Park** – Located on the old Mart site at Sentry Hill.

- Out of date permits are invalid and will result in a fixed penalty fine if Pay and Display ticket is not displayed.
 - In the event of the permit holder changing their vehicle, the holder must notify Donegal County Council.
 - Once issued, permits are non refundable.
 - Donegal County Council reserves the right to revoke or cancel a permit at any time if deemed so necessary.
 - A permit does not guarantee the holder a parking space in any given car park, this is subject to availability.
