## C/542/13 APOLOGIES

Apologies were received from Clrs. Byrne and McEniff who were unable to attend the meeting.

### C/543/13 CONTINUATION OF THE MEETING IN COMMITTEE

On the proposal of Clr. Mc Brearty, seconded by, Clr. M. Mc Bride, it was resolved in accordance with Section 45 of the Local Government Act, 2001 to continue with the meeting in committee. At the request of the Mayor, the Members of the Media in attendance vacated the Chamber.

## C/544/13 <u>ADJOURNMENT OF THE MEETING</u> On the proposal of Clr. O' Domhnaill, seconded by, Clr. Mc Gowan, it was resolved to adjourn the meeting and deal with the remaining items on the agenda of the Adjourned September Meeting.

C/545/13 <u>RECEPTION OF DEPUTATION FROM THE GLENTIES</u> <u>WINDFARM INFORMATION GROUP</u>. Members welcomed Mr. Ernan O' Donnell , Mr. Peter Crossan, Planning Consultant and Ms Siobhan Browne, from the Glenties Windfarm Information Group to the meeting. Following a brief introduction by Mr. O' Donnell, Mr. Peter Crossan, Planning Consultant informed Members that the purpose of the presentation was to set out and put in context the reasons why Donegal County Council and its Elected Members should consider minor amendments to a variation of the County Development Plan 2012-2018. He contended that recent refusals by An Bord Pleanala with regard to wind farms at Straboy, Glenties and at Altnagapple in Ardara further substantiated this claim. There were, he suggested, a number of conflicting issues in the County Development Plan, noting that in particular the zoning "open to consideration" currently affected over 2,300 town lands in the County. It was claimed that this was at odds with the requirements of a number of European Directives relating to the environment and the European Court regarding specific environmental impacts.

Mr. Crossan alluded to the fact that the Planning & Development Act, 2010 (as amended) required a Strategic Environmental Assessment pursuant to the EU Habitats Directive, a process that required consideration in the drafting of the County Development Plan. The current plan, he suggested, failed to meet these objectives.

During the course of the presentation detailed information was provided in relation to the following;-

- 1. The statutory basis for a material variation of the County Development Plan.
- 2. Obligations under the various SEA, Habitats, Environmental Directives etc and the fact that the County Development Plan is required to be subject to assessment under specific criteria including the interrelationship between biodiversity, population, human health, flora and fauna, soil and water, air and climate, material assets, cultural heritage and landscape.
- 3. An overview of the specific policy context including the assertion that the various directives as outlined above needed to form part of the consideration of all zoning decisions with specific obligations on the local Authority to protect the receiving environment and the residential amenity whilst taking cognisance of Government Policy regarding renewable energy in the County.
- 4. Overall impact of the European Communities Environmental Objectives (Freshwater Pearl Mussel) Regulations 2009.

- 5. The related ecological impact of wind farm developments including specific reference to the displacement of peat entering water courses and general sensitivity of fresh water ecology.
- 6. Socio and economic impact of wind farm development.
- 7. Noise and health impacts with specific reference to the appropriate separation distance of this type of development.

Concluding the presentation, Mr. Crossan advised of the need to take account of the cumulative impacts associated with wind farm development, the importance of the local environment and its sensitivity to change. He outlined the necessity of implementing the proposed variations in order to protect societal interest and to comply with the requirements of EU legislation on the environment in the interests of biodiversity. He called on Members to recognise the fact that there was an urgent need to exclude from wind farm development the Sub- Basin District of the Owenea for obvious environmental reasons. He advised also of the need to provide for a meaningful set back distance for all wind farm development.

Clr. O' Domhnaill said that it was regrettable that millions were being spent on the protection of the fresh water pearl mussel in Donegal yet wind farm technology was now contributing to their overall demise. He advised of the need to re-visit the wind farm policy in the County Development Plan with specific consideration in relation to the overall set back distance. This, he confirmed , needed to be included on the agenda of the next Planning SPC. He advised also of the need to reimburse local communities affected by this type of development.

Clr. Mc Brearty welcomed the presentation and said that he was appreciative of the opportunity to listen to both sides of the argument. He applauded the fact that the group did not operate under any specific political influence.

Clr. Gallagher alluded to the comprehensive nature of the presentation. She outlined the need to amend the policy in the interests of the people of Glenties, and for the overall protection of rural communities in Donegal. She questioned whether or not a planning decision in favour of the developments at Straboy and Altnagapple would stand in a court of law.

Clr. Campbell said he was of the opinion that there were serious flaws and weaknesses in the County Development Plan as adopted and thus queried ;-

- The balance if any that was required in relation to the rezoning of areas and the requirement of this authority to provide a strategic approach.
- The need for further elaboration in relation to the noise and health impact of wind farm development together with the associated set-back distances.

The Mayor thanked all who had contributed to the debate, acknowledging the rights of local communities to have their concerns listened to, and adequately addressed.

Mr. Crossan replied to a number of queries raised by Members and advised of the following:-

- That the regulations were clear and the catchment areas for fresh pearl water mussel needed to be looked at again in terms of compliance with national and EU Directives.
- Regarding the ecological impact of peat displacement it was confirmed that it was impossible to mitigate against sediment entering into the water courses.
- That the areas in question needed to be re zoned out of wind farm development given the serious physical and ecological impacts mentioned.
- The need for overall balance and the maintenance of the County's diverse natural environment.
- The average maximum height of a wind turbine applied for in Donegal was 125m.
- With regard to noise and health impacts it was acknowledged that there was a significant body of evidence to support the existence of these factors and thus it would be prudent to introduce a set-back distance based on ten times the tip height of the turbines as an absolute minimum.

Concluding his presentation, Mr. Crossan advised that there was only a 23 % annual return on any given turbine and that in the USA there was a concerted move away from wind farm development on the basis of its efficiency capabilities. Ms Siobhan Browne, addressed Members at this juncture giving a passionate description of the impact that this type of development was having on her home and family life. She asked Members to take heed of the concerns raised by local residents as failure to do so would result in many young families being forced to move out of their native communities.

Mr. Crossan and Mr. O' Donnell thanked Members for the attention and advised of the urgency to deal with matter in a logical and compassionate manner. It was acknowledged that the issue had divided many local communities and that vulnerable landowners in rural communities were often put at risk. Many of the issues raised they noted needed to be dealt with promptly otherwise the taxpayer would in the long-run bear the brunt of the associated fines.

Clr. Mc Brearty on a point of order advised that he had specific issues in relation to Minute C/472/13 and was of the opinion that the minute in question did not reflect the intent of Clr. Mc Eniff's motion.

Clr. Blaney enquired as to whether or not he was questioning the accuracy of the minutes and if this was possible given that Clr. Mc Brearty had not been present at the meeting in question.

Clr. Mc Brearty again reiterated the need for legal opinion in relation to the accuracy of the minute and the fact that it did not accurately reflect what was said in relation to Travellers nor includes comments made by other Councillors. He asked that previous advice provided by the Council Solicitor in relation to the accuracy of the minutes be read out for the benefit of the Members.

Mr. Liam Ward, Meetings Administrator confirmed that the advice received in relation to a similar query clearly indicated that all Members had the right to raise an issue regarding the accuracy of the minutes, on the basis that they were either inaccurate or incomplete, and subject to the agreement of those Members present on the day in question. He acknowledged that whilst he did not have the information to hand, the advice outlined above was reflective of the response provided by the Council Solicitor. He asked Clr. Mc Brearty to outline in detail what he believed took place on the day and thus allow for further consideration.

Clr. Blaney thus proposed, seconded by, Clr. O' Domhnaill, to adopt the Minutes of the Meeting of Donegal County Council held on the 30<sup>th</sup> September, 2013.

Clr. Mc Brearty stated that he wanted to have it recorded that he did not support the motion as put forward by Clr. Mc Eniff. Clr. Murray also expressed a similar view.
