APPLICATION FOR PERMIT

Under Article 59 of the Road Traffic (Construction and Use of Vehicles) Regulations 2003 (S.I. No. 5 of 2003).

APPLICANTS SHOULD NOTE THE FOLLOWING

1. Permits under Article 59 are intended to deal with
 - a) Vehicles normally used in places other than a public road and used on a road only occasionally when travelling to or from such places
 - b) Vehicles carrying an **INDIVISABLE** article of such dimensions as to contravene the Regulations.
2. Before making an application for a permit, the applicant must give to the commissioner of the Garda Síochána (In this Regulation referred to as the "Commissioner") 4 clear days' notice of such application, and such notice shall be accompanied by a copy of the application for the permit. Saturday, Sunday and any public holiday (within the meaning of the Organisation of Working Time Act 1997 (No. 20 of 1997)) is not included in the reckoning of the 4 days' notice.
3. **ANY APPLICATION TO DONEGAL COUNTY COUNCIL MUST BE ACCOMPANIED BY A NOTICE FROM THE COMMISSIONER ACKNOWLEDGING RECEIPT OF THE APPLICATION, WITH ATTACHED LIMITATIONS OR CONDITIONS.**
4. The application shall contain an undertaking by the applicant to refund to Donegal County Council the amount of any damage caused to any public road by use of the vehicle under the permit which may be granted as a result of the application, provided that a claim for such refund is made by Donegal County Council before the expiration of twelve months from the last date when a vehicle is driven on the public road under the permit.
5. The applicant may be required, as a condition to the issue of the permit, either to deposit with the application, a sum sufficient to cover the amount of any such damage, or to furnish other sufficient security.

6. Donegal County Council may attach to the permit any limitations, restrictions or conditions (including particular conditions as to weight, dimensions, speed, number of trailers, springs, tyres and wheels) which they consider advisable to prevent unnecessary damage to public roads or which, after review and/or consultation with the Commissioner, they consider expedient to protect other road users.
7. A permit shall at all times be carried on the vehicle to which it relates, or on the vehicle drawing the trailer to which it relates.
8. A permit is valid for the period of 12 months from the DATE OF ISSUE of the permit or for such lesser period as may be stated in it.
9. Where a vehicle, in respect of which a permit has been issued, is being used in contravention of any condition attached to the permit, Donegal County Council may withdraw it. Where Donegal County Council proposes to withdraw a permit it shall give 21 day's notice of such intention to withdraw it to the holder and shall consider any representations made by the holder within that period.
10. Applicants should note that an incorrect or incomplete application form will result in the permit application being refused. Further details may be requested by Donegal County Council to substantiate details submitted in the application form. If requested, this must be furnished before a permit is granted.
