On the proposal of Cllr McMahon, seconded by Cllr Sweeny the Minutes of the Roads Workshop of the Municipal District of Donegal held on the 10th August 2023 were confirmed.

MDD/116/23 HOUSING & CORPORATE SERVICES REPORT

HOUSING SERVICES

Progress reports on Casual Vacancies, Grants, Loans, Tenant Purchase Scheme 2016, HAP Tenancies, Housing Need, Housing Capital, Approved Housing Bodies Development, and Lease & Repair Scheme

Ms McCann advised that works to the existing casual vacancies is ongoing with the majority of the houses due to be completed by mid-October. The keys for the 16 units at Oak Meadows have been received and it is expected Letters of Offers will issue later in the week. Ms McCann also submitted that the contractor overseeing the energy retrofit project in Killybegs is making good progress.

On behalf of the Housing Capital Office, Ms Quinn submitted that the Phase 3 housing development at Railway Park is substantially complete, and it is expected the handover will take place in early October. The Phase 1 Drumacrin Project in Bundoran has progressed to Stage 4 and a request is currently with the Department to appoint the successful contractor. The SI in Kilcar is due to be tendered shortly and investigations are ongoing with the Fintra Road site in Killybegs. Ms Quinn further submitted that the design is currently being finalised with the Laghey site and contractual matters are being concluded with the 5 no. 2 bedroom turnkey properties at

Rockview in Ballyshannon. The proposed 35 no. turnkey units in Donegal Town is awaiting Departmental approval.

A number of comments / queries were dealt with as follows:-

New Housing Developments

Cllr Jordan welcomed the completion of the additional 16 units at Oak Meadows and noted that these allocations will assist in reducing an element of the housing need within the Donegal Town area.

Cllr Kennedy noted the gross housing need of 27 for Killybegs and submitted that the construction of new housing developments should be expedited as the housing need figures are on an upward trajectory. Cllr Kennedy sought a report on how many houses have been purchased since the beginning of 2023.

Cllr Naughton also welcomed the completion of the 16 units at Oak Meadows and sought an update on the Laghey site. Cllr Naughton submitted that the expression of interest process in relation to suitable parcels of land for social housing development appears to be slow to move forward.

Cllr Sweeny welcomed the refurbishment of the long-term void in Ballyshannon and expressed his frustration at the delay in finalising the completion of the 5 no turnkey units in Ballyshannon and emphasised the importance of concluding the contractual matters as soon as possible. Cllr Sweeny sought an update on the negotiations in relation to the derelict site in the centre of Ballyshannon.

Ms McCann submitted that in order to reduce the housing need within this MD, along with the various housing developments proposed within the major towns, the Housing Office is also actively pursuing single acquisitions. Ms McCann agreed to provide details of the number of houses purchased since the beginning of 2023.

Ms Quinn acknowledged the timeframes in progressing projects and agreed to seek a detailed update on 5 no. units at Rockview in Ballyshannon as well as an update on the discussions taking place in relation to the derelict site in Ballyshannon. Ms Quinn advised that the Laghey site is complex and is aware that engagement is ongoing with the relevant landowners and will revert with comments following a meeting scheduled to take place this week.

Phase 1 Drumacrin, Bundoran

Cllr McMahon expressed his frustration in the delay in progressing the Bundoran housing development and emphasised the importance of ensuring a Traffic Management meeting takes place in advance of the construction works commencing. Ms Quinn submitted that she would feedback Cllr McMahon's comments to the Housing Capital Team and noted the importance of the Traffic Management meeting.

Croí Cónaithe Scheme

Cllr McMahon noted the benefits of the Croí Cónaithe scheme, however, submitted that some applicants are struggling financially to commence the works in advance of the grant payment. Cllr McMahon sought an update report from the Regeneration Unit.

Cllr Naughton submitted that a major time delay factor in processing these applications was awaiting the Engineers approval to proceed with the project.

Cllr Sweeny sought clarification in relation to the possibility of using the Croí Cónaithe letter of offer as security for funding from a number of financial institutions.

Ms McCann agreed to seek an update from the Regeneration Officer.

EERW Project

Cllr McMahon noted that a number of houses within the Gaelic Park Housing Estate in Bundoran required new windows and doors and queried when the energy retrofit works will take place in Bundoran. Ms McCann highlighted the benefits of the energy retrofit works and agreed to feedback Cllr McMahon's comments to the Engineer.

MDD/117/23 ROADS / TRANSPORTATION SERVICES REPORT

2023 Roadworks Programme Status Report

Members noted the reports on the Road Works Programme circulated with the agenda and Mr Sweeney advised that due to the recent spell of good weather the Roads Section have progressed a number of projects within Area 14.

Follow up Issues from the previous meeting

Mr Sweeney provided an update on the follow up issues from the previous meeting, as circulated by email, that dealt with the following matters: -

Mountcharles Road Safety Issue

Cllr Jordan has advised the area office of the location of the safety issue where two separate vehicular accidents have occurred on the N56 at the Glen Mountcharles in recent months. The Roads Office then contacted the Garda to see if they were able to provide a view on the cause of these accidents and they advised that the accidents happened in May and June 2023 and road conditions or road markings were not a contributing factor.

Conclude the High Road at Kilcar Take Over

Discussions are ongoing with the local Parish Council on taking the High Road in Kilcar in charge. Options are being considered to cover

the cost of surfacing works on this road in advance of taking it in charge process commencing.

Relay the points raised in relation to Teelin Pier & Harbour with the Marine Engineer

An email was sent to the Marine Engineer on 12th June 2023 outlining the points raised at the meeting in relation to Teelin Pier.

Active Travel Projects - Monitor the flashing lights within Dunkineely

This matter was referred to Road Central who manage the contractors who look after the maintenance of the school flashing lights on 20th June 2023. Road Central advised that the contractor is currently waiting on approval from the TII to upgrade these lights to include solar panels.

Arrange a meeting with a landowner to discuss the footpath repair works in Pettigo

The area office has met with the landowner and have commenced the process of drafting a sale agreement for the necessary lands to facilitate the proposed works.

Proceed with amendment to RI Programme 2023

The RI programme has been amended to reflect the agreed change.

Convey Members best wishes to Donal Murphy EE

This message was relayed to Donal Murphy on 12th June 2023

Other Items:

M Sweeney also submitted the following items by e-mail for consideration by the Members:-

New Area Engineer

I wish to advise the Members that Jonathon Mulhern has recently been appointed as the new Area Engineer as a replacement for Donal Murphy.

Dunkineely to Killaghtee

The National Roads Office have advised that they have secured funding to commence scoping works and survey works to assist in the possible development of an active travel project to help address the issues previously raised by the Members about pedestrians walking along this narrow section of the N56 National Secondary Route between Dunkineely and Killaghtee.

Also, as part of these scoping works, consideration will be given to extending the footpath out as far as the GAA pitch on the eastern side of the town that was also raised by the Members at a previous MD meeting.

Tullyleague Junction on the N15

The Road Safety Engineer and the National Road Office have reviewed the issue raised by the Members in relation to right turning vehicles off the N15 onto the Tullyleague road and have advised that all lining and signage is in line with current standards and there is no accident history at this location. They are, however, aware that the reported issue is still occurring despite the road layout being to standard. To resolve this issue consideration could be given to closing the junction off the N15 into Tullyleague as there are alternative access routes into the Tullyleague area. The Road Safety Engineer and the National Road Office also advised that the TII do intend to review the N15 between Donegal and Ballyshannon in the future but had no definitive date as to when this review will be carried out.

Donegal Town One Way System

The area office wishes to advise the Members that a contractor has been appointed to carry out the works associated with the implementation of the Donegal Town One Way System. Arrangements are currently being made to have a prestart meeting with the Contractor to discuss a start date and programme duration etc. Further information when known, will be provided on the Council Social media platforms to inform the public of the works.

A number of comments / queries were dealt with as follows:-

N15 Road Safety Issues

Cllr Jordan noted that the removal of the right-hand turn lane has increased the risk of accidents at this junction and motorists wishing to turn right off the N15 at this junction are in fear of being rearended by other vehicles as the hard shoulder is being used as a climbing lane. Mr Sweeney advised that the TII will be carrying out a safety review on the N15 and will consider this junction along with the Tullyleague Junction but as noted above, had no definitive date as to when this review will be carried out.

Dunkineely

Cllr Jordan welcomed the scoping and survey works to address the road safety issues between Dunkineely and Killaghtee and also welcomed the review of the flashing lights at Dunkineely.

Cllr Kennedy queried who will be carrying out the scoping and surveying works for the proposed Active Travel application for the road between Dunkineely and Killaghtee and queried the proposed costs.

Cassan Sound Takever

Cllr Jordan welcomed the High Road, Kilcar takeover and emphasized that the Cassan Sound road also requires taking over.

Mr Sweeney advised that work is ongoing in the background in relation to the Cassan Sound take over.

Bruckless Bus Shelter

In response to Cllr Kennedy's query in relation to the Bruckless Bus Shelter, Mr Sweeney advised that the NTA are reviewing the current list and will be speaking to the Area Offices about the works necessary at each of the locations they are willing to fund.

Teelin Pier

In response to Cllr Kennedy's query in relation road lining on Teelin Pier, Mr Sweeney agreed to follow up with the Marine Section.

Fintra Bridge

Cllr Kennedy sought an update on the Fintra Bridge Re-alignment Project. Mr Sweeney advised that an e-mail has been received from Road Design advising that the project will be tendered in one part rather than two parts and it is anticipated it will go out to tender in October with an expected construction commencement date in early 2024.

Cloghore, Ballyshannon

Cllr McMahon highlighted the road traffic concerns expressed by residents living between Rockfield School and the Celtic Wave junction at Cloghore, Ballyshannon and queried if it was possible to reduce the grass verges and ensure the roadside is maintained to facilitate good vision lines. Cllr McMahon submitted a young wheelchair user who attends Rockfield School is unable to make her way to school without the use of a vehicle, despite living within a short distance of the school. Cllr McMahon further submitted that the cottage located adjacent to the Celtic Wave junction is constantly under threat of being flooded and sought an update on a possible solution to this ongoing issue. Both Cllr Naughton and Cllr Sweeny concurred with Cllr McMahon comments.

Mr Sweeney agreed to relay this issue to the Roads Safety Engineer to review. He also submitted that a budget of approximately €80,000 is required to carry out remedial works to alleviate flooding concerns in this area. Mr Sweeney agreed to continue to explore funding options to help alleviate this flooding.

Roads & Footpaths

Cllr McMahon submitted that there is an issue with the road surface adjacent to the Filling Station on approach road from the East End of Bundoran and queried which company was carrying out manhole investigations. Mr Sweeney agreed to investigate the roads surfacing issue and advised that the company carrying out manhole investigations are the contractors working for NBI who are rolling out broadband in the Bundoran area and are investigating if fiber optic cables can run in the existing ducting between the existing manholes.

Cllr Naughton welcomed the commencement of the footpath works in Pettigo.

Donegal Town One Way System

Cllr Naughton welcomed the commencement of the Donegal Town One Way System and noted that the implementation of the project will ultimately reduce the level of traffic congestion within the town centre.

Road Signage

In response to Cllr Naughton's query in relation to adding Drumark to the Ballydevitt sign, Mr Sweeney agreed to investigate same.

Lighting

Cllr Naughton commended the Killymard Community Improvement Scheme and queried if it was possible to erect 2 additional public lights at the Killymard graveyard. Mr Sweeney advised that it was policy to reduce the number of public lights in rural areas, however, suggested the funding for same may be obtained from the Members Public Lighting fund.

In response to Cllr Naughton's query in relation to the switching on of the lights at Laghey Bridge, Mr Sweeney agreed to investigate same.

Donegal Town Roundabouts

Cllr Naughton noted the works carried out at the Tullyearl roundabout to facilitate windmill lorries and queried if it was possible to consider the erection of public art feature on this roundabout and on the Donegal Town/Ballybofey roundabout. Cllr Sweeny suggested making contact with Wind Farms in relation to possible funding.

Mr Sweeney submitted that the Area Roads Office has been working with the Tidy Town Committee regarding the upgrading of the Tullyearl roundabout and noted that the larger roundabout adjacent to the Public Service Centre would facilitate a feature, however, funding and safety concerns must be taken on board.

Roads Staff

Cllr Naughton welcomed Jonathan Mulhern to the Roads Office and Cllr Kennedy wished to convey good wishes to Thomas Hegarty on his recent retirement. Mr Sweeney acknowledged Mr Hegarty's 47 years of service and advised that a request for his replacement is with the HR Section.

Road Improvement Programme

In response to Cllr Sweeny's query in relation to additional funding for Ballyshannon streets, Mr Sweeney advised that the reallocation of funding as previously agreed will be included in the next batch of minutes, and subject to funding being available after these works are completed, additional works on College Street will be considered.

Rock, Ballyshannon

Cllr Sweeny queried if the parking area outside Saimer Childcare Centre could be reallocated to set down only parking and sought a solution to the upgrading of the Rock Steps.

Mr Sweeney noted the level of work and funding required to repair the Rock Steps and agreed to investigate the set down only parking at Saimer Childcare Centre.

Housing Estate Funding

In response to Cllr Sweeny's query in relation to the commencement of the works at Cluain Barron, Mr Sweeny confirmed these works will be completed in 2023.

Ballyshannon / Bundoran Cycleway

In response to Cllr Sweeny's query in relation to drainage works adjacent to the houses on the Ballyshannon / Bundoran road, Mr Sweeny advised these works will be completed in conjunction with the cycleway project.

Bus Eireann Workshop

Cllr Conaghan wished to acknowledge the meeting held with the Bus Eireann representatives recently.

MDD/118/23 ECONOMIC DEVELOPMENT, INFORMATION SYSTEMS & EMERGENCY SERVICES REPORT

On behalf of the Economic Development, Information Systems and Emergency Services Directorate, Ms McBride submitted that a successful promotional trip to Chicago and Milwaukee took place recently and the #LoveDonegal 2023 day is scheduled for the 14th September. The Tip O'Neill Irish Diaspora Awards ceremony will be held on the 16th September 2023 and the North West City Region are holding a collaborative event on the 4th December. Ms McBride also highlighted a number of Enterprise Office events including an Asia Matters business event scheduled to take place on the 2nd and 3rd October.

A number of comments / queries were dealt with as follows:-

Ireland West Airport

Cllr Kennedy noted the record passenger numbers for Ireland West Airport and sought a further breakdown of the incoming and outgoing passenger numbers. In response, Mr Martin advised that Donegal County Council provides an annual financial contribution to the airport and agreed to seek a further breakdown of the figures.

Donegal Tourism – Associate Members Committee

Cllr Kennedy noted that the Tourism Report referred to an e-mail released to all members advising of details of the new committee members for the Donegal Tourism Associate Members Committee. Cllr Kennedy sought further clarification in this regard, as a number of members have not received the correspondence.

TIDES Project

Cllr Kennedy referred to the TIDES project which is currently promoting 3 pilot VR sites in the county and sought to ensure that the VR equipment purchased for Killybegs and Burtonport is installed when the construction works have been completed. It was noted that the TIDES project is concluding and Ms McBride agreed to ascertain details on the VR equipment for Killybegs and Burtonport.

Outdoor Dining Projects

Cllr McMahon sought details of the commencement date for the Westend Outdoor project and Cllr Naughton sought an update on the Donegal Town Outdoor Dining Project. Cllr Conaghan also made enquires in relation to the works to the Diamond and Pier in Donegal Town. Mr Martin advised that the tenders obtained for both the Bundoran and Donegal Outdoor projects exceeded the budget available, and negotiations have been ongoing to source additional funding. There is a commitment to deliver both projects and it is expected commencement will take place shortly.

Camper Vans

Although Cllr McMahon wished to highlight that Donegal welcomes all visitors to the county, he sought a workshop to discuss the ongoing issues with camper vans who are not respecting the caravan and camping code of conduct. Mr Martin noted the detailed strategy in place for the caravan and camping sector and welcomed the proposal to hold a workshop.

Shared Island Projects

Cllr Sweeny welcomed the progression of the Shared Island Projects, particularly the Regenerative Tourism projects which are located within the Donegal MD. Mr Martin advised that the feasibility studies are nearing completion, and it is expected a number of business cases will be completed and utilised to seek funding from the Department to implement the projects.

All-Ireland Strategic Rail Review

Cllr Naughton expressed his disappointment that the Donegal MD is not included in the current rail plan and urged members of the public to make submissions as part of the consultation process. Cllr Naughton emphasised the importance of a rail link to Donegal, particularly in terms of tourism, health and the reduction in carbon emissions. Mr Martin noted that the advisory document lacks content

for Donegal and observations will be forwarded by the 29th September.

MDD/119/23 ENVIRONMENT SERVICES REPORT

Ms Bogan presented the report for the Environment Section, as circulated with the Agenda highlighting with the following matters:-

- Waste & Litter Management
 - Keep Donegal Beautiful Sustainable Holidaymaker Campaign
 - Summer Greenpiece 2023
- County Laboratory
 - Public Service Announcements (PSA's) Water Quality
 - Bathing Waters 2023 Season
- Flood Relief Scheme (FRS) Unit
 - Donegal Town Flood Relief Scheme

Ms Bogan noted the report which contained details on waste and litter management as well a water quality and bathing waters report.

A number of comments / queries were dealt with as follows:-

Beach Access Mats

In response to Cllr Sweeny's query in relation beach access mats for wheelchair users, Ms Bogan agreed to refer the query to the Coastal Officer.

Rossnowlagh Portaloos

Cllr Sweeny advised he had received a number of complaints in relation to the condition of the portaloos in Rossnowlagh and emphasised the importance of constructing permanent toilet facilities that are connected to the water and sewer mains. Ms Bogan agreed to relay Cllr Sweeny's comments to the Management Team.

Lifeguards & Emergency Services

Cllr Sweeny commended the lifeguard service provided during the summer season and Cllr McMahon wished to convey his thanks to the emergency services who played a vital role in a rescue operation in Bundoran last weekend.

Bottle Banks

In response to Cllr McMahon's query in relation to the dumping of waste beside bottle banks, Ms Bogan advised that the Council are awaiting receipt of the Commencement Order to allow for the use of CCTV in prosecutions. Cllr McMahon wished to acknowledge the service provided by the local Tidy Towns Committee in Bundoran and the TÚS workers as well as the Litter Warden, Martin Burke. Cllr

McMahon also recommended the appointment of an additional Litter Warden.

Air Pollution

In response to Cllr Kennedy's comment in relation to an unpleasant odour along the Shore Road in Killybegs, Ms Bogan agreed to relay the comments to the Laboratory Section.

Water Quality

Cllr Kennedy advised she has received reports that the water quality at St John's Point is poor and queried if sample bottles could be made available for collection. Ms Bogan agreed to relay the comments to the Laboratory Section.

Septic Tanks

Cllr Jordan sought clarification in relation to a couple who did not originally register the property's septic tank, however, have since carried out works in 2023 and are querying if they can make a claim under the Septic Tank Grants Scheme. Ms Bogan agreed to seek clarification.

Attendance of Representatives from Bus Eireann

(i) Expressway Services

- 1.0 Cllr Conaghan welcomed all attendees to the Workshop and following a round of introductions, invited Mr Yates to make a presentation.
- 2.0 As a follow up to the previous meeting held in the earlier part of the year, Mr Yates provided an updated on the progress within the Expressway's Five Point Plan for Donegal. In terms of Capacity, Mr Yates submitted that a relief coach was added to four daily Route 32 trips in July and August as well as providing additional services for the Rory Gallagher Festival and the Sea Session Festival in Bundoran. Mr Yates further submitted that Reliability on Expressway services in Donegal has increased steadily each quarter to 99.8% in Q2 2023 and expressed his remorse at an incident that occurred in July at Dublin airport whereby passengers arriving off flights with prebooked tickets had no Donegal bus service. Over 90% of services leave within 10 minutes of scheduled departure time and it was noted that the Sligo roadworks, Donegal Town traffic congestion and Ballybofey roadworks can lead to additional delays. The Bus

Eireann representatives wished to emphasis the streamline online booking facilities and the value for money to be obtained by prebooking tickets and young adults and students utilising the Leap Card facility.

3.0 A number of comments / queries were dealt with at the workshop. The Members expressed their dismay in relation to the Dublin Airport incident and suggested a private operator should have been utilised when no Expressway bus was available. In response to staffing queries, the Bus Eireann representatives submitted that since COVID, recruitment has become challenging, and a number of measures have been put in place to attract suitable drivers as well as a Customer Service Agent was recruited for the Summer Season to provide an information service at Dublin airport. In terms of actions, Bus Eireann agreed to share customer feedback in relation to wayfinding, facilities and services and to follow up with the NTA in relation to Leap Card agents within Donegal. Bus Eireann also agreed to monitor the number of fleet deployed with toilet facilities for the Route 30 / X30.

(ii) Traffic Congestion in Donegal Town and Bus Parking on the Diamond

4.0 M Sweeney provided an analysis of the number of users and their specific timeframes for utilising the bus parking facilities outside the Abbey Hotel in Donegal. It was noted that delays due to traffic congestion / roadworks on the approaching journey to this specific stop can cause several transport users utilising the bus stop simultaneously. In order to reduce the traffic congestion in this area and provide more appropriate facilities such as wheelchair accessibility, covered waiting room and toilet facilities, Mr Sweeney advised discussions have commenced with a local landowner who is developing a site some 400 metres from the existing bus stop. In order to seek NTA approval with this Transport Hub proposal, Mr Sweeney and Mr Martin sought Bus Eireann's approval in principle for the suggested relocation of the bus stop. welcomed the discussion and noted that Bus Eireann would not be in a position to fund the proposal but suggested that perhaps a leasing agreement or a private business model could be appropriate. In order to consider the proposal further it was agreed Mr Sweeney would forward the User Analysis Worksheet along with a copy of the presentation to Bus Eireann. Bus Eireann agreed to carry out a number of reviews and committed to respond by the first week in October. Bus Eireann agreed to circulate details of an appropriate NTA contact to discuss possible Bus Hub funding options as well as updating the Council on service changes once NTA licences for Expressway services have been approved. Bus Eireann also agreed to update the Council on new accessible bus stops.

(iii) School Transportation

5.0 As school transportation is operated independently, Mr Yates suggested making contact with Fiona Scanlon, School Transportation Manager. It was agreed the Fiona's contact details would be circulated.

(iv) Follow Up Meeting

6.0 It was agreed to arrange a follow up meeting in approximately six months.

2. House Acquisition Programme & Buy & Renew Programme

The Council is currently in the process of acquiring 2 no. units under the Buy & Renew Programme at Donegal Town. This acquisition will see 2 no. long-term vacant properties brought back into productive use for social housing purposes. Significant works will be required to the properties following the completion of the contract stage and in advance of letting.

The Donegal MD is considering expressions of interest for potential house acquisitions throughout the municipal district as well as considering options advertised on the market.

3. Social Housing through Turnkey Acquisition

Donegal County Council's turnkey acquisition process is continuing throughout the county. This competitive dialogue procurement process will result in a major capital investment in social housing and initial projects have now been completed under this process. This is a very effective mechanism enabling the Council to feed into the design of the proposal so as to ensure that the end product is suitable for the needs of social housing tenants. Proposals are subject to meeting the requirements of the procurement process, planning, departmental approval and contract.

Construction works to the approved turnkey development at Brookfield, Donegal Town are now complete. The development provides a total of 38 no. high quality and energy efficient social housing units in Donegal Town.

A further development of 5 no. 2 bedroom properties at <u>Ballyshannon</u> is complete. Final contractual matters are now complete, and the units are in the process of being handed over to the approved applicants.

In addition, Council officials are continuing to dialogue with Developers in relation to an additional valid proposal for Donegal Town for 35 units. This proposal has now received its connection offer from Uisce Eireann. A Stage 3 approval request was submitted to the department in August 2023; subject to approval, the Developer will be issued with an Invitation to Submit a Final Tender and final approval will then be sought from the department. Members will be fully informed of these proposals upon receipt of final departmental approval.

4. Lands / Property for Social Housing Purposes

The Council is planning to develop further projects on existing landbank in various locations throughout the county. Preliminary designs are underway for a number of these sites and are informed by the pertaining approved social housing need at local level.

In parallel with the construction and turnkey programmes outlined above, the Council is actively pursuing the acquisition of lands suitable for housing purposes, in towns and villages where there is currently not a social housing solution available / shortfall.

In addition to the current expression of interest advertisement on the Councils' website for parcels of land, derelict sites / buildings with the potential to deliver social housing, the Council is also separately identifying parcels of land with social housing potential in areas of need.

Shared Island Funded Projects Update

North West RegTech Initiative is a proposal to develop an all-island national institute in Regulatory Technology in the North West with partners DCSDC, Catalyst and ATU. Work is well underway by the appointed consultants (Stratagem Partners) for the Scoping/Feasibility Study and Business Case/Economic Appraisal for completion by the end of October 2023. **Navigating the Future of Regulation** conference is planned for 25th October 2023 in ATU Letterkenny (see above for info).

Crossborder Innovation Plaza to develop cross-border innovation campuses in Ballyshannon and Irvinestown in partnership with Fermanagh and Omagh District Council (FODC). Following scoping and consultation the sectoral scope has been expanded to also include provision for non-food/renewable options. Site appraisal and benchmarking are well underway by the appointed consultants with development options due early October 2023. The completed Feasibility Study, Economic Appraisal/Business Case is on track for delivery by early November 2023.

Regenerative Tourism Project is a proposal to develop a cross border slow tourism destination which preserves and showcases the region's rich, social, cultural and natural heritage while enabling tourism enterprise clusters to grow and prosper. Option refinement and economic appraisal is now underway. The Draft Feasibility Study, Economic Appraisal/Business Case is due mid-October 2023 with Final Report on track for delivery by end of October 2023.

Slí Cholmcille Project is a proposed 250 km pilgrimage route linking key Colmcille related sites across Donegal and Derry, with the ambition to link across NI to Scotland. DCC is leading feasibility assessment with partners DCSDC and Slí Cholmcille CLG. Work is well underway by the appointed consultants for the Scoping Study, Business Case/Economic Appraisal and Design Toolkit (Outdoor Recreation NI) for completion by the end of October 2023. A wider stakeholder engagement event in June 2023 was followed by local engagement in August/September as well as cross-border animation planned for October 2023.

All golf clubs in the county are invited to attend these meetings which provide a good forum for clubs to work collaboratively, share learning and insights and identify opportunities to cross promote and co-operate further so as to help build Donegal's world-class golf reputation and in turn increase number of high yield visitors to the county.

International Association of Golf Tour Operators (IAGTO) Golf
Convention took place in Derry in October. Between 50 to 75 Golf Tour
Operators from across all key markets travelled to Derry for this
convention. Donegal County Council and Derry City and Strabane District
Council worked in partnership with Tourism Ireland to arrange to meet
these tour operators and provide them with information about the region

as well as assisting them with hosting fam trips to the region.

Golf Media Fam Trip to Donegal: Donegal County Council's tourism team is working on a collaboration between Fáilte Ireland, Donegal Airport, and Emerald Airlines to bring a number of golfers into the county.

The venture aims to showcase the unparalleled beauty and excellence of Donegal's golf courses and will bring some of the most influential golf reporters who have the power to spotlight Donegal on the global stage.

The website plays a critical role in terms of proactively promoting the county and in enabling visitors and/or potential visitors to easily access essential information to allow them to make decisions and plan their holiday in Donegal.

The tourism team is working on the website redevelopment, and this is being informed from the findings of extensive research into user behaviour as they plan holidays. The aim of this redevelopment is for the new website to become much more focused on the needs of users. It will continue to serve the tourism industry by driving referrals to businesses and growing the tourism economy throughout the county.

Donegal Tourism

Associate Members Committee

The Associate Members Committee of Donegal Tourism Clg provides a forum that enables its members to share views, opinions and insights and to provide a connection between associate members and the Board of Directors of Donegal Tourism Clg.

The committee is made up of associate members nominated and voted by the associate members of Donegal Tourism and a poll is taken every two years.

In April 2023, the process for nomination of associate members onto the committee commenced. Each associate member was assigned a business category and was invited to vote on the membership of the committee.

The Associate Members Committee election process was completed in July and the first meeting of the new Associates Members Committee took place on September 13th at the Silver Tassie Hotel Letterkenny. This meeting focused on exploring the role of the committee, its members and the work of Donegal Tourism Clg. Three associate members from the committee were also selected to sit on the board of Donegal Tourism. The next board meeting for Donegal Tourism Clg is scheduled for October 3rd.

Grant Schemes

Minor Tourism Related Works Grant Scheme

All successful applicants under the 2023 MTWGS have been issued letters of offer and applicants are getting works underway.

The team will continue to liaise with all applicants to ensure the smooth drawdown of funds in a timely manner.

Regional Festival & Events Grant Scheme

All successful applicants to this grant scheme have been issued letters of offer and work is underway with the various festivals that have been completed to drawdown this funding. All funding must be drawn down by December 2023 as this is then recouped from Failte Ireland at the end of each year.

Ireland West Airport

Ireland West Airport is enjoying a record-breaking year for passenger traffic in 2023. Statistics show that a record 367,000 passengers passed through the airport during the period January to June 2023, making it the busiest six-month period in the airport's 38-year history.

Donegal Tourism is working with the Ireland West Airport marketing team to update branding and imagery on all digital screens and billboards within the airport and ensure that Donegal has maximum exposure throughout the airport. In addition, a monthly distribution of brochures is provided to the airport for arrivals.

Two new models of the Saldanha – Tides Project

Donegal County Council Tides Project has appointed a Marketing company to promote the three pilot VR sites – Fanad Lighthouse, Greencastle Maritime Museum, and Fort Dunree.

The campaign will include a competition centred around these sites and procurement of new imagery from the catchment areas around these regions – Inishowen and Fanad. The agency will work closely with the Fanad Lighthouse, Greencastle Maritime Museum, and Fort Dunree to promote their offering.

There will also be a launch of the two new models of the Saldanha, which were delivered to the two sites (Fanad and Dunree) in July.

TOURBO Project

The Council has commenced the implementation of an Interreg Europe consortium, led by Seville Chamber of Commerce to deliver the TOURBO project, which will help small and medium sized tourism businesses with green and digital transformation known as the 'Twin Transition'.

The project includes an analysis of the tourism sector in terms of green and digital skills/capabilities, training businesses and pilot actions such as new technology trials and knowledge/expertise collaboration. Tourism businesses will be eligible to apply for a grant of up to €5000 under the TOURBO programme. For more information visit https://www.interregeurope.eu/tourbo.

Sustainable Arctic and Peripheral Biking Tourism Project

The Council has secured €428,600 to deliver this project which will provide businesses with an opportunity to learn from various good practice approaches across Europe to encourage sustainable biking business. The implementation of this project has commenced and will progress in the coming period.

Chicago – Milwaukee Aug 2023 – Post Event Report

Donegal County Council Tourism team under the auspices of Donegal Tourism participated in the Milwaukee Irish Fest 2023 on 17th to 20th August. This included a meeting with tour operators and travel agents in Chicago in advance of the festival.

The below report sets out details of the objectives of the event, details of the team attending, details of the events held, and a summary of the benefits accrued from the events.

Objectives

The objective of attending this event was:

- To target potential visitors, attending the Milwaukee Irish Fest who
 have a strong interest in Irish cultural and music, on the
 attractiveness of Donegal as a destination to visit on the island of
 Ireland.
- 2. To build a database of potential visitors to be targeted via a range of marketing campaigns to convert intentions/desires into visitors to the county.
- 3. To build connections and relationships with US based tour operators and travel agents who are already featuring Ireland in their itineraries and to highlight Donegal as a strong and attractive destination for their customers.
- 4. To raise awareness among US based tour operators and travel agents of the bespoke Donegal Travel Concierge Service available to assist and support tour operators in building their itineraries in Donegal.

The team

Three members of staff attended the Chicago Donegal Showcase and the Milwaukee Irish Fest 2023, and this included Anne Marie Conlon, Head of Economic Development, Sarah Nolan, A/Head of Tourism and Mary Daly, Tourism Officer. Unfortunately, the Cathaoirleach Cllr. Martin Harley and Leas Cathaoirleach Cllr. Gerry McMonagle was not in a position to attend this event.

The Donegal Tourism trade was also invited via an open call to participate in this trade event and Harvey's Point Resort participated and provided one staff member to attend this event.

Chicago Donegal Showcase

On Wednesday 16th August, Donegal Tourism, in conjunction with industry partner Harvey's Point Hotel, hosted over 30 tour operators, travel agents and diaspora connections at the Donegal Showcase event in Chicago. This event provided an opportunity to present to those attending the key compelling reasons for visiting Donegal and for including Donegal in their Ireland itineraries.

Positioning Donegal as an emerging and exciting destination on the Wild Atlantic Way and as a new and relatively undiscovered destination on the island of Ireland was received positively by the various tour operators attending.

This event was also an excellent opportunity for the team to learn more about the changing consumer preferences in this US market and a number of tour operators referred to the desire for return visitors to Ireland to experience new destinations on the island and that Donegal was emerging strongly as a preferred location in this regard.

The showcase event also provided an opportunity to connect with a small number of Donegal diaspora in Chicago and these relationships will be developed further in the coming period through the proactive engagement of the Donegal Diaspora project. These individuals continue to play a key role in advocating for Donegal and promoting the county as a place to visit and there is an opportunity to nurture these relationships and support them in their efforts.

Milwaukee Irish Fest

The Milwaukee Irish Fest is the largest Irish Festival in the world and is attended by over 120,000 people from the US each year. This event is supported by Tourism Ireland with a number of counties attending to promote their own counties as destinations for US visitors. In 2023 Galway, Clare, Mayo, Leitrim and Donegal manned stands in the Irish Destinations area.

There were also a number of Donegal businesses showcasing their products at the festival and this included Edel McBride, Oideas Gael, Raithlin Knitwear, Brenda Hewitt, James O'Donnell Photography, Harvey's Point Resort and Study Abroad Ireland and this meant that Donegal was very well represented at the Milwaukee Irish Festival in 2023.

Visitors to the festival were encouraged to stop at the Irish Destinations area to find out what there is to do and see in Ireland. The Irish Destinations area provided information on where to visit during a trip to Ireland.

At the Donegal stand a variety of information was available for visitors to the stand including the new Donegal tourism brochure, tips on top 10 things to see and visit in Donegal, Aer Lingus voucher for flights to Dublin and Aer Lingus Donegal Airport offers. In addition, to this information and Donegal merchandise, the Donegal stand hosted a competition for visitors to the stand with a number of prizes and this resulted in 600 entries to the Donegal Tourism potential customer database. This information will be used for future direct marketing campaigns.

Under Scheme A, €109,940 was awarded to 25 businesses ranging in value from €840 to €5,000. 6 of these businesses were awarded additional funding of €63,535 under Scheme B, ranging in value from €2,894 to €15,000. LEAN provides strategic intervention for businesses to work with third party consultants worth up to €4,500 (Client contribution €200). It is designed to encourage clients to adopt Lean business principles in their organisations to increase performance and competitiveness. Lean is for all companies, regardless of sector – it is not just for manufacturing companies.

IMMERSE

LEO Donegal has received funding of €68,000 from Creative Ireland from the Creative Communities Action Fund, to deliver the IMMERSE project, a collaboration between Donegal County Council, Eirmersive, Connected Hubs, Regional Enterprise Offices

(Midwest/Northwest/West), CREW, Údarás na Gaeltachta and the Western Development Commission. The project, a multi-agency, panregional proposition across the Atlantic Innovation region, will focus on the Content Creation Sector. Responsibility has been assigned to the Western Development Commission to handle project operations.

The Western Development Commission will submit a draft report to LEO Donegal in late November 2023, prior to final submission to Creative Ireland.

Scale-X

Scale-X North West began on Wednesday September 6th involving participants from Donegal and Leitrim.

The 11-week Accelerator Programme, aimed at start-up entrepreneurs with the potential for fast growth, will run until November 22nd. 12 entrepreneurs across a diverse group of businesses, sectors and

backgrounds have been selected to take part in the programme. At the final event, each business will present their business pitch idea to a judging panel.

Ambition

Ambition is a pre-accelerator programme which focuses on female entrepreneurs.

15 businesses have been recently selected to participate in the fourth programme for Donegal's early-stage female entrepreneurs. Businesses will attend twelve half-day workshops and the programme will run from September 2023 to December 2023.

Creative Coast Donegal

Creative Coast Donegal's aim is to support the building of a strong creative and digital economy in Donegal with businesses that are robust, confident, financially viable, and collaboration-friendly, all impacting positively on the local economy in terms of job creation, as well as being pro-active and competitive on an international stage. There are currently 204 members of the Creative Coast Donegal network. The LEO Donegal and external consultants are currently developing a 3-year action plan for the creative industry in Donegal.

LEO Donegal is developing a 'Meet The Makers Directory', a directory of craft businesses in County Donegal. This is currently being designed and will be made available at the Meet the Makers event, referred to earlier, which is taking place on October 20th at Lough Eske Castle.



Project Description/	Final dates for the burning of cut and other agricultural green waste		
Activity	The Waste Management (Prohibition of Waste Disposal by Burning) Regulations 2009 makes it an offence to dispose of waste by burning. An initial five-year exemption was provided for the permissible disposal of waste by burning where it was done as a final measure after the preferred alternatives had been assessed, the local authority was notified and the material to be burned consisted only of uncontaminated wood, trees, tree trimmings, leaves, brush, or other similar waste generated by agricultural practices. This exemption has been extended on several occasions.		
	In early 2023, the Department of the Environment, Climate and Communications announced that the practice of burning agricultural green waste will end on the 30th of November 2023 .		
	To facilitate a final transition, a last short time-period for burning re-opened on the 1st of September 2023 and will close on the 30th of November 2023. There will be no further extension.		
	Farmers who plan to undertake the burning of agricultural green waste within this timeframe must notify their local authority in advance.		
	Material types		
	This final burning exemption applies to farmers who generate agricultural green waste through:		
	 Management of hedgerows Land clearance and maintenance activities Wind fall material arising Pest-infected and diseased material requiring management 		
	This exemption does not apply to the controlled burning of growing vegetation as this is covered by Section 39 & 40 of the Wildlife Act 1976. In addition, if land is in a Special Area of Conservation (SAC) or a Special Protection Area (SPA), it is likely that an application will have to be made to the National Parks and Wildlife Service (NPWS) for permission to conduct any burning of vegetation. For the management of invasive species, please refer to the NPWS.

What are the sustainable practices to replace burning?

In November 2022, the Irish Bioenergy Association on behalf of the Department of Agriculture, Food and the Marine developed a feasibility study on the sustainable management of agricultural green waste in Ireland.

This report outlines many sustainable alternatives to burning which farmers are permitted to use, including:

Use of flailing and return the cut material to the ground in-situ

Establish a nature pile/biodiversity habitat corner allowing the material to decompose over time

Produce sustainable wood fuel for own heating use on-farm

Composting of the material on-farm

Off-farm energy generation from high quality, large volume, uncontaminated material

Use of the material for animal bedding

Produce landscaping material

Biochar production

Orphan Schemes

The desk study of all 1104GWSs within the county was utilised to identify all orphan scheme within the county. 295 GWS were classified as orphan through this process and have decreased to 273 based on the takeover programme to date. These 295 schemes were investigated further to identify GWSs with less than 10 connections. 158 GWSs were identified after this review. A detailed analysis of each scheme is currently being conducted to establish if these schemes meet additional parameters set out by Uisce Éireann as mentioned above. All 158 schemes have been reviewed and 37 schemes have been deemed to meet the criteria set out by the programme. These 37 schemes will be checked on site to confirm if conditions match the desk study. The total number of Orphan schemes is now 273 due to the progress made on the takeover programme to date.





1.0 RURAL REGENERATION AND DEVELOPMENT FUND (RRDF)

- 1.1 EXISTING APPROVED CATEGORY 2 RRDF PROJECTS (2020)
- **1.1.1 Back to Ballyshannon** A transformational project to re-energise, re-imagine and sustain the social, cultural, historical, physical and economic fabric of Ballyshannon's historic town centre.

Value: €247,500. (RRDF funding approved €185,625)

Update: Acquisition of the key regeneration site in Market Yard was completed by year end 2022. The Team continues to work towards the publication of a planning scheme, so as to develop this project as a shovel ready capital project targeted for future Category 1 RRDF funding.

A workshop was held with Members on July 13th 2023 to update them on this evolving consultation and design process. It is anticipated that design work will complete and work to prepare publication of a statutory planning scheme will occur in Q4 2023.

1.1.2 Ramelton Re-Imagined.

Category 2 Value: €249,159 (RRDF funding approved €186,869) Category 1 Value: €7,949,868 (RRF funding approved €6.3m)

Update: Part 8 planning for this project was confirmed at a Plenary Meeting of the Council on Wednesday 6th of April, 2022.

The Detailed Design phase is now complete and it is intended to open a construction tender in Q1 of 2024 ahead of a projected commencement to site later in 2023. The process of project handover to the Council's Capital Project Delivery Unit (CPDU) has commenced. CPDU will manage the construction and handover stage of the project.

The Team will continue to update and advise Members on progress and key milestones as this project moves towards commencement on site.



1.2.2 THIRD CALL FOR CATEGORY 2 PROJECTS UNDER THE RURAL REGENERATION & DEVELOPMENT FUND (RRDF)

Repowering Buncrana.

The Elected Members of the Inishowen Municipal District were updated on the status of this

project at workshop on Friday 27th January 2023. The project was then submitted to the DRCD for Decision Gate 2 Pre-Tender Approval on Monday 20th March, 2023. Decision Gate 2 approval was subsequently received on 3rd April, 2023 and this project is therefore now approved to proceed to tender.

A sale agreed position has been reached in respect of the town centre acquisition interest enabled by this project. The property concerned is the former Garda Barracks at St. Orans Rd, Buncrana. The Councils legal services have now been instructed to close out and complete this acquisition and this is ongoing. The property will be redeveloped as an economic development proposition as a part of this project with a forward view towards job creation and inward investment.

A detailed tender package for the procurement of Architect Led Full Integrated Design & PSDP Team services has also now been prepared and is undergoing final review before opening the formal tender process on eTenders. It is acknowledged that the Members of the Inishowen Municipal District have requested a workshop in respect of the Repowering Buncrana project, and arrangements will be made to facilitate this once the tender process has opened and greater certainty can then be given in relation to the timelines for the further development of the project going forward. It is anticipated that this workshop will be facilitated in late October/Early November 2023.

1.3 Rathmullan RRDF Project Development work

A formal Part 8 planning scheme for this project was published on Thursday 24th November 2022. Submissions or observations were required to be made in writing on or before 4:30pm on Wednesday 18th January 2023. A Chief Executives Report on the proposed development was brought before the Elected Members for consideration at a Special Meeting of the Council on 13th February 2023 when Members decided to proceed with the development as proposed.

Work is now continuing to position the project for application to future calls of the Rural Regeneration & Development Fund (RRDF) for category 1 (capital) projects. The next stage in project development work concerns the preparation of a Business Case. In this regard FPM were appointed on 25th September 2023 to provide services for an Economic Appraisal including a Business Plan and Financial Analysis of the project.

The project is a partnership with Rathmullan The Way Forward CLG.



1.5 Milford Town Centre First Plan

In late 2021 the Department of Rural and Community Development sought nominations for towns to be considered as part of the 1st Phase of the Town Centre Masterplan Initiative. Minister Heather Humphries TD subsequently announced that Milford was successful in securing €100,000 under the call. The Regeneration & Development Team is now leading on the delivery of a Town Centre First Masterplan for the Town.

GM Design Associates Ltd were appointed as the successful consultancy service to deliver the Town Centre First Plan for Milford on Tuesday 14th February 2023 and the project commenced with the first stage of Public Consultation which took place over a period of 3 weeks beginning on Thursday 16th February and concluding on Thursday 9th March 2023. The first stage consultation process involved a number of targeted workshops, including a project workshop with Elected Members which took place on Tuesday 14th February 2023, as well as a cross-directorate workshop, a community stakeholder group workshop and workshops with students attending the two local secondary schools. A very successful Public Consultation Event was also held on Wednesday 22nd February which was attended by c.120 no. participants.

The public engagement also centered on the launch of a dedicated project website, facebook page and twitter page, and provided for responses via an online resident's survey, a business survey, a feedback form for individual submissions as well as a kids' page. On the whole there has been a hugely positive response to the public engagement with 227 no. online surveys completed with a further 128 no. survey responses from the secondary school pupils, 355 no. in total. There were also 16 no. comment sheets submitted, 3 no. written submissions and 2 no. email submissions as well as 86 no. kids' responses.

The consultants, GM Design Associates Limited completed the process of collating, recording and interpreting the findings and results of the public and stakeholder engagement together with the conclusions of the baseline analysis of the town centre including the SCOT analysis, and have finalised the Stage 1 Report entitled 'Milford TCF Plan Baseline Profile', which was presented to the Elected Members at a Workshop on the 5th of May 2023. This Report has directly informed the Draft Milford Town Centre First Plan which was published for public consultation from the 10th of July to the 4th of August 2023. A drop in event was held on the 26th July 2023 in the Milford PSC with 64 attendees and 42 submissions were made via completed survey forms, comments sheet and email.

The Consultants are now working to complete the Milford TCF Plan, which involves, inter alia, translation, response to submissions and environmental screenings, after which it is planned to hold a workshop with the Members of the Letterkenny – Milford MD to present the proposed Milford TCF Plan before final launch arrangements are confirmed. It is anticipated that this



workshop will proceed in October/early November and separate arrangements will be made in due course.

1.6 Creeslough Village Plan and Community Regeneration Project

Donegal County Council, the Creeslough Working Group and the Creeslough Community Association supported by Arup launched a public consultation process to prepare a Village Plan and community regeneration project for the Creeslough Community in May 2023.

On 27th July 2023 a formal Part 8 planning scheme for the Creeslough Community Regeneration Project was published. A Chief Executives report on the proposed Part 8 development and the statutory consultation process was brought before the Elected Members at a plenary meeting of Donegal County Council on Monday 25th September 2023 when the Members decided to proceed with the development as proposed. Planning consent for the project is now confirmed.

Work is now continuing to position the project for application to future calls of the Rural Regeneration & Development Fund (RRDF) for category 1 (capital) projects. The next stage in project development work concerns the preparation of a Business Case, ground and site investigations and the preparation of detailed project costings. In this regard Jennings O'Donovan & Partners Limited Consulting Engineers were appointed on 15th September 2023 to provide structural & civil engineering design services for the project, including PSDP services and geotechnical investigations. On 25th September 2023 FPM were appointed to provide services for (i) Community Engagement and Company Formation, and (ii) an Economic Appraisal including Financial Analysis of the project. This work will now continue in earnest.

ARUP are continuing work to prepare the final Creeslough Village Plan. Members were updated on the status of this work by ARUP at a workshop on Tuesday 19th September 2023. This work involves translation and formatting prior to confirmation of appropriate launch arrangements before year end.

2.0 URBAN REGENERATION AND DEVELOPMENT FUND (URDF)

2.1 Existing approved URDF project in Letterkenny (application submitted 2018; final approval to proceed received September 2019)

This first application secured €1.9m in URDF monies, match funded by €600,000 for three sub-projects. Sub-project A, preparation of Letterkenny 2040 Regeneration Strategy is now complete and available at www.letterkenny2040.ie.

Sub-project B, CPO in respect of the Letterkenny 2040 Strategic Urban Regeneration Site, significantly progressed having served Notices to Treat and Enter in March and April 2023. On 8th May 2023, Donegal County Council



took possession of the CPO lands required to enable the delivery of Phase 1 development of the site as regards Alpha/Beta office accommodation and public realm infrastructure. Negotiation on compensation continues in parallel. Acquisition by agreement of remaining property at 29 and 31 Port Road to enable Phase 2 completed on 2nd August 2023 and both properties are also now in the possession of Council.

In addition, a Recommendation has been prepared to progress the business case for an Affordable Housing Scheme in respect of the residential component of the Concept Masterplan relating to the remainder of the strategic site (Phase 2). As a result, this part of the site will transfer to Housing colleagues with alignment and input from both the Regeneration and Development Team and the Capital Projects Delivery Unit. Further updates will be brought to the Letterkenny-Milford MD in this regard as this work develops.

Please refer to Capital Project Delivery Unit MD reporting for update as regards the public realm sub-project.

2.2 Successful application to the Urban Regeneration & Development Fund (May 2020)

The Councils successful application to URDF Call 2, entitled 'Letterkenny 2040 (Phase 1): To Re-energize and Connect the Historic Town Centre' secured a provisional allocation for total project cost of €18.1m (comprising €13.6m URDF support together with match funding committed by the Council in the sum of €4.5m). Total project uplift was secured at Decision Gate 1 in relation to Preliminary Business Case to take account of inflation resulting in total project cost of €19.3m (comprising €14.5m URDF support and €4.8m match funding by Donegal County Council). Project costs will remain under review at each stage of project development and as the approval gateways under the Public Spending Code are navigated.

The project will advance five sub-projects to varying stages as follows:

- The further enhancement of the Cathedral Quarter
- The re-purposing of the Courthouse
- Strategic land assembly towards:
 - o Renewal of Lower Main Street
 - o Advancement of a Regional Transport Hub
 - Enhancement of 'LK Green Connect,' walking, cycling and parkland infrastructure.

DHLGH approval to proceed with tendering processes and acquisitions was secured on 7th March 2023 following approval of the Detailed Project Brief and Procurement Strategy. DHLGH advise that each sub- project will now progress on its own timeline including the preparation of individual Final Business Cases prior to appointment of construction contractor.



Accordingly, steps are being taken to proceed with each sub-project as set out in the following table.

Notwithstanding, the following actions have been commenced/underway:

- Formal engagement with a number of landowners commenced and commitment given to further re-engage with particular landowners in September 2023.
- Tender package for Valuation Services in relation to the Cultural Corridor element closed on 21st July 2023 and an appointment is currently being made. Activation of acquisition steps in relation to phase 2 (from constructed Phase 1 to Pearse Road) is dependent on progress on the Part 8 to inform the extent of lands required and previous commentary of capacity of inhouse resources refers.
- High level legal appraisal with Councils solicitor completed on 9th June 2023.

2.3 'The Eat Out' Outdoor Dining Infrastructure Project, Letterkenny

'The Eat Out' Outdoor Dining Infrastructure Project at the public space to the front of An Grianan Theatre secured Part 8 planning consent at the plenary Council meeting in November 2022. Detailed design of this project enabled in the context of the further development of the concept contained in the Letterkenny 2040 Regeneration Strategy via the appointment of The Paul Hogarth Company and O'Connor Cronin Sutton Engineers is well advanced. The Regeneration Team now provide support and input into the detailed design process which is led by Community Development wherein a procurement process for construction contractor closed for tender submissions on 16th August 2023. Further updates are being provided by Community Development.

2.4 Letterkenny Cultural Corridor

Part 8 proposed development for the 'Cultural Corridor' section of LK Green Connect is progressing and is at an advanced state of readiness. The target for publication of the Part 8 is September 2023 leading to consideration of Chief Executives Report on the Part 8 consultation at the November 2023 Council meeting. The team continue to work towards these target dates whilst balancing some additional negotiations with landowners that have arisen. Any adjustment in publication timeline will be communicated directly to Members.

2.5 2nd Phase of LK Green Connect

Early design work using in-house resources commenced initially in January 2023 on Part 8 proposed development for Phase 2 of LK Green Connect to



link walking and cycling infrastructure at the completed Phase 1 to Pearse Road.

Due to pressures across the wider work programme of the Regeneration Team, only limited progress has been made with a fresh application of resources targeted for September 2023. Given the early stage in the design process, the timeline for publication of the Part 8 is yet to be confirmed and, as referenced, is subject to capacity of staff resources across both URDF and RRDF programmes. The preferred scenario is to publish a Part 8 by year end 2023. Workshops at MD level will be arranged as this project develops.

In parallel with design work, it is proposed to make further contact with landowners.

2.6 Youth/Community focused project at Lower Main Street

Early engagements with Letterkenny Youth Club and Donegal Youth Service have commenced to further explore the potential for a youth/community focused project at Lower Main Street as envisaged within the Design Concepts contained in the Letterkenny 2040 Regeneration Strategy and relating to a number of Councils acquisition interests under URDF Call 2 successful application. In this regard, a partnership in principle has been agreed. Following progress on relevant land acquisition under the Councils URDF Call 2 project, it is targeted to commence design processes as regards a future capital scheme at this location. Timeline for commencement of design work is likely to be Q of 2024 at the earliest and is highly dependent on capacity of inhouse resources. Updates will be provided to Members on ongoing basis.

2.7 Collaboration with Housing Section of Donegal County Council

Collaborative working arrangements have been established with the Housing Section of Donegal County Council to explore and develop social/affordable housing schemes on key regeneration sites within the town centre generally and, more specifically at Lower Main Street and at Phase 2 of the Strategic Urban Regeneration Site located between Pearse Road and Ramelton Road. Members will be updated as this work progresses.

2.8 URDF Call 3

On the 11th July 2023, Minister O'Brien announced an allocation of €4m under URDF Call 3 for Donegal County Council in relation to Letterkenny Regional Centre. URDF Call 3 focusses on enabling Local Authorities to tackle long-term vacancy and dereliction in Letterkenny town centre and on the acceleration of residential development. The programme will provide a rolling fund to Local Authorities to enable acquisition and design and civil works that may be required to de-risk property to make it more attractive for onward sale. A funding agreement has been completed and returned to DHLGH and a further return is be completed for return to DHLGH by a deadline of 25th August 2023. A further workshop with Letterkenny-Milford MD will be required as regards next steps, resources and timeline.



2.9 Other

The Regeneration and Development Team continue to engage in other regeneration related work areas in Letterkenny, engage with key stakeholders on a rolling basis and support other sections of Donegal County Council as required and across several other activities.

3.0 CROI CONAITHE VACANT PROPERTY REFURBISHMENT GRANT SCHEME

The Council administers the Croi Conaithe Vacant Property Refurbishment Grant Scheme on behalf of the Department of Housing, Local Government and Heritage. The grant schemes, which came into operation in July 2022, provides grants to property owners to refurbish properties that have been vacant for two years or more for use as their principle private residence or to be made available for rent. The level of grant funding available is €50,000 or €70,000 if the property is derelict. The grants are increased by 20% for offshore island properties. To date, the Council have processed 302 applications with 87 approved and 16 rejected on the basis that they do not meet the scheme criteria mainly relating to the proposed works or that the property has not been vacant for two years or more and built on or before 2007. The balance of applications is either awaiting further information from the applicant or at first technical inspection stage. There are two applicants who have completed the works and these are currently being processed.

4.0 COMPULSORY PURCHASE ORDER ACTIVATION FUND

In April 2023, the Department of Housing, Local Government and Heritage launched the CPO Activation Programme for the activation of vacant and derelict properties. The main steps of the programme include:

- **Step 1**: Identification of vacant and derelict properties
- **Step 2:** Identification of and engagement with owners.
- **Step 3:** Communication regarding the various schemes and measures in place to support bringing the property back into use, and

Step 4: Where owners of vacant and derelict properties cannot be identified or where they are unwilling to engage, use of available legislative powers to compulsory purchase or acquire such properties. The acquired properties may subsequently be used for social housing, made available for sale on the open market or used for other purposes.

The Council are currently undertaking Step 1 to identify vacant and derelict properties through the GEO Directory. This survey is being undertaken in the following towns, which includes town identified at the workshops held with Elected Members in July 2023. The surveys will be rolled out to other towns over the coming months:

To date, 1,545 properties have been surveyed with 678 confirmed as vacant and 48 as derelict. The next step is for our team to identify and engage with the property owners to make them aware of the supports available to bring the vacant property back into productive use. The Members will be kept up to date as we progress through the work programme.

Response: Upon receipt of the report of the recent near miss incident on Thursday 21st September 2023 outside

the national school at Dunkineely , the Area Roads office immediately brought this to the attention of the Road Safety Engineer and asked him to review the location to see if there are any other additional measures that could be implemented at this location to help address the issue of vehicles failing to stop at the pedestrian crossing outside the school when the lights are red. The road passing the school is the N56 National Secondary Route and lies within the 50kph zone. Any additional measures identified by the road safety engineer need to be discussed and agreed with the TII's National Road safety team before they can be implemented. Also, in February 2023, in response to other reported incidents of vehicles not stopping at these lights the Council arranged for a Road Safety Assessment Report to be carried out which concluded with short, medium, and long-term recommendations which will help with road safety in the vicinity of the school. These recommendations were discussed with the school and a copy of this report was provided to assist in the schools application to the Department of Education for the necessary funding to complete the works which formed part of their planning permission in 2018 for the school extension and carpark facility on the school grounds which when implemented will help with the overall road safety in the vicinity of the school.
