C/135/14 CONSIDERATION OF REPORT IN RELATION TO THE REVIEW OF PROCEDURES FOR THE SUBMISSION OF MOTIONS UNDER URGENT BUSINESS AT MEETINGS OF DONEGAL COUNTY COUNCIL

The Director of Housing & Corporate, Mr Liam Ward alluded to his report citing a number of reasons as to the need for amending the existing arrangements.

Members themselves, he noted, had requested a review of the arrangements and on this basis after consultation with the Housing & Corporate SPC and the Corporate Policy Group, a number of recommendations had been endorsed to proceed to the full Council for approval. These included:-

- 1. Where a Member proposes to submit a motion under Urgent Business, a typed copy of the motion must be provided to the Mayor and every member before 12 noon on the day of the meeting. Members would then have a period up to 3 pm to decide if they wish to put their name to the motion for submission in accordance with Standing Order 28 (a).
- 2. A motion under Urgent Business should be accepted in situations only where the subject matter has arisen in the period after the normal deadline for submission of motions has passed.
- 3. Motions under 'Urgent Business' shall be limited to the Proposer, the Seconder and one Speaker from each political Grouping.
- 4. In the event that a motion is passed to suspend Standing Orders to complete the remaining items on the agenda, motions under 'Urgent Business' already accepted by the Council will be dealt with at the end of the meeting subject to a maximum time of 20 minutes per motion.

A number of issues were raised including

- The fact that there were two types of meeting with one specifically dedicated to motions & questions.
- That a facility needed to be in place to deal with issues of local and national importance which arose in the period after the motions and questions deadline.
- Specific mechanism needs to be put in place for those meetings in which Member's own motions and questions are submitted.
- Concern that Motions submitted under Urgent Business are taking precedence over Member's own business.
- Cited need also to review Standing Orders in the context of the suggested changes.

The Meetings Administrator clarified that any decision taken would not impact on the 6 Motions Under Urgent Business currently submitted for the February Meeting.

Thus Members queried the overall methodology and the necessity of amending Standing Orders to accommodate same. They agreed to defer a decision on the matter pending the election of the new Council.

C/136/14 FILLING OF CASUAL VACANCY IN THE MEMBERSHIP OF DONEGAL EDUCATION AND TRAINING BOARD ARISING FROM THE RESIGNATION OF CLR BARRY O'NEILL Members considered the report circulated with the agenda in relation to the above.

On the proposal of Clr N Mc Bride, seconded by, Clr. Mc Brearty it was proposed that Clr Harley fill the casual vacancy on the Education & Training Board occasioned by the resignation of Clr Barry O' Neill.

Clr Brogan then proposed, seconded by, Clr Crawford that Clr Seamus O' Domhnaill fill the casual vacancy on the Education & Training Board occasioned by the resignation of Clr Barry O' Neill.

A lengthy debate ensued during which Members expressed disappointment that the nomination of Clr O' Domhnaill was a deviation from normal protocol, given that such vacancies were traditionally filled by a representative of the original nominating party or grouping.

A lengthy debate ensued with a number questioning the democratic nature of the process. Calls were made for a common sense approach to be taken.

Reference was made also to the fact that the Fianna Fail grouping had been excluded from the current pact.

Clr Brogan contended that there was a wider issue involved and affirmed that Councillors who could not meet particular commitments should not take up positions on committees of this nature. He asked that a record of Member's attendances at Committee and Forum Meetings for the past five years be provided.

He claimed also that Clr Mc Brearty had not attended meetings of the Regional Health Forum West since January 2013.

Responding Clr Mc Brearty said that his non-attendance had been directly related to the performance of his mayoral duties,

Following a number of heated exchanges the Mayor adjourned the meeting to 2pm.

"We the Undersigned members of Donegal County Council call on our Government to lobby the British Parliament and the Northern assembly to ensure that Northern Ireland is exempt from the HGV road user levy, which will have a detrimental affect on livelihoods for all concerned especially when crossing the border into Northern Ireland on a daily basis. If implemented by the British Government it flies in the face of the Good Friday agreement which was supported by 90% of the people in the South and 70% of the people in the North which should be honoured by all on this Island of Ireland. By supporting the Good Friday agreement Irish citizens in the South should have the same rights as Irish citizens living in the North. Please support our call for equal rights and our call for the British Government to abandon their unfair tax being introduced on the 1st April 2014".

A request signed by Clrs S O'Domhnaill, P McGowan, G Crawford, D Alcorn, C Brogan, P Canning, L Blaney, M Quinn, M McBride, N McBride, J Boyle, T Slowey, J Campbell & M T Gallagher to have the following motion discussed as urgent business in accordance with Standing Order No 28 was submitted to the Meetings Administrator:-

"That Donegal County Council requests that the Department of Agriculture fully consider the inherent constraints (soil types & annual rainfall) on small upland and wet grassland farms (*The new and more sustainable landscape management approach is adopted in disadvantaged areas, which maximises the vital tourism, environmental, social and economic benefits of an Equitable Rural Development Programme and rewards cost effective targeted actions of small farmers that benefit the wider rural community)* and that they acknowledge the worrying population declines, and its social consequences in upland areas and respond by harnessing the crucial green image of less intensive farming, married with increasing Agri-Food production, to achieve its ambitious harvest 2020 goals".

It was unanimously agreed to consider same prior to the close of business.

C/138/14 CASUAL VACANCY ON THE EDUCATION & TRAINING BOARD ARISING FROM THE RESIGNATION OF CLR BARRY O' NEILL

On resumption Clr Mc Brearty called on Clr Brogan to apologise for his earlier comments and said he would be forced to take appropriate action if this was not forthcoming.

Another heated debate took place during which it was suggested by Clr N Mc Bride that the meeting be deferred for a period of one week to allow all concerned reflect on the issues raised. A number of Members called however for the meeting to continue.

Thus on the proposal of Clr Gallagher, seconded by, Clr Mc Gowan it was resolved to further adjourn the meeting for a 25 minute period until 3.00pm.

C/139/14 CASUAL VACANCY ON THE EDUCATION & TRAINING BOARD ARISING FROM THE RESIGNATION OF CLR BARRY O' NEILL

The Mayor advised that there was considerable support at this juncture for adjourning the meeting, but acknowledged that there was also quite a number of Members who wished to continue with the proceedings.

Clr O' Domhnaill at this juncture advised of his intention to withdraw his name from the selection process. Thus it was resolved that Clr Harley be selected to fill the casual vacancy on the Education & Training Board arising from the resignation of Clr O' Neill.

C/140/14 <u>CONSIDERATION OF REPORT ON POTENTIAL</u> <u>ACQUISTION OF LIFFORD AND ROCKHILL BARRACKS</u> (AS CIRCULATED WITH MANAGERS REPORT AT <u>MEETING OF 27TH JANUARY, 2014)</u>

Members were informed that the situation remained the same as outlined in the County Manager's report issued for the January Meeting of the Council.

The County Manager recapping the main aspects of his report advised that the following needed to be taken into consideration:-

- 1. The fact that there was unanimous support for the acquisition of Lifford Barracks and that the €00,000 price was manageable within the resources currently available.
- 2. Acknowledgement also of the fact that a number of Members were in favour of acquiring Rockhill.

He was he confirmed recommending the purchase of Lifford Barracks and was now in a position to negotiate with the Department of Defence regarding same. He would, he said, keep options open regarding Rockhill and that the provision existed for any interested bodies or groups to engage with the Council in the development of the facility.

Some Members whilst acknowledging the rationale for acquiring Lifford Barracks, alluded to the fact that it would also make good business sense to purchase Rockhill given that the long term gain would far outweigh initial expenditure.

They outlined the need for further negotiation with the Department of Defence in the interests of value for money. The long term investment potential of acquiring 25 acres of land within the jurisdiction of a Gateway Town was acknowledged.

Clr Larkin proposed, seconded by, Clr McBrearty that the Council revert to the original plan and negotiate with the Department of Defence to acquire both Barracks. It was suggested that the deferred payment period be extended from 6 to 20 years.

Clr Crawford outlined the importance of the Lifford facility for the community as a whole. He proposed that the County Manager

proceed with the purchase of the Lifford Barracks, though noted that this was without casting any judgement on Rockhill element of the package. This was seconded by Clr Mc Gowan.

Members proceeded to debate the pros and cons of acquiring both properties. The value for money aspect was further debated with Clr O' Domhnaill contending that this was entirely dependent on whether the Rockhill property was actually needed and the long term costs associated with retaining such a property.

It was generally acknowledged that there was room for further negotiation and that a better deal could be thrashed out encompassing both properties. Clr O' Neill proposed, seconded by, Clr Gallagher that an all party working group be set up to look at the options available to facilitate the acquisition of these two facilities.

It was further suggested that Minister Mc Ginley be approached with regard to the findings of the group and a new submission forwarded to the Department of Defence.

The County Manager noted that the discussion had been informative and useful. He was, he said, satisfied that the purchase of Lifford was both affordable and manageable, but indicated that he was not in a position at present to confirm whether it was possible to purchase Rockhill. He confirmed that in the absence of a private sector investor or benefactor, Rockhill was a relatively challenging project to develop on a cost related basis. He noted that there were specific obligations arising also from the fact that it was a Protected Structure. He informed Members that the cost of acquiring same would have to come down considerably to make it affordable and outlined his intention to work with the aforementioned working Group.

Recognising that Members were supportive of the proposal to acquire Lifford Barracks, the County Manager advised that it would be possible to re-engage with the Department of Defence. In response to a call for a vote on the matter, the Manager said that the Council would pursue Lifford and seek to keep options for acquiring Rockhill open for further consideration and did not wish to divide the Council by putting the question to a vote. - 3. Repayment on three days notice.
- C/142/14 TO NOTE REPORT ON THE CHANGES TO THE BUILDING CONTROL REGULATIONS DUE TO TAKE EFFECT FROM 1ST MARCH 2014 UNDER THE BUILDING CONTROL (AMENDMENT) REGULATIONS 2014 Members considered the report circulated with the agenda in relation to the above.

During a lengthy debate members noted that:-

- The introduction of the regulations would effectively prevent people from building their own homes.
- Give rise to serious consequences for one off housing developments and lead to the decimation of rural areas.
- The need for working drawings at the various stages of development and the use of approved materials only, was simply a ploy to keep Architects in work.
- Small contractors would suffer in the long-term.

- Such over regulation would lead to a 25% increase in the cost of building a dwelling.
- That there was now no incentive to come back to Donegal to build a house.
- There was a need to reduce building costs and the associated development charges.
- Proper debate essential including the holding of a workshop to discuss same.
- Clarification necessary regarding what constituted a competent builder.
- That it would be better for the Council to oversee the whole process at a viable cost rather than inspect 12% to 15% of the commencement notices received.
- That the introduction of the regulations would lead to Financial Institutions introducing more rigorous rules in relation to the drawdown of monies.
- The necessity of having specific regulations in place to monitor Architects involved with the process.

Queries were raised with regard to the following:-

- 1. Whether applicants should submit commencement notices before the 1st March before the new Regulations came into operation.
- 2. The input required from the Construction Industry Federation.
- 3. How many individuals were qualified to certify buildings under the new legislation in Donegal.

Mr Michael Mc Fadden, Executive Engineer, informed the meeting that the regulations were effective from March 1st and had been introduced to strengthen the arrangements in place for the control of building activity.

This legislation it was acknowledged placed the onus on the applicant to appoint a competent builder.

He informed Members that Planning permission would not be affected by the new regulations and that Building Control would only become involved when construction started. The new inspection system, he noted, provided for specific risk factors. Commencement Notices received before March 1st would, it was confirmed, be dealt with under the old regulations. It was acknowledged also that the CIF were involved in the creation of non mandatory regulations for competent builders with these becoming mandatory by 2015/2016.

Mr Mc Fadden alluded to the fact that the certification aspect was not new and that the old system had provision for the engineer concerned to sign off on specific works.

The most important document now, he confirmed, was the completion certificate as a development could not be sold or rented without this documentation.

The County Manager reminded members that what was being talked about was the formalisation of a system that should have operated efficiently in the first place.

Clr Mc Gowan proposed, seconded by, Clr O' Domhnaill that proposals be submitted to the Department regarding the necessity of making acceptable provision for one off housing developments.

Motion No 1- Independent Judicial Enquiry into Policing

On the proposal of Clr Mc Brearty, seconded by, Clr Quinn, the following motion submitted earlier in the Meeting in accordance with Standing Order No 28 was moved:-

"We the Undersigned members of Donegal County Council call on the Government to hold an Independent Judicial Public inquiry into Policing in the past, Policing in the present and Policing in the future with a proper set of terms of reference. We also call on Government to Establish a Police Authority, Policing boards in each Garda District throughout the Country and that GSOC be given the independence it needs for citizens to make complaints against the force which will give them the confidence that their complaint will be independently investigated".

Alluding to a number of allegations of police corruption, he cited, the need for immediate reform of the justice system affirming that an injustice anywhere is a threat to justice everywhere.

Motion No 2 - HGV Road User Levy

"We the Undersigned members of Donegal County Council call on our Government to lobby the British Parliament and the Northern Assembly to ensure that Northern Ireland is exempt from the HGV road user levy, which will have a detrimental affect on livelihoods for all concerned especially when crossing the border into Northern Ireland on a daily basis. If implemented by the British Government it flies in the face of the Good Friday agreement which was supported by 90% of the people in the South and 70% of the people in the North which should be honoured by all on this Island of Ireland. By supporting the Good Friday agreement Irish citizens in the South should have the same rights as Irish citizens living in the North. Please support our call for equal rights and our call for the British Government to abandon their unfair tax being introduced on the 1st April 2014".

Motion No 3 – Payment of Benefits through Post Offices
