



Read letter from the Managers, ⁶ *Abernian Fire & General Insurance Company Ltd. 49, Dame St. Dublin* drawing attention to the fact that a considerable number of the Public Bodies in Ireland have augmented their insurances owing to the increased cost of building materials and labour, approximating to 50 per cent. and drawing the Guardians attention to the fact that in the event of fire occurring they might possibly incur a very considerable loss.

Read letter from Local Government Board forwarding substance of a report received from their Inspector, Miss Brown, regarding the children boarded out in the Union.

Copy.

There are at present 4 children boarded out by the Guardians under the provisions of the Pauper Children (Ireland) Acts 1898 - 1902.

These children are all in good homes. They are healthy and well cared for. Their personal cleanliness is good. Their School attendance is regular.

Their clothing was in good condition, sufficient and suitable.

Two children have been removed from the Boarded-out Register since my former inspection. One of these is now lived out with her former foster parent, and doing well. The other was claimed by her grandmother, and is now living with her and an elder sister.

There are two children at present in the Workhouse. Suitable foster-homes have been procured for them, and they are shortly to be boarded out.

"The Guardians considered the report very satisfactory."

No 29,569 : 1916

Read a verbal letter from Local Government Board stating that the Board of Trade have made an Order under Section 5 (2) of the Trade Boards Act dated 7th June, 1916, fixing rate of wages etc.
