Owing to the failure of Edward Coll Bread Contractor to carry out his Contract for the supply of Bread to the Workhouse from 1st Oct 1914 to 30 Sept 1915, the extra cost of procuring Bread amounted to £19. 13. 7 The Guardians retained a sum of £6. = 6 = 0 leaving a balance due by the Contractor of £13. 7. 7 - The Contractor and his Sureties had been written to for this sum. The Contractor Edward Coll and his two Sureties Daniel Crossan and David Dickson appeared before the Board and pointed out that owing to the great increase in the price of Flour caused by the war the Contractor who is a struggling

A man without any means found himself unable to complete his contract, he made every effort to get some person to complete his contract but failed.

The Guardians having considered the matter found that it was impossible for this man to complete his contract owing to the increased price of flour caused by the war. It was proposed by Mr Hugh McDermott and seconded by Mr Christopher Leary and passed unanimously that the Guardians retain the pay order for £6-6-0 and relieve the contractor and his sureties of any further responsibility subject to the sanction of the Local Govt Board.

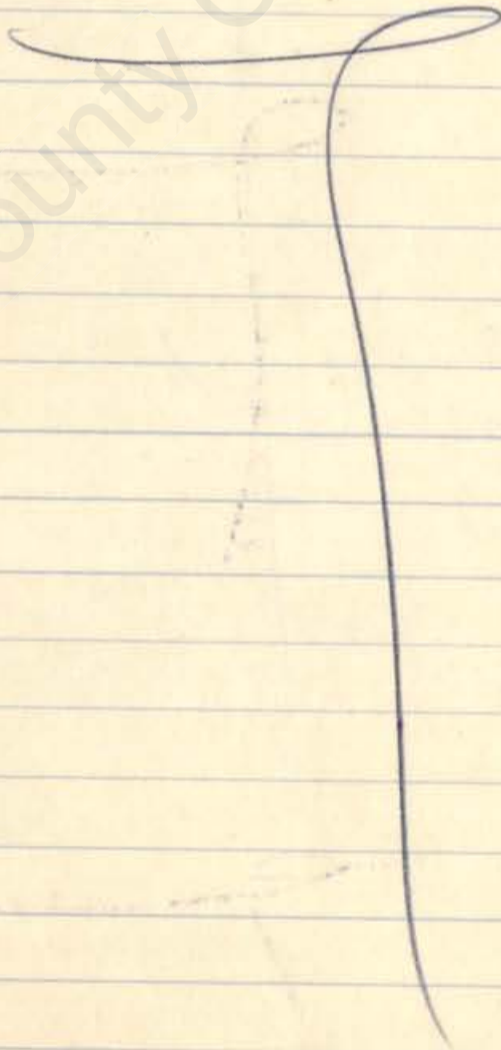

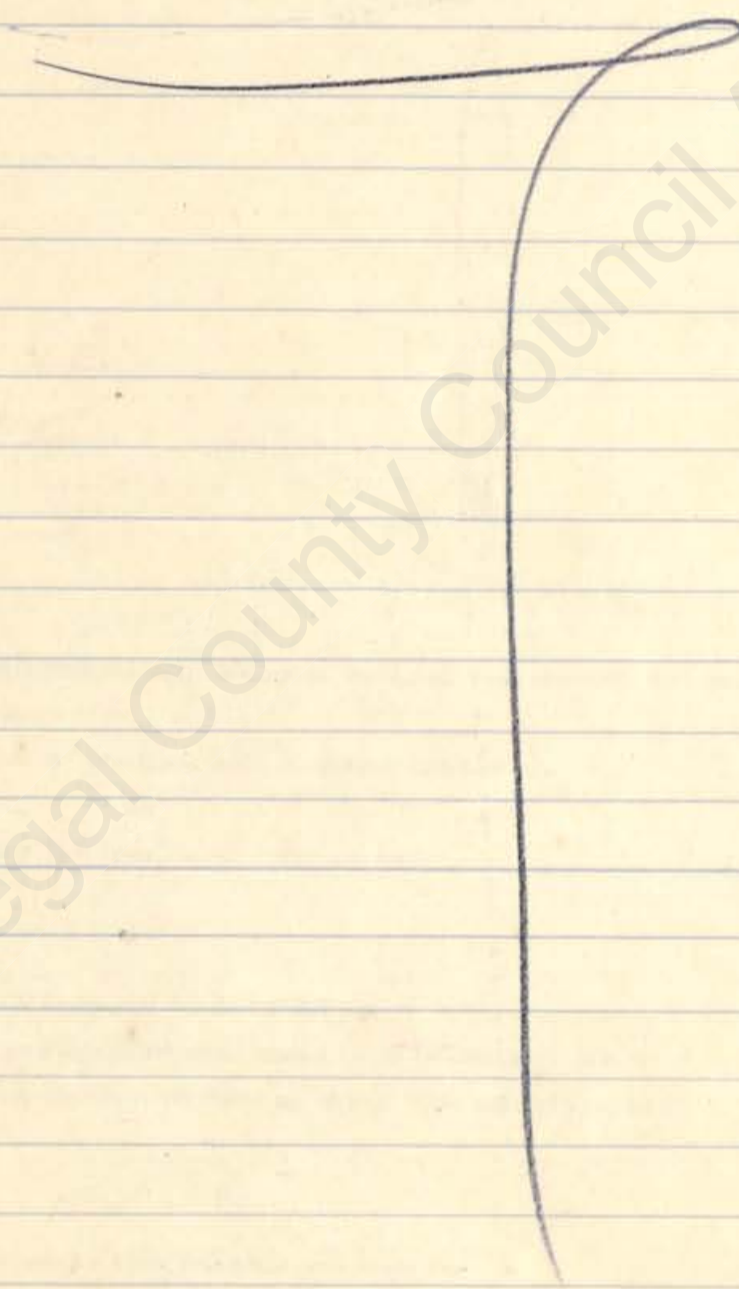

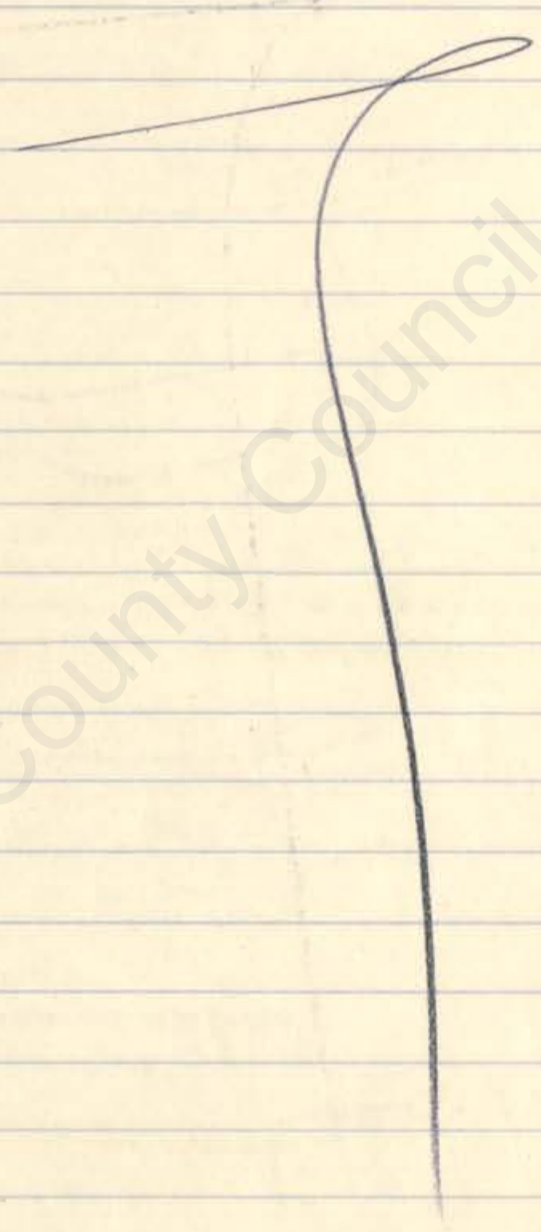
