### Closing of the War Khouse.

The Milford Guardians wrote relative to the admission of the Dunfaughy War Khouse inmates to their War Khouse and intimated that they were prepared to admit them at the following terms :-

Each inmate from the Dunfaughy Union to be charged ten shillings a week and in addition the Clerk of the Milford Union to be paid five pounds a year by the Dunfaughy Guardians. The Dunfaughy Guardians to pay all expenses for the removal of their inmates and for future cases of admission from their Union. The Milford Guardians to have the option at any time of rescinding this scheme on notice of motion for its consideration.

~~On the motion of Councillor McNulty~~  
The Clerk reported that on receipt of this letter on the 19th instant, he had summoned a special meeting of the Guardians to consider the matter. Approved.

On the motion of Mr McNulty seconded by the Chairman the following resolution was unanimously adopted :-

"That the terms of the Meiford Guardians be accepted and that it be open to the Bunfanaghy Guardians if they so consider to rescind this scheme at any time by due notice of motion. All Officers who may receive a superannuation allowance from the Guardians, to be required to return to the service of the Guardians when requested. The Relieving Officer to issue admission tickets for the Meiford Workhouse when this House is closed which is to be done on the 31st proximo and the Clerk to take all necessary steps for this purpose. Funds to be asked for the conveyance of the inmates to the Meiford Workhouse. The following Guardians to assist the Clerk in carrying out the scheme as soon as the sanction is received from the Local Govt. Board - Messrs John McNulty J.P., James McIntyre and William Burnip. The Clerk to give the following Officers one month's notice that their services will not be required after the 31st March 1917 viz: "Master, Matron, Nurse, Night Nurse, Wardsmaid and General Servant and that the Chaplains be notified that the Guardians will take into consideration at their meeting on the 14th April next the revision of their salaries with a view to their reduction. Arrangements to be made that <sup>cases</sup> inmates who may be sent to the Meiford Workhouse from

this Union, that they be conveyed by motor car. Casuals on no account to be so treated."

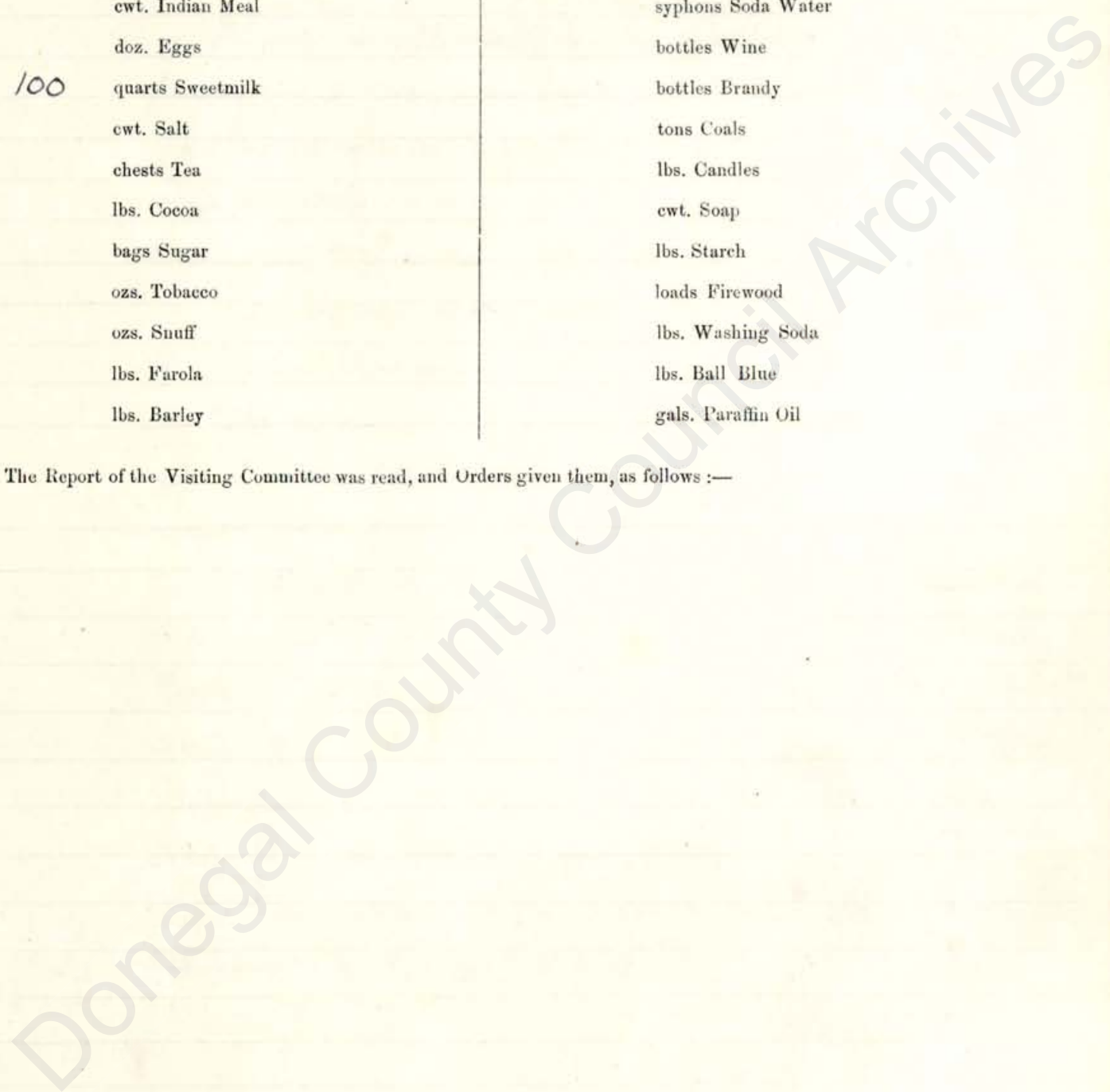

The Master reported that ten inmates were removed to Meepers Workhouse on Tuesday, he had employed Maurice McGee carpenter for a few days to affix additional locks, he also had to employ Cassie Moffitt to help in cleaning etc. for the last two days in view of the closing of the workhouse, at a remuneration of two shillings a day without rations, at the request of the Medical Officer I gave 8 ozs. of whiskey to the inmates when leaving.
