8. 7. 1916 Gentlemen. I am in receipt of your letter of the 24th requesting me to give an explanation regarding the delay in the bringing of the Byrne family to the Fever Hospital. I beg to inform you that I left Burtonport on the 10th at 5.30 with 3 patients and a nurse and John Byrne. I was ordered by the Nurse to go very slow and to escape all the broken stones on the road. I also had to stop every time the nurse wanted to see the patients which was about every half hour. I want you to understand that if patients are to be removed in quick time they cannot get the treatment they should get on the Road. I wish to draw your attention to the removal of the patients on the following dates July 2nd I was ordered to be in Burtonport at 12 o'clock and didn't get leaving there until 7.30 P.M. and on July 4th I was ordered to be in Report at 10. A.M. and didn't get leaving until 3.30 P.M. I hope your Board will consider the injustice of having to wait seven hours on the Pier for patients. your obedt servt John McLoone
