From Local Government Board date 11th June 1908,
referring to Council's Minutes of 16th Ult. the Board
state that they have sanctioned payment to the
Clerk of £10- as an instalment of remuneration
for his services in connection with the Council's
present Improvement Scheme under the Labourers'
Acts.

From Local Government Board date 11th June 1908,

Reports from Medical Officers of Health were read.

The following Letters from the Local Government Board for Ireland, or others, were read, and directions given thereon, as follows:—

referring to the entry on Council's Minutes of 16 Ult. relative to the claim of Mr. F. G. Townsend Engineer of the Council for payment of a sum of £45- for his services in connection with the Council's Improvement Scheme under the Labourers Acts, the Board state that it is for the Council themselves to determine whether the sum claimed is due to the Engineer in accordance with the terms of his appointment.

The Council are satisfied as to the amount above mentioned being due to the Engineer.

The Cottage Rent Collector reported date 20th June 1908 that a tenant of a labourers cottage in Clifhore had sublet the cottage to a man named Montgomery. It was also reported to the Council that a cottage tenant named Kerrigan in Magheracar had taken in lodgers.

The necessary steps to be taken in the above cases.

From Local Government Board date 6th June 1908, stating that they have received the resolution of the District Council of 16th Ult. suggesting that Mr. Michael Nelly of Finnes should be excluded from the Schedule to the Board's Order fixing the Area of Charge for Expenses in connection with Bundoran Water Supply, and the Board request that they may be furnished with full particulars in order that the holding may be identified.

The required information to be furnished to the Local Government Board -

From Local Government Board date 13th June 1908, enclosing a letter received by the Board from Mr. M. Loughlin relating to a nuisance at Hamilton Hall Bundoran and asking that the Board may be furnished with the Council's observations on the subject in connection with the entry thereon contained in the Council's Minutes of 16th Ult.

The Owner of the premises Mr. Hamilton, Bundoran was written to calling upon her to abate the nuisance complained of, but no action was taken by her to comply with the Council's requirements.

The Medical Officer of Health to be instructed to visit and report as to the nuisance complained of and steps to be taken to compel Mr. Hamilton to put the premises in a proper sanitary condition.

From Mr. R. H. Reid Solicitor date 12th June 1908, stating, that in the malicious injury case brought against the Council by Mr. Moore in which she claimed £80 damages, the Judge awarded her £37..10..0 and that subject to the Council's approval, he had given notice of appeal to the Assizes.

Mr. Reid to be instructed to proceed with the Appeal.

The Clerk reported that Messrs. James McGonigle and John Wilson, the former an elected and the latter a coopted Councillor, had failed to sign the necessary declarations within the prescribed time.

Mr. Cassidy proposed, Mr. Gorman seconded and it was passed unanimously,

"That Mr. Patrick Brechin be coopted as a Councillor

Mr. Maguire proposed, Mr. Gowan seconded, and it was passed unanimously - That Mr. R. J. Reynolds be coopted as a Councillor.

The Clerk was directed to instruct Mr. Townsend L. E. to submit to the Council designs for a public Urinal in Bundoran.

From Mr. Pack-Beresford Inspector date 27th June 08 forwarding a bill of Costs from Mr. Stubbs in respect of the opposition of certain persons to portions of the Improvement Scheme made by the Council and stating that he proposed to allow the sum of 10/- as costs to the owner or occupier concerned in respect of each site indicated in blue ink on the application.

The cases marked were for Thos. Meehan, Occupier, two cases 10/- each.

The Council approved of Mr. Pack-Beresford's ruling on the application for Costs.

From Bernard Keenan, Ballyshannon date 4th July 08 applying for a vacant cottage in Sminver and offering Mr. M. Flanagan Main St, Ballyshannon as security for the rent.

The application was granted.

From Mr. Peter McPhelim, Rent Collector stating that William Carty tenant of a Cottage in Magheracar is three months in arrear of rent.

Proceedings to be taken against William Carty to recover the rent or possession of the cottage.

From Local Government Board date 3rd July 1908, stating that the Board have received the form "L" Returns furnished by the Medical Officer of Health of

Ballintubber and Ballyshannon Districts, for half year ended 31st March last, and the Board forward Extracts therefrom for the consideration of the District Council.

The Board observe from the return that Sanitary Sub Officer Higgins made no reports to the Medical Officer of Health of Ballintubber Dispensary District during the period in question, and they request that the Council will be good enough to call upon the Sanitary Sub Officer to furnish an explanation in writing as to his neglect of duty in this respect.

The Extracts from the reports are as follow

Ballintubber Dispensary District.

The Sanitary Sub Officer made no reports to me during the half year.

The nuisances reported have not been abated.

There are yards in the village which are in an unsanitary state and have no sanitary accommodation.

The village of Ballintubber is practically without a Water Supply.

The Main Sewers of the village require to be opened and cleaned.

Ballyshannon Dispensary District.

Some people keep cattle in very close proximity to their dwelling houses in the Union.

The houses of the poor in the town are in most cases very defective and unsanitary.

They are badly lighted, most of the rooms ~~are~~ used as sleeping apartments have no chimneys and in a great number of cases one apartment must be used for a large family of all sexes as a sleeping room.

From Local Government Board date 6th July 1908,
forwarding for the Council's information a copy of their Inspectors, Mr. R. Pack-Beresford's report relative to the houses proved to be unfit for human habitation at the Local Inquiry recently held into the Improvement Scheme made by the Council under the Labourers Acts, and the Board call attention to the provisions of Sec. 17 of the Act of 1885, as to the procedure to be observed by them

Reports from Medical Officers of Health were read.

The following Letters from the Local Government Board for Ireland, or others, were read, and directions given thereon, as follows :—

when they are in a position to supply House accommodation for the persons occupying the houses referred to in the report.

From Local Government Board date 16th July 1908, inquiring what action was taken by the Council in regard to Sanitary defects in the Ballintra and Ballyshannon Dispensary Districts to which attention was drawn by the Medical Officer of Health in their form "B" Reports for half year ended 31st March last.

The consideration of the matter was postponed.

From Mr. John Higgins, Sanitary Sub Officer date 17th July 1908, stating in explanation as to why no reports were sent in by him to the Medical Officer of Health of the Ballintra Dispensary District for half year ended 31st March last, as follows:

"I visited the District regularly twice a Month and any Sanitary defects I caused to be removed and always found this done at my subsequent visits. The fact of no written reports having been sent in was entirely due to an oversight caused by my being engaged in connection with the Seed distribution.

I regret that no written report was supplied and I undertake to report in writing in future."

The Council considered the explanation satisfactory.

From Mr. W. McVity J.P. Bundoran date 16th July 1908, drawing the Council's Attention to the state of Finner Graveyard and suggesting that a caretaker be appointed at a salary of £3- a year to have the nettles and grass cut down regularly, as the amount allowed to the present caretaker, £1- a year is not sufficient to keep the Graveyard as it should be kept.

The matter was left over till next Meeting for the attendance of Mr. Gorman, Councillor for the Division.

From Local Government Board date 17th July 1908, referring to the entry contained in Council's Minutes of 6th Ult. and previous correspondence relative to the claim furnished by Mr. W. O'Kane, Bundoran for the erection of certain Labourers Cottages in the District, the Board forward for the Council's information a copy of a letter which the Board have ^{addressed} received to Mr. O'Kane on the subject.

The Board's letter to Mr. O'Kane is as follows:

Sir,

Advertising to your letter of the 14th May last relative to the claim furnished by you to the Ballyshannon Rural District Council for the erection of certain Labourers Cottages in the District, I am directed by the Local Government Board of Ireland to state that this claim does not become due until the Council's Engineer certifies for payment.

To Mr. Wm. O'Kane.

From Mr. A. Scott, Dublin, Architect of Labourers Cottage Scheme date 13th July 1908, stating with reference to Mr. O'Kane's Contract for the erection of Labourers Cottages as follows:

"The cottages are now all built, but there are some trifling defects to be remedied in a few of them, and some fencing to be completed.

On 5th August next the contract will be four years running, I do not intend to let it run into a fifth year. The Contract must be determined and the value of the unfinished work deducted therefrom."

James Higgins, Glyhore applied to the Council to have some repairs required at the Labourers Cottage occupied by him carried out. There are some slates off the roof and also some tiles, and rain comes in through the windows.

From Mr. A. Scott C.E., Architect of Labourers cottages date July 31st 1908, enclosing a certificate for £50- in favour of Mr. O'Kane on foot of his contract for 18 labourers Cottages. Of the 18 cottages 16 are finished and occupied, and two, in Killinangle and Drumholme, are fit for occupation and should be occupied with as little delay as possible. The Cheque should not be paid till the keys of the Cottages are handed over.

The Keys were handed over and payment of Certificate allowed.

From Mr. A. Scott, C.E. Architect of Labourers cottages date 4th Septr. 1908, stating that Mr. O'Kane, Contractor applied to him for a final certificate and also ^{claims} for Extras, which he cannot give.

They had employed a competent man to remove the obstruction as the matter was urgent - An account for £ 24.. 10.. 6 for the work was sent in by William Logue, Bundoran for carrying out the necessary work.

I beg to hand you herewith Mr. O'Kane's account for extra work checked by me in red ink. As you will observe the amount allowed being £20-10-0. Many of the items I have had to strike out altogether particularly his charge for cut stone quoins as he has supplied no quoins better than those specified—I have also had to strike out his charge for fire grates which he supplied and fished in substitution for fire brick paved hearths and backs which he omitted—

I allowed him to supply ironmongery for which a sum of £31..10..0 had been provided in Specification i.e. £1..15..0 for each house—He makes a charge for ventilating flues in rooms which have no fireplaces and for which I allow half, 10/- being half the amount claimed—

I enclose you his first bill for extra work for comparison with his second and final account. He claims £5 for extra foundations which I cannot allow, same being provided for in Specification—

I also enclose you a bill of deductions under heads of omissions and defects, the value of which I estimate at £40..1..0 and which sum is to be deducted from the balance due on foot of his contract—

I need not deal separately with these items as they explain themselves, but if there is any further explanation wanted by your Council I shall be glad to supply same—

From Local Government Board date 15th Dec 1908, referring to previous correspondence relative to the resolution of the Council of 16th May last suggesting that the holding of Mr. Michael Melly of Finner should be excluded from the schedule of the Board's Order of 13th Decr. 1904 fixing the Area of Charge for expenses in connection with Bundoran Water Supply the Board explain that when in 1904 they assented in a variation of the above mentioned Order they were influenced by the fact that the four tenants tenements affected had been erroneously included by the Clerk of the Union in the Schedule submitted to the Board for the purpose of the preparation of the

of Order and that the Guardians of Ballyshannon Union recognising this error had not assessed rates in respect of Bundoran Water Supply upon the four tenements in question -

Before the Board can consent to a further modification they ask to be informed by the Council whether the same conditions explained above apply to Mr. Michael Melly's holding.

Ordered

The holding of Mr. Michael Melly was included in the Area of Charge by mistake - He was an under-rated tenant for whom the landlord formerly paid all rates - The mistake was not discovered till after the passing of the Local Government Act of 1898, since this the tenant has repeatedly complained to the Council, and we are desirous that the mistake should be rectified by having Michael Melly's holding excluded from the Bundoran Area of Charge -

From Local Government Board date 17th Dec '08 stating that they observed in Council's Minutes of 5th Inst. an entry of the Board's letter of 27th Novr. 1908, forwarding Extracts from Form "B" returns furnished by the Medical Officers of Health of Ballyshannon and Ballintubber Dispensary Districts and in reference thereto the Board point out that no order appears to have been made by the Council with regard to the defects pointed out by the Medical Officer of Ballintubber and only part the Ballyshannon report appears to

have been dealt with. In conclusion the Board request that the Council will be good enough to take the Medical Officer's suggestions into their consideration.

The Council have the reports of the Medical Officers under consideration.

Fresh notices for abatement of nuisances in Ballintubber District to be served and proceedings taken against persons who fail to comply with them.

This Council has always been willing to cooperate with Donegal District Council in providing a Water Supply for Ballintubber, a considerable portion of the Village being in that District, but up to the present cooperation has been refused.

The report of the Medical Officer of Ballyshannon District is general and vague. The Council are at present about to carry out a scheme under the Labourers Acts which will provide dwellings for a number of persons occupying unsanitary houses.

From Messrs. Ashwell & Co. Solicitors Victoria St. Westminster date 17th Dec. 1908, requesting the Council to pass a resolution approving of the Bill before Parliament for the construction of the Bundoran and Sligo Railway, and securing a Grant of Public Money for carrying out the work.

Mr. Thomas Gorman Jun. proposed, Mr. John Gowan seconded, and it was passed unanimously,

"That we, the members of the Ballyshannon District Council having considered the plans and Bill of the proposed Sligo and Bundoran Railway, the benefit it would confer, not alone in the Congested District through which it passes by developing the important fishing and agricultural industry as well as opening up the most picturesque seaside resorts in the Country and supplying a long-felt and much-advocated missing link between Railway Systems in the North and West of Ireland, hereby give the project our hearty approval and support we request the cooperation and support of the Board of Agriculture and Congested Districts' Board in securing a grant in aid from the Government towards the cost of constructing of this line of Railway which has been favourably considered by the present Chief Secretary for Ireland as being a great necessity -

From Local Government Board date 4th Jan'y 09,
stating, that they have received the report of their Medical Inspector, Dr. MacCarthy relating to the Sanitary condition of Ballyshannon Rural District, Extracts from which are enclosed, and requesting that each of the matters referred to may receive careful consideration.

The Board also request that the Council will be good enough to give directions to the Sanitary Sub Officer to carry out the suggestions of Dr. MacCarthy as regards reporting the result of Sanitary Notices served by him.

The Sanitary Sub Officer should also keep a diary in accordance with Art. 17(13) of the Board's Sanitary Order No. 1 of 3rd May 1900, and he should be required to be more frequent and systematic in his inspections in future.

The Board regret to observe from the report that that the Orders served by direction of the Council are not enforced and they desire to state that in cases where Notices requiring the abatement of Nuisances are not complied with, legal proceedings should be instituted by the Council against the persons in default, in accordance with the provisions of Sec 111 of the Public Health (Ireland) Act 1878.

With regard to Registration &c. of the Common Lodging Houses in the District the Board point out that the Provisions of Sec. 87 & 91 of the Public Health (Ireland) Act 1878 are mandatory.

The Council would do well to take into consideration

the question of providing in conjunction with Belleek and Kinlough District Councils and the Guardians of the Union a suitable Ambulance for use in the entire Union.

The extracts from Dr. MacCarthy's report are as follows:

"There is one Sanitary Sub Officer, John Higgins, in the District. He keeps no diary and the blocks of his Notice Book are not filled in. The number of reports made by him therefrom could not be checked. There is much in the town of Ballyshannon and throughout the District requiring energetic and systematic inspection by the Sanitary Sub Officer. The Rural District Council have not as yet taken any action to administer the Dairies, Cowsheds and Milkshops Order 1908, I have attended and explained the Order personally to the Council.

There is one Creamery in the Ballyshannon Rural District. There is no systematic inspection of the Meat and Milk supplies.

Dr. Gordon, Ballyshannon has made 18 reports.

Dr. Corcadden, Ballintra has made 16 reports during the past 12 months. More reports might be made with advantage, but the Sanitary Authority pay little attention to the reports made to them by the Medical Officers of Health and Sanitary Sub Officers.

Formal notice to abate is generally served, but no further action is taken when the Notices are not obeyed, which usually happens. No prosecutions have been instituted by the Sanitary Authority during the past 12 months. Much more attention requires to be paid to sanitary matters, the improvement of existing dwellings and the systematic abatement of nuisances.

Ballintra is still without a supply of pure water. The Rural District Council were found by the Local Government Board to have been in default as to this matter over five years ago. The Medical Officer of Health reported that the sewers of Ballintra were blocked at the time of my visit -

The Sanitary Report Book contains no results. The Sanitary Sub Officer should in all cases report what has been done by persons on whom notice has been served by the Sanitary Authority and the report of the Sanitary Sub Officer should be entered in the Sanitary Report Book with the date on which the report was made.

The bye-laws under the Public Health Acts are in force in the Rural District for any purpose. The Common Lodging Houses are not registered or regularly inspected. There are I am informed six houses which should be registered, 5 in Ballyshannon and 1 in Ballintra. There is a heavy two-wheeled van at the Fever Hospital which is used by the District Councils of Ballyshannon, Bellicek and Kinlough for the conveyance of patients suffering from infectious diseases to Hospital -

The Sanitary Authority have not provided their District with an efficient disinfecting apparatus. The Sanitary Authority should pay more attention to Public Health matters especially as to the improvement of existing dwellings with a view to checking the spread of Tuberculosis -

Consideration of the Report was adjourned till next Council Meeting -

From Local Government Board date 16th Jany 1909

referring to the Minutes of the Council of 2nd Inst. the Board note the statement of the Council that the Holding of Michael Melly was by mistake included in the area of charge for the expenses in connection with Bundoran Water Supply but they desire to be informed whether when considering the Original Area of Charge the Board of Guardians of Ballyshannon Union intended that this holding should be embraced in the Area of Charge or whether the Clerk of the Union misunderstanding the Guardians intention returned the holding in the list of tenements submitted to the Board.

The question of the exclusion of Mr. Melly's holding from the Bundoran Area of Charge was not before the Board of Guardians when the Area was formed -

From Local Government Board date 29th Jany 1909. referring to Minutes of the Council of 2nd Inst. containing an entry of a letter from the Board of 17th Ult. respecting the Medical Officer's Returns form 'B' relating to Ballintra and Ballyshannon Dispensary Districts for the half year ended 30th Septr last. and with reference to the Order made thereon in relation to Ballintra Water Supply the Board point out that the Council should proceed to carry out their duties independently of what may be done by the Donegal Rural District Council. The Board also inquire why the proposal to erect a pump in Ballintra was not proceeded with -

The pump was given up and Mr. McGuire £. E was instructed to prepare plans &c. to procure a Water Supply from sources near Ballintra, the plans

6

were prepared and forwarded to the Local Government Board but did not meet with the approval of the Board.

From the Town Commissioners of Ballyshannon date 1st Feby. 1909, drawing the Council's attention to the unsanitary condition of the Back Mall road in the town caused by the deposit of offensive matter and rubbish thereon and also to the entrance to the Pig Market from the Back St.

The Commissioners to be informed that they are a "Cleaning" body and have authority to remove the nuisance complained of.

A claim for £200. compensation for an alleged malicious injury in the burning of a house in the townland of Carrickboy was received from Mr. Stubbs, Solicitor for Mr. Henry Coane, the claimant -

Dr. Gordon, Medical Officer of Health reported a case of Enteric Fever in Glymore. The patient was sent to the Fever Hospital and the House disinfected.

From Local Government Board dated 14th Jan'y. 1909, stating that the Board have had before them the resolution of the Council on 7th Inst. striking off a sum of £7..17..6 arrears of rent due by tenants of Labourers' Cottages in the District and pointing out that the Council must be prepared to satisfy the Auditor as to the legality of their action in striking off these arrears.

The arrears were struck off on the Auditor's recommendation.

From Mr. Thomas Orr, Solicitor date 22nd Jan'y. 1909, on O'Kane's contract for Labourers' Cottages, acknowledging receipt of Clerk's letter of 12th Inst. with enclosures and stating that he has consulted with Mrs. Elizabeth O'Kane who is acting under Power of Attorney from her Husband William O'Kane. Mrs. O'Kane is most anxious to have the matter settled with the District Council and she is willing to accept of the amount due, but she will not allow any deduction for Mr. Scott the Engineer - He gets his commission for the contract and she thinks it monstrous to ask for a sum of £81..4..0 for a few extra journeys from Dublin - If the Council send a draft for £122..16..0 she will accept it in full and leave her to settle with Mr. Scott direct - The Council has nothing whatever to do with Mr. Scott's extra account against the Contractor. In conclusion Mr. Orr states that this offer is without prejudice in case the Council do not agree to the terms and pay Mrs. O'Kane £122..16..0 within a fortnight from date of letter -

The Council adjourned consideration of Mr. Orr's letter.

From Local Government Board date 29th Jan'y 1909, forwarding a letter received from Mr. John Gallagher an applicant for a Cottage under Labourers' Acts.

The Application of Mr. John Gallagher was rejected, at the inquiry, he occupies a house containing six apartments.

On the maps served on Mr. Gavigan the site claimed was shown to be on the South side of the road but on the maps subsequently filed with the Council it appears that the site being taken is on the North side of the road. The land is equally good on both sides of the road, but Mr. Gavigan has a very great objection to the house being built on the North side of the road as it will cut up a 3 acre field very badly.

Mr. Bissett further states that Mr. Gavigan would be very grateful if the District Council would agree to change the site to the South side of the road, a consent from the landlord to the change can be got without difficulty and he feels sure that the Engineer to the Council will consider the other equally good.

The Council agreed to change the site as requested provided the Local Government Board approve of the change and the Council's Engineer also

approves.

Mr. Brechin brought before the Council the cases of three cottages about to be built in the townland of Clyhore, it would be more convenient for the tenants as they would be nearer their work if the sites of the Cottages were removed from the land of Andrew Young to the land of Edward Knox the plots to remain as at present fixed, there are four sites of Cottages on Edward Knox's land and three on Andrew Young.

The Council have no objection to the change proposed by Mr. Brechin, provided that the change can be carried out and that there is land enough on Mr. Knox's plots for three extra cottages -



From Local Government Board date 18th May 1909 stating that the Board have had before them the Medical Officer's Return form "L" relating to Ballyshannon Dispensary District for half year ended 31st March 1909, and the Board forward Extracts from the Report for the consideration of the Council.—

The Extracts are as follow :

Ballyshannon Dispensary District.—

Ballyshannon has no system of sewerage. The sewers are badly constructed; square drains nearly always defective.

The sewerage is washed into the River Erne.

Some people in Ballyshannon keep cattle in close proximity to their dwelling houses.

The Cowsheds are not as clean as they should be and any that have been found dirty have been reported by me.

From Local Government Board date 1st May '09 referring to the entry on Council's Minutes of 1st May 1909, the Board point out that a Rural District Council are not empowered to provide fire hose unless invested with Urban powers, but that hose for sewer flushing purposes might be provided by them.

The Local Government Board's Order date 1st May '09 authorizing the construction of Urinals in Bundoran

was also received.—

It was proposed by Mr. Michael Maguire, seconded by Mr. Thomas Gorman Junr. and passed unanimously—

"That we, the Ballyshannon Rural District Council at our meeting held this day desire to extend to Mr. P. A. McHugh, her family, and the Irish Parliamentary Party our sincere sympathy on the death of Mr. P. A. McHugh M.P. whom we always regarded as ~~an~~ ideal husband, father and patriot."

A grateful country mourns the loss of one of its most useful representatives in Parliament.

The Clerk was directed to advertise for tenders for erecting Urinals in Bundoran and also for extending the Water Supply down Sweeny's lane.

From Local Government Board date 21st May 1909, stating that the Board have incurred expenses amounting to twenty-six pounds, four shillings in relation to the Council's application for a Provisional Order under the Labourers (Ireland) Acts and requesting a payable Order for that amount.

From Mr. R. H. Reid, Solicitor to the Council date 29th May 1909, forwarding a requisition to be signed in the case of Mr. Ellis, Bundoran, from whom land is being taken as cottage
