Notice convening Special Meeting

The notice convening the Special Meeting of the Council was read.

Confirmation of Minutes

The minutes of last Monthly Meeting held on 2nd day of October 1922 were read and confirmed.

Housing Scheme.

Amended Specification layout of Site approved by Ministry
Read letter from the Ministry of Local Government No 362/16/1922
Letter Kenny Urban District dated 13th September 1922 Returning
with approval endorsed thereon. Copy of the Amended Specification
in relation to the layout of the site to be secured for the purposes
of the Housing Scheme, and stating that the specification as amended
has been approved subject to the substitution of a 6" for a 4"
Main sewer. A Memorandum of some points requiring attention in
regard to the reversing of the site was enclosed.

The letter stated that the cost estimated at £81.4.0 of providing
Gas main and lamp should not be charged against the Scheme.

Re Tenders for Erection of Houses.

Read letter from the Ministry of Local Government No M. 562/26/1922 Letter Kemy Urban District dated 12th October 1922 stating that the Minister for Local Government appreciates the efforts of the Council to secure a tender at a more reasonable figure than has recently prevailed but having regard to the sum available on the basis of a shilling rate with corresponding loans the Council might do well to confine their immediate proposal to the erection of four houses and arrange with the builder whose tender may be accepted to build further houses at the same or cheaper terms if a larger grant is obtained in respect of a further local contribution that the Council's request of the 22nd May last in this matter is not being lost sight of that the Minister is satisfied that building by direct labour is in general dearer and less satisfactory than building by contract

Tenders Accepted

The Council considered Tenders according to advertisement for:-

- 1 The layout of Sites for 6 Working Class Houses in 3 blocks of 2 Houses each at Back Road Silt Kemy
- 2 The Erection of 2 Working Class Houses (Block No 1)
- 3 The Erection of 2 Working Class Houses (Block No 2)
- 4 The Erection of 2 Working Class Houses (Block No 3)

Acting on the suggestion of the Minister of Local Government on the foregoing letter the Council confined themselves to the acceptance of Tenders for the erection of 4 houses only.

The Tenders of Mr James Johnston of Ballyraine being the lowest were accepted as follows:-

Read letter from the Ministry of Local Government No L.G. 319/22 dated 25th September 1922 that in view of the financial position of local Authorities generally, it has now been decided to make payments of the amounts which were paid into the Local Taxation Account during the financial years 1920/21 and 1921/22 and still remain withheld from local Authorities and endorsing a draft for £9: 10: 8 in favour of the Council amount being computed as follows:- Grants under Section 58 of Local Government (Ireland) Act 1898. two years £6: 6: 1 Balance in respect of years 1920/21 and 1921/22. That in view of the present payment and of the fact that the payment of normal local Taxation Grants in the current financial year is assured the Minister trusts that the Council will take immediate steps for the prompt discharge of arrears of local loans and will adopt effective measures as far as circumstances permit for the repair of damages to roads and bridges &c. during the recent troubles

Forwarding Copy of Notice inserted in this Register of 12th Sept. 1922 re Official Certificate for the purposes of the above Regulations issued by the Government of the United States of America with respect to American ports intended for export to Ireland.

Malicious Injuring Claims

From the Ministry of Local Government No 35/78/1922 dated 16th October 1922 stating that as the whole Code of Criminal and Malicious Injuring law is now under consideration with a

View of Amendment it is desirable that no claims should be decided at present and that the Council's Solicitor should be requested to endeavour to have all claims under this Code in which the Council are interested adjourned to the Hilary Sessions when it is hoped arrangements will have been completed to have them dealt with on an equitable basis.

The Town Clerk reported that all the cases in which the Council was interested have been got adjourned to the Hilary Sessions.

Malicious Injury Defences.

Read letter from the Ministry of Local Government No 35/106/1922 dated 20th October 1922 referring to the Council's minutes on the 14th August last and stating that in order that extravagant claims should not be admitted through lack of proper local evidence it was essential that all Malicious Injury claims lodged since the June should be defended and the Council should instruct their Solicitor accordingly.

Change of Inspectors Address.

Read letter from Sean O'Farrell Ins. Local Government Inspector that until further notice his address will be: Tinsfail Ballyshannon.

Entrance to Mr Clure's Terrace.

Read letter from Mr Jack McAuley dated 4th November 1922 drawing attention to the entrance to Mr Clure's Terrace and stating that a pipe or gate is badly needed as at present the place is very obstructive to traffic crossing.

Ordered that the matter be attended to when the tunnel is being repaired.

Connection to Sewer

Read application from Mr Philip Carroll for permission to connect a pipe from W.C. about being put into No 1 Barracks to the Main Sewer.

Permission granted. Sufficient fall to be provided for.

Water Supply. St. Numan's College

Read letter from the Rev J. McElhannon dated 21st October 1922 complaining as to the late hour at which the water is in the morning turned on to the college.

The Town Clerk stated he had instructed the Water Manager to have the water turned on at 10 o'clock a.m. being an hour earlier than usual.

Water Storage in Reservoir

Read letter from Dr R. N. Moore, R.M.S. Tinscomill Mental Hospital, stating that there was only 3' 6" of water in the Reservoir and that the supply from Lough Salt was he thought less than usual and asking that the Glenary water be turned on to the town.

Broken Sewer Pipe

Read letter from Mr Finnegan dated 16th September 1922 that during the Steam Rolling of the Streets the earthenware sewer pipe from her houses at St. Columba's Terrace was broken and that she had been called upon to repair same as a nuisance was being caused at the place. She had the pipe repaired temporarily. A new earthenware 9 inch pipe will have to be provided and the cost of same was estimated at Five Pounds and she made application to the Council for payment of this sum.

Ordered that the matter be fully enquired into and brought again before the Council.

Sanitary Condition of Waste Space

Read letter dated 10th October 1922 from Mr John Kilkenny Vice principal Technical School directing the attention of the Sanitary Authority to the insanitary condition of the waste ground adjoining the school.

The Town Clerk reported that on receipt of the letter he directed the Sanitary Sub Office to investigate the complaint which he did and reported that there was no nuisance on the waste ground referred to and that the slaughter house adjoining was.

inspected and found clean.

Street Hoop Brush

Read letter from Mr Frank G. McClean dated 31st October 1922 offering his road sweepers to the Council for £30 that the brush requires refilling but otherwise was in perfect working order. Ordered that further quotations be invited.

Assessment to Income Tax

Read notice of Assessment to Income Tax on the Gas Works + Water undertakings of the Council for the year ending 5th April 1923. Amount of Assessment £751.

The Town Clerk reported having served Notice of Appeal against the Assessment.

Reports Sanitary Sub Officer

The Sanitary Sub Officer reported that since last monthly meeting 40 houses yards and premises had been visited and inspected and no nuisances found to exist that Richard Collins had complied with the notice requiring the provision of Water Closet accommodation for house occupied by James McDermott and in the case of notice served on Dan Kelly that the works are in progress. Nothing done in the case of Hugh McCay Church Hill.

The Council further extended the time in Hugh McCay's case, as he has promised to have the works carried out as soon as he possibly can.

Reports of Shops Act Inspector

The Shops Act Inspector reported that the provisions of the Act are being observed throughout the District.

Rate Collectors Account

The Town Clerk reported that the Rate Collector had since date of last monthly meeting lodged balance of the full amount of the first moiety of the Rates for the current financial year.

Water Manager's Report

The Water Manager reported having visited Glencair and Barnamuggagh reservoirs on the 5th November and found 4 feet of water in Glencair reservoir and 3 feet of water in Barnamuggagh reservoir. No supplement supply coming into Barnamuggagh he found it necessary to curtail the hours of supply to 8 hours out of the 24 hours. A considerable quantity of water was being used in washing motors. All the fire plugs and street fountains are in good working order.

The report was adopted.

Gas Manager's Report

The Gas Manager reported that during the month of October 315,610 cft. of gas were manufactured the coal carbonized 39 tons 6 cwt. At present there were 31 street lamps lighted that as ordered by the Council he altered the position of one of the lamp posts on the Post Road. That he disconnected from the main several services where there was no consumption. He renewed a service supplying one of the lamps at Rosemount the service was completely worn out. Some leaks had been discovered during the work.

The report was adopted.

Gas Manager Collection Account

The Gas Manager's collection account was submitted examined and showed arrears of quarter prior to 30th September last amounting to £42: 2: 8. outstanding.

Housing Minutes

Acceptance of Tenders Approved of

Read letter from the Ministry of Local Government No. M. 362/27/1922 dated 4th November 1922 approving of the acceptance by the Council of the tenders of Mr James Johnston for the lay out of sites for six houses at £569: 10 and the building of two houses at £935: 7: 6 and two houses at £945 and stating that the cost of providing gas main and lamps if included in the tender is

not to be charged against the Scheme for the purpose of the Government Grant.

The Council have noted the proviso as regards the cost of providing the gas main and lamp.

Building Contract

The Building Contract James Johnston with the Council for the layout of six houses at £569.10.0 and the building of two houses at £985.7.6 and two houses at £945. was submitted signed by the contractor and the Seal of the Council was affixed thereto.

Purchase Money of Site at Back Road

Ordered that pending negotiations by the Vendors for the redemption of the Head Rent that the Purchase money £250 be lodged on Deposit Receipt in the joint names of the Solicitors for the Vendors and the Town Clerk in the Hibernian Bank Ltd Messrs Baldwin & Robinson Solicitors for the Vendors having agreed to the Council entering upon the lands for carrying out the Scheme on this being done.

Letting of No 13 Rosemount Terrace.

The Town Clerk reported having let No 13. Rosemount Terrace to Charles Dorman on its becoming vacant at the Weekly rent of 2/8 and that the tenancy commenced on Saturday the 30th September 1922. The Council ratified the letting.

Notices to Quit

The Town Clerk reported have had Notices to Quit served on the following tenants of the Council owing to the payment of their rents being in arrear William O'Donnell No 7 Parnell Road James Drain No 2 Ballymacool Terrace and Allen Doherty No 5 McClures Terrace.

The Council approved of the proceedings taken.

Gasworks Account

On the report and recommendation of the Finance Committee the Treasurer's Advice Note for Payments detailed in the Financial Statement Book R. Expenditure No 50 to No 54 both inclusive amounting to sixty seven Pounds Fifteen Shillings and eight pence (£67:15:8) was signed as required

Taxation Law CostsRead letter from the Irish Provisional Government Ministry of Local Government No 4128 dated 28th October 1922 that Circular No 640 22 ad. Bealtaine 1922 relative to taxation of bills of costs is now to be regarded as withdrawn that in future as a general rule the payment of costs due to Solicitors by local bodies should be vouched at the audit by a certificate of taxation from the taxing Offices of the High Court etc.Gasworks takingRead letter from the Ministry of Industry and Commercial Protection Section No 442A dated 7th November 1922 that in the transfer of the documents etc. from the London Board of Trade the Department cannot trace any reference to the Council's gas undertaking having been authorised and it is not on a list of Statutory gas undertakings supplied them by the Board of Trade asking to be informed whether this is correct - a copy of a letter being sent by the Ministry to all unauthorised undertakings in Southern Ireland was endorsed.The Town Clerk submitted copy of his reply dated 28th November 1922 to the Ministry of which the Council approved by

that the gas undertaking at Little Keniff is owned and controlled by the Council and was acquired by them under Section 81 of the Public Health (Ireland) Act 1878 from the Little Keniff Gas Co. Ltd in the year 1901

That the company had not any statutory powers and the Council did not seek authorisation of the undertaking as they did not consider it necessary. That the gas manufactured for the year ended 31st March 1922 was 3,181,272 cf. The plant is capable of far greater output. The rate of charge at present is 17/6 per 1000 cf. Gas is supplied for industrial purposes and also for public lighting

Inspectors of Weights and Measures.

Read letter from the Ministry of Local Government dated 8th November 1922 stating that it has been proposed to train Members of the Civic Guard as *ex officio* Inspectors of Weights and Measures. That the Ministry would accordingly be glad to be informed as soon as possible as to (1) The General View of the Council in regard to the proposed transfer of the functions lately performed in this respect by the Royal Irish Constabulary to the Civic Guard (2) What arrangements are at present in force locally, and (3) Whether local Sub-standards of weights and measures are available.

The Council are in favour (1) of the proposed transfer (2) No arrangements are at present in force locally (3) There are no Sub-standards of weights and measures available.

Transfer of Road Powers Order 1922

Read letter LQ from the Ministry of Local Government dated 11th November 1922 enclosing Copy Order transferring to the Ministry of Local Government the duties formerly discharged by the Roads Section of the Ministry of Transport and stating that in future all communications on subjects which have been hitherto dealt with by the Roads Section should be addressed to the Ministry

Bill of Costs re Roan Street Improvement Works

Read letter from the Ministry of Local Government LQ 41/11/1922 dated 15th November 1922 transmitting Bill of Costs furnished by Messrs. D & T. Fitzgerald Solicitors together with location certificate showing the amount payable to be £10.6.6

Jurors Lists

Read letter from the Ministry of Local Government No 14/27/1922 dated 22nd November 1922 Relative to the preparation of the Juror Lists and the names of persons removed therefrom by the Revising Barrister at the Annual revision on the ground that such persons are dead or over age being included by the local Officer in subsequent lists prepared by him for revision

with the result that public inconvenience has been caused directing that special care be taken that the names of all persons expunged by the Revising Barrister at any Annual Revision on the ground of death or of age exceeding 65 years shall be omitted from all future lists of Jurors prepared for revision

Local Government Elections

Read letter from the Ministry of Local Government No 273/4 dated 22nd Nov 1922 that it is the intention of the Government to introduce at an early date legislation enabling the Local Government Elections in January next to be deferred. Accordingly no steps need at present be taken in regard thereto

Factory and Workshops Act 1901 Sanitary Conveniences

Read letter from the Ministry of Industry and Commerce No 71.15 dated 22nd November 1922 Relative to the necessity for the provision of adequate and suitable sanitary accommodation in accordance with the provisions of the Factory and Workshops Acts 1901 and enquiring whether the Council has adopted standards under Section 22 of the Public Health Act 1890

The Town Clerk submitted his reply of the 25th Nov 1922 that the Council had not prescribed any standard under Section 22 of the Public Health Act 1890 re Sanitary Conveniences for Manufactures etc

Reception to the Civic Guard

Read letter from the Ministry of Local Government No Q. 84/11/1922 dated 1st December 1922 re proposed reception to the Civic Guard and pointing out that the expenses incurred in connection with this reception may not be placed on the rates

Contribution in lieu of Rates on Government Property

Read letter from the Commissioner of Valuation No 2211054 dated 16th November 1922 enclosing Form of Application for payment of Contribution in lieu of rates for the current year for completion

Form completed and returned.

Report of Medical Officer of Health

The Medical Officer of Health reported that in the house in High Road occupied by James Scott (Owner Mr M. J. Finnegan) the floor of the room is rotten in several places and the joints which are bare are eaten away with dry rot giving rise to a smell and in his opinion it is unsanitary and injurious to health and he recommended that new joints properly ventilated and a new flooring be put into the room in question.

Ordered that notice be served on the owner and one month allowed to carry out the works recommended by the Medical Officer of Health.

Reports of Sanitary Sub-Officer

The Sanitary Sub-Officer reported having since date of last meeting inspected 50 Houses, yards and premises. At Mr. Clure's Terrace he found 3 Ashpits requiring to be emptied. That Hugh McCay of Church Hill had not done anything to comply with the Notice requiring W.C. Accommodation to be provided for house occupied by Manus McMonagle Main Street.

Ordered that the Surface Men be directed to have the Ashpits at Mr. Clure's Terrace cleaned out.

Ordered that Hugh McCay be notified that the Council will not extend the time beyond the date of next Monthly Meeting for him to carry out the works required in connection with house occupied by Manus McMonagle.

The Sanitary Sub-Officer also reported that David Kelly had complied with the requirements of the Notice to provide a sufficient Water closet for house at Main Street occupied by him and his undertenant.

Water Supply

Read letter from Dr. Moore R.M.S. Asylum dated 22nd Nov 1922 Calling attention that there was only 3' 8" of water in the reservoir and it struck him the supply coming from Lough Salt was smaller than ever.

The Town Clerk reported that having consulted with the Chairman he gave directions to the caretaker at Lough Salt to resume the fortnightly scouring of the Valves on the Lough Salt Main so as to remove air lock that might take place.

The Council ratified the order.

Alleged Nuisance @ Vacant Space

Read letter from the Vice Principal Little Remy Technical School dated 21st Nov 1922 Acknowledging receipt of the Town Clerk's letter re above and stating that there has been a considerable improvement in the area referred to since the Council's action in the matter.

Settlement by Negotiation

Read resolution forwarded by the New Ross Rural District Council passed by them at their meeting on the 8th Nov last calling on the leaders of the warring parties to meet and arrange a truce give orders to cease fire and settle existing differences by negotiation and thereby permit the country to settle down to peace and prosperity.

On the motion of Councillor John Doherty seconded by Councillor John P. Speer the resolution was unanimously adopted.

Report of Water Manager

The Water Manager reported 5 feet of water in Glenear Reservoir and 3' 9" in Barnamuggagh Reservoir on the 3rd Dec inst. That the scouring of Lough Salt Main last week improved the flow at Barnamuggagh. Very little water from auxiliary supply at Barnamuggagh. The water is on to the town for 10 hours daily. All the street fountains are in good order except one in Church Lane which is constantly put out of action.

Gas Managers Report

The Gas Manager reported that during the Month of November 461 930 cft of gas had been manufactured from 57 tons 7 Cwt of Coal that there were no additional consumers since last meeting All the Gas plant is in good working order.

Rate Collectors Account

The Rate Collector Mr Neil Jones submitted a Schedule of uncollected Rates for the Half year ended 30th September 1922 on Vacant premises amounting to £19. 18. 5 and claimed repayment of same from the Council under Article 92 of the Public Bodies Order 1904

The Council recommended that the amount £19. 18. 5 be struck off as irrecoverable for the reasons stated in the Schedule and refunded to the Collector

Unemployment Grant

The Town Clerk reported that the £300 allocated to the Urban District for the relief of unemployment had been received from the County Council since date of last Monthly Meeting

The Council fixed the rate of wages to be paid Workmen at 7th per hour and appointed the Chairman of the Council and Councillor Patrick O'Donnell to sanction the employment of men by the overseer. They agreed to offer the overseeing of the works to Patrick Sweeney who acted in a similar capacity for the Steam Rolling Contract and fixed his wages at £2 per week should he not accept the job a Special Meeting of the Council

Reports of Medical Officers of Health

The Medical Officer of Health reported that the house in Post Road occupied by Michael Hogan owner Mrs Kathleen Mulholland had no Water Closet accommodation and recommended that the Landlord be asked to put a W.C. in the house or yard

Ordered that Notice be served on the Owner requiring sufficient Water Closet accommodation for said house to be provided within the space of one month from the service of the Notice

Further the owner be notified that if the Notice is not complied with within the time mentioned the Council may at the expiration of such time do the work required to be done and recover the expenses incurred in so doing in the manner provided by the Public Health (Ireland) Act 1878

Faulty Chimney

The Medical Officer of Health reported a faulty Chimney in connection with houses occupied by James McDevitt and Connell Bradley at Main Street Owners respectively Richard Collins Ballymacool and John R Fleming Derry. That the condition of affairs is injurious to health and he recommended that the flue be opened up and necessary renovation carried out

House not hygienic

The Medical Officer of Health reported that dwelling house at High Road occupied by Mr Bonaghan is not in his opinion hygienic from two partitions in the Kitchen made of bags covered with plaster - That the plaster has fallen off in places leaving the bags bare - He recommended that the partitions in question be demolished and suitable wooden partitions erected

Ordered that Notice be served on the Owner Mrs M J Finnigan and one month allowed to carry out the recommendations of the Medical Officer of Health

Reports of Sanitary Sub-Offices

The Record of Work performed by the Sanitary Sub-Offices since date of last meeting was submitted and showed that 30 houses and yards in Lower Main Street had been inspected and no nuisances found to exist - He further reported that the Provision of Water Closet accommodation for house occupied by Manus McMonagle owner Hugh McCay Church Hill was now in the hands of a Contractor

Lough Salt Water Works

The caretaker Lough Salt reported having scoured the main on the 13th + 27th days of December 1922

Gas Consumption Tirconall Mental Hospital

Read letter from the R.D.S. Tirconall Mental Hospital dated the 19th Dec. 1922 that as the Gas Meter has shown an abnormal increase in the consumption as compared with the corresponding months of 1921 requesting that the meter be examined to ascertain whether it is registering accurately.

The Town Clerk was instructed to reply that the Gas Manager had examined the Gas Meter and ascertained that it was registering accurately. Any increase in the Gas Consumption in the Hospital must be accounted for otherwise than by comparison of corresponding periods as recorded by the meter.

Gas Manager's Report.

The Gas Manager reported that during the month of December 557 050 c.f. of gas were manufactured the coal carbonised being 68 tons that the long shed ordered by the Council to be erected was now complete the work being satisfactorily carried out by John Harkin a full statement of the Accounts up to the 31st Decr. would be left before the meeting after going carefully into the Accounts he recommended a reduction of 8% per 1000 c.f. in the price charged for gas. All the Gas plant was in good working order.

The Report was adopted.

Gas Works Account 9 Months ending 31st Decr. 1922

The Accounts of the Gas Works undertaking for the period 1st April 1922 to 31st December 1922 was submitted and showed on the Revenue Account a profit of £3. 1. 2. The Gas manufactured for the quarter ended 31st December was 1,334,590 c.f. allowing 3% for Condensation left 1,294,553 c.f. for distribution 22000 c.f. were used in the works and 1,055,600 c.f. sold leaving 208,953 c.f. or 16% unaccounted for.

The Gas Manager Mr Kelly was complimented on the satisfactory working of the undertaking.

Reduction in the Price of Gas.

The Council unanimously reduced the Price of Gas from 12/6 to 10/- per 1000 c.f. from the 1st day of January 1923.

Gas Manager's Collection Account.

The Gas Manager's Collection Account was submitted and showed arrears of Quarters prior to 31st December 1922 outstanding amounting to £61. 8. 1.

Water Managers Report.

The Water Manager reported that the Layburn Reservoir at Carnamuggagh reached the overflow on the previous Friday and this day the Town Reservoir was within 1' 6" of the overflow. Glencair Reservoir stood at 6' that the scraping of the South Salt Main would be commenced in the near future. Fire Plugs and Water fountains were in good working order. The town was being supplied from Town Reservoir at Carnamuggagh.

Public Lighting.

Ordered that the Public Lamp at Mr Bartley Ramsay's Main Job be put in order and lit for the remainder of the Season.

Unemployment Grant.

The overseer reported that he was unable to procure Carters to cart the stones from the Quarry to the roads at the rate fixed by the Council.

Ordered that the matter be left in the hands of the Town Clerk and the overseer to arrange the price for the Carting.

The Overseer was authorised to dismiss any workmen not giving satisfaction to him in the carrying out of the relief works.

Shops Act.

The Shops Act Inspector reported that the provisions of the Shops Act were being observed in the District.

Alleged defective Gas Meters

The Gas Meters at Burt Hall National School was alleged by the School Authorities to be registering fast and that the consumption for the period ended 31st March 1922 was entirely excessive.

Ordered that the meters be sent for testing.

Housing MinutesBallymacool Terrace Tenants

A number of the Council's tenants from Ballymacool Terrace attended the Meeting and handed in a Notice that they would refuse to pay rents for the Gardens from the 6th January 1923 unless the Council put up some kind of a fence to save their crop.

The tenants having stated their grievances the Council decided to have a gate removed from its present position and re-erected at entrance to the gardens, so as to prevent animals trespassing.

Councillors William Boyle and Edward McQuaid were appointed a Committee to consult with the tenants as to their taking the vacant gardens.

Water Manager's Report

The Water Manager reported having visited the previous day the Glenear and Lannamuggagh Reservoirs there were 9 feet of water in Glenear reservoir and the upper reservoir at Lannamuggagh was at the overflow. That during the past month the entire main from Sough Salt to Lannamuggagh had been scraped a distance of about 10 miles. Had it not been for the assistance of the 3 inch scraper which scraped the incrustation the 5 inch scraper would never have been got through.

He strongly recommended the Council to order the scraping of the main to be carried out annually. During the scraping operations the scraper got stuck three times. He intended next day cutting out the automatic valve and hatch box and replacing same by 30 feet new main. Some years ago this valve was partly dismantled and the side plates are obstructing the free passage of the water. This valve is only passing $3\frac{1}{4}$ inches of water and he was of opinion when the proposed work is complete the pipe will deliver about 4 inches of water into Lannamuggagh reservoir.

The Report was adopted

Gas Manager's Report

The Gas Manager reported that during the month $67\frac{16}{20}$ tons of coal were carbonised producing 506980 cf. of gas. The public lamp at Bartley Ramsay's ordered at last meeting to be lit had been put in commission. The 5 light gas meters Birkhall School had been sent for testing. That cargo of coal received last week was a good coking gas coal with little ash. All gas plant was in good working order.

Gas Manager's Collection Account

The Gas Manager's Collection Account was submitted & examined and showed arrears of Quarters prior to 31st December 1922 amounting to £61.3.1. outstanding

Lenders for Motor Car Service

Ordered that Lenders be invited for supplying all Motor Car service required by the Council for the year 1st April 1923 to the 31st March 1924 @ per mile

Special Water Tax.

The Council fixed the 1st day of April 1923 as the date for the revised scale of charges for water for other than domestic purposes coming into operation. They revised the charge for water to public houses to 10/- a year and for water to fields to 10/- a year.

Water Supply to Mr Charles Kelly's Mill Premises

Read letter from Mr Charles Kelly Steam Mills Little Renny dated 29th January 1923 relative to the accommodation of the town's water to his mill yard and stating that in view of the employment which his mill affords that the Council in fixing a rent for the water will appreciate same.

Extract from Report

The quality of the building mortar is poor as the lime is of an inferior quality and contains a large percentage of millstone grit. It should be mixed in the proportion of 1 lime to 2 sand as specified or it should be gauged with Portland Cement 1 part to 6 parts of ordinary mortar.

The building stones are also very poor quality.

Further letter from the Ministry of Local Government Ref No. H. 362/28 1922 dated 24th January 1923 on same subject.

The Town Clerk submitted copy of his letter of the 27th January 1923 in reply of which the Council approved. The Architect of the Scheme Mr John Mc Intyre was in attendance and informed the Council that the works were being carried out in strict accordance with the specification that the matters referred to by the Inspector in his report had been rectified immediately after Mr O'Maille's inspection.

The Tenders of Messrs John Kelly Ltd Londonderry was the lowest and the Council accepted the tenders for 200 tons best St Helens Screened Gas Coal delivery in June 1923 at the price of 4/6 per ton

The desirability of getting the Gas Coal by Steamers at Port-Ballypaine Quay was discussed and the relative cost considered

It was decided to ask Messrs Kelly Ltd at what price they would be prepared to deliver a cargo of about 200 tons of the same class of coal as now contracted for ex Ship at Port Ballypaine in the month of October next as the Council are anxious to open up and make use of waterway provided the prices of rail and water are equally favourable.

Recreation Ground

Ordered that notices be served on the owners and one month allowed to provide sufficient Water Closet accommodation for each house.

glazing of the lamp heads should be taken in hand. That 4 new lamp heads are required to replace worn out ones. All the gas plant in good working order. The report was adopted.

President Cosgrave's Visit to Salthill

Address

Dear Mr President

On the occasion of your visit to our townships we the members of the Salthill Urban District Council on behalf of the people whom we represent bid you welcome. The part which you took in the struggle that culminated in the Treaty earned for you the admiration and respect of the Irish People. But there were more difficult times ahead and the responsibility you were asked to shoulder when you took up the unfinished work of our late beloved President Griffith was enough to make even a very great man hesitate. During the last twelve months you have earned the confidence and respect of all those who believe in majority rule and democratic government. No man was ever confronted with a more difficult or dangerous situation. We will remember the terrorism that was rampant here in Donegal some twelve months ago and we cannot help noticing the great change

that has since taken place. All this is due to the unparalleled courage of yourself and your Executive backed up by the brave men of the National Army to whom the Country owes so much. We know that Kilkenny only awaits the opportunity of again returning you at the head of the Poll and we are confident that the Irish People realising the critical years that are before us, will return a strong National Party to re-elect and back up the present Executive who have rendered such service to our Country.

Protest Against Abolition of National Benefit Committee

On the motion of Councillor John Doherty seconded by Councillor Patrick O'Donnell the following Resolution was unanimously agreed to:—

That we the members of the Salthill Urban District Council protest in the most emphatic way against the change in the system of dispensing outdoor relief or National Benefit as by the change a large number of destitute people are left to starve or to depend upon the charity of the people for a crust to sustain life. By the scheme for the abolition of Workhouses the destitute people were to receive 10/- a week National Benefit this by an order of the late Government was reduced to 4/- the same an order from the same source abolishing the National Benefit Committee and placing authority in a County Board of Health. Through all this middle of the Government the local National Benefit Offices has no money and the state of affairs mentioned above is a bitter fact for the persons concerned.

Housing Minutes

Increase of Rent and Mortgage Interest (Restrictions) Act 1923.

Read letter No 501/2521/1923. Dated 5th July 1923 from the Ministry of Local Government stating that the above Act came into operation on the 24th June last and is to continue in force until 20th June 1926. Copies of the portions of the Act chiefly affecting the Administration of Local

Authorities were enclosed and particular attention was directed to the provisions of Section 3(6) 4(a) 8(2) and Section 16.

Payment on A/c of Grant

Read letter No. 362/26/1923 Letter Penny Urban District dated 7th July 1923. from the Ministry of Local Government stating that a sum of £675 had been paid to the Council's Treasurer as a further instalment of the Grant allocated to the Council in respect of their approved Housing Scheme out of the Government Housing Grant of £1,000,000.

Rents of Houses at Back Road.

Read letter from the Ministry of Local Government No. 362/27/1923. dated 23rd July 1923. Relative to the entry in the Minutes of the Council on the 2nd July 1923, as to the fixing of the rents of the four houses recently provided by the Council under the Housing of the Working Classes (Ireland) Act and requesting to be furnished with particulars of the payments to date and outstanding liabilities in connection with the Scheme.

Particulars furnished on the 26th July 1923.

Read further letter from the Ministry of Local Government No. 362/27/1923 dated 3rd August 1923 stating that the weekly rent of 7/- at which the houses are let is not even sufficient to meet the Annual Charges on the Scheme, notwithstanding the fact that 75% of the Cost is being met from Free funds. (Rates and Government Grant) The rent fixed would yield £72:16:0 annually while the outgoings would be £83:14:0 involving a deficit of £10:18:0 per annum. That the ratepayers have already contributed towards the provision of the houses and the Minister is not prepared to approve of an inadequate rent which would throw an additional burden on them. A rent of 8/- a week is the lowest which will ensure the Council against loss. This would yield after deducting Collection Charges about £79 per annum to meet charges of £66:5:3. on loan and £1:16:0 for Insurance leaving only £10:18:9 for maintenance which is an inside figure.

It was added that the Council might consider selling the houses to the tenants on the lines of a memorandum enclosed. That a number of local Authorities have already found this a solution to the rent question.

The Council considers that the weekly rent of 7/- so fixed by them is the maximum rent that could be obtained for the Houses. The tenant being also responsible for the rate on the Houses. The Agents for the Sale of the Houses to the occupying tenants meets with the approval of the Council and the Town Clerk was instructed to convey the terms to the tenants and ascertain whether they would be prepared to purchase.

Letting of No 11 & No 21 Ballymacool Terrace.

The Town Clerk reported having let as Weekly Tenancies House No 11 Ballymacool Terrace with garden at 3/3 a week to Michael Collins and House No 21 Ballymacool Terrace with garden at 2/6 a week to James Rowan. Tenancies to commence on Saturday the 28th July 1923.

Read correspondence with Messrs John Kelly Ltd Londonderry as to delivery of a cargo of Gas Coal at Port Ballygarra. That taking everything into consideration the Council would be well advised to take this cargo by rail through Derry and they offered prompt delivery within the next 10 days of 200 tons Best St Helens Screened Gas Coal as last delivered at the same low price 4/6 per ton delivered at Old Town Station.

The Council accepted the offer and further decided to take a further parcel of 200 tons of the same coal at the same price at such time hereafter as may be arranged provided Messrs Kelly Ltd agree to supply same on these terms

Acknowledgement of Vote of Condolence

Read letter from Mrs Mitchell and family, acknowledging receipt of letter of condolence on the death of her husband the late Mr A Mitchell former Gas Manager of the Council

Report of Medical Officer of Health.

The Medical Officer of Health reported that a nuisance is caused at the Oldtown Railway Station Letterkenny by the absence of a W.C. at the Station and also at the Station Masters House and recommended that a W.C. be installed at the Station for the Public and another at the Station Masters House.

Ordered that the notices be served on the Letterkenny & Lough Swilly Railway Company requiring them to provide Water Closet Accommodation as recommended by the Medical Officer of Health within one month

That the season has been the wettest for the past 22 years, and notwithstanding this the full supply coming from Sough Salt the Asylum Reservoir has on several occasions this year been below the overflow. He again suggested that a meter should be put on for the town and another for the Asylum, so that the exact consumption could be seen.

The Town Clerk was instructed to reply that the Reservoir for the Town constructed by the Asylum Committee has never yet been made water tight though this was promised by Dr Moore in August 1922 to be done. The Council again request this work to be carried out before the suggestion as to meters is considered by them.

Water Managers Report.

Read letter M 7493 dated 25th January 1924 from Mr Hunt Secretary and General Manager Londonderry & Lough Swilly Railway Co. drawing attention to the existence of a serious nuisance adjacent to the Company's Gate House between Oldtown and Settle Railway Station caused by an open drain 200 yards long which conveys a large part of the Settle Railway Sewerage to the river and asking that the matter be immediately remedied.

The Executive Sanitary Officer was instructed to reply that the cleansing of the open sewer referred to has been discussed by the Council on previous occasions. The Council appointed the following as a committee to inspect the ~~sewer~~ and report to them the best method of dealing with same so as to remove all cause of complaint viz. The Chairmen, Councillors John P. Speer John Curran, and the Executive Sanitary Officer.

Sewer Kilmacrenan Road.

The Town Clerk reported that a manhole cover of the Public Sewer at Kilmacrenan Road got broken by the heavy motor lorry traffic since date of last meeting and that he had ordered a new cast iron cover for same.

The Council ratified the action taken by the Town Clerk.

Reports of Sanitary Sub-Offices

The Record of Work performed by the Sanitary Sub-Office since date of last Meeting was submitted and showed that 40 Houses Yards and premises had been inspected. He reported having found a Sewer blocked at St. Columba's Terrace. Owners Mr M. J. Finnegan Occupier Hugh Longham that Anthony & Ferragal Gallaghers and Richard Collins had not complied with the requirements of the Notice served on them.

In the case of Messrs Anthony and Ferragal Gallaghers the works are in the hands of a contractor and the Council further extended the time allowed by the Notice to date of next Monthly Meeting.

In the case of Richard Collins the Executive Sanitary Officer was instructed to write Mr Collins that unless the requirements of the Notice be immediately carried out legal proceedings will be taken and the Executive Sanitary Officer was authorised to summon him to the District Court should he fail to comply with the terms of the letter. In this case a letter was also received from the Hon Sec Settle Railway Branch of the All Ireland Towns' League drawing the attention of the Council to the existing nuisance.

Ordered that Notice be served on Mr Finnegan requiring him within 14 days to make good the defective sewer.

Sanitary Notice Oldtown Station

Read letter from the Manager Settle Railway & Lough Swilly Rly. Co. dated 16th January 1924 stating that he noted the Council had agreed to an extension of time to this date in connection with the Notice requiring W.C. accommodation to be provided for the above station.

The Sanitary Sub-Office reported that nothing had yet been done to comply with the Notice.

The Executive Sanitary Officer was instructed to write the Railway Company and enquire when they expected to start the works.

Shops Act Inspector's Report

The Shops Act Inspector reported that the provisions of the Act were being observed throughout the District.

Water Managers Report

The Water Manager reported having visited the previous day the two reservoirs. The Glencair reservoir was at the overflow. The Larnanagh the water level was 7' 9". The Sough Salt Water Works inspection committee having recommended that an additional hatch box should be placed on the main at Ballaghderg hill it would be advisable also to put a Sludge Valve. This would require 1.5 Valve. 1.5 in T piece 1.5 in Collar. He recommended that the position of the hatch box should be the level best part of the road. Little Kenney side of Campbells! He considered an occasional visit to Sough Salt during Sludging operations would be advisable. That he inspected all the Air Valves on the Sough Salt System on the previous Friday. He was drilling and tapping two of the Small Air Valves. covers and inserting a 1/2 inch pipe 6 inches long so that the working of these Valves can be more readily ascertained.

The Council adopted the report.

Sough Salt Water WorksCommittee Report

The Committee appointed at last month's meeting with Bull Power to have all works carried out that might be considered necessary to increase the flow from Sough Salt or conserve the water supply reported having visited the different reservoirs and made an inspection of the entire system. Glencair and Sough Salt. They found the Glencair reservoir at the overflow. They had the several Sludge Valves and Air Valves on the Sough Salt System examined at Kilmacrenan and the Glassagh. They found on the Sludge Valves being opened a full supply in the main under strong pressure. Ballaghderg hill reduced the quantity of water in the pipes and at the top of the hill the pressure was considerably reduced. They considered an additional Hatch box should be placed on the main at Ballaghderg to facilitate scraping operations and that the main should be at once scraped from the Glassagh Bridge to the Reservoir at Larnanagh. That an occasional surprise visit should be

paid by the Council and the sludging of the main carried out under their observation. During their inspection they found the Town Water being used washing a Motor car at a tap for supplying the dwelling house occupied by William McAuley. Owner also noon.

The report was adopted and it was ordered that the additional hatch box and sludge valve be provided that the main be scraped from the Glassagh river to the Reservoir at Larnanagh and that an additional surprise visit be paid for sludging the main further that the owner of the tap for William McAuley's house be required to have frame removed to the house. otherwise that the supply will be cut off.

Waste of Water

It was reported that there was a waste of water in field at Newline recently occupied by Mr William Gallagher. Owner Mr Thomas MacFadden caused by a defective cattle drinking trough tap.

Ordered that the owner be called upon to at once repair the tap should he fail to do so supply to be cut off.

Gas Manager's Report

The Gas Manager reported that during the month of January 588 080. C.F. of gas had been manufactured out of 73 tons 16 cwt. Coal.

There was an increase of 81,100 C.F. in the corresponding period last year. That it would be advisable to order a cargo of 200 tons coal.

That all the gas plant was in good working order.

The report was adopted. The Council directed that the balance of 200 tons of coal on order be now got.

Gas Manager's Collection Account

The Gas Manager's Collection Account was submitted and showed the amount outstanding to be £71. 2. 9.

Town Court

The reestablishment of the Town Court was considered by the Council and it was the unanimous opinion that the Court should be again set up.

The Town Clerk was instructed to communicate with Mr L J Walsh District Justice on the subject.

Quarry of Stones

The Council decided to advertise for the raising and piling of 500 tons of stones at the Glencair quarries for road metal.

Tenders to be considered at a Special Meeting of the Council to be held on Monday the 18th day of February 1924 at 7 o'clock P.M.

The following were appointed a Committee to visit and inspect the quarry and report on same to the Council Councillors William Doyle John Curran and the Town Clerk.

Street Closures

Complaints having been made as to boilers at upper Main Street the Town Clerk was instructed to bring the matter under the notice of the Fire Guard.

Housing MinuteAllocation of the Irish Housing Fund

Read letter No H 501/2666/1924 M.S. dated 11th January 1924 from the Ministry of Local Government requesting to be furnished with particulars of the liabilities (if any) of the Council as at the 1st April last in respect of repayments of principal and interest in the course of the financial year ending on the 31st March 1924 on foot of moneys borrowed after the 21st Dec. 1908 under sanction for the purposes of the Housing of the Working Classes (Ireland) Acts 1890 to 1908.

Particulars supplied

Dampness in Gable No 25 Ballymacool Terrace.

It was reported that the damp was getting into No 25 Ballymacool Terrace gable and destroying the house. That the Chairman and Town Clerk had interviewed Mr Charles Kelly the owner of land adjoining from which the dampness came and had asked his permission to make a trench on his land and fill up same with stones so as to prevent the dampness or to give the Council a Cartway over his land at the gable of the house. Read letter from Mr Kelly in which he stated that if the proposed cartway is of service to the Council he would be prepared to consider an offer on the other hand he would be prepared to permit the Council to cut a trench and fill it in in an improved manner.

Numbering of Houses

Read letter from the Ministry of Local Government No. 9238/1924 dated 8th March 1924 that representations have been made that delay in the delivery of letters and inconvenience to Postal Officials frequently occur through the failure of householders and others in Cities and large towns to have their houses properly numbered. Directing the attention of the Local Authority to their powers in the matter and requesting them to take the matter into early consideration with a view to having any necessary alterations made to meet the suggestions put forward in their letter

The Council unanimously decided not to take any action in the matter

 transferred to the Council of such County Borough or Urban or
 Rural District"

The Town Clerk reported that the Rate collector had not closed
 his collection within the intended time and that the sum of £63.1.9
 remained undelivered to the credit of the Council

Read letter dated 4th April 1924 from Mr Neil Jones that
 he must again ask the Council to give him another month's
 extension to complete his collection. He did his best during the
 past month to have all the rates collected though suffering from

bad health all the time that he placed himself in the Council's
 hands and promised some what may be will have all rates squared
 up before the 1st day of May next.

Petrol Pump Shell Mase. Kilmacrenan Road

The adjourned consideration of Mr Jack McAuley for permission to
 erect a petrol pump (Shell Mase) at Kilmacrenan Road on site
 indicated on plan lodged was taken up. The Town Clerk reported
 having interviewed Mr Logue occupier of the premises opposite
 which it is proposed to erect the pump and that Mr Logue had
 no objection to same being placed there

The Council agreed to grant the permission sought subject to an agreement in writing being prepared by the Council's Solicitor at the cost of the applicant and at such rent as may be agreed upon the Council to have the right to call for the removal of the pump at any time.

The Town Clerk was instructed to ascertain from Strabane and elsewhere the rents usually charged in cases of the kind.

Nuisance at St Columba Terrace

The Executive Sanitary Officer informed the Council that the Sanitary Sub Officer reported to him on the 21st March that a dangerous nuisance at St Columba Terrace the property of Mrs M J Finnegan and that he had served a 148 hours notice on her requiring the nuisance to be abated by having the Sewerage System repaired and the block therein removed.

The Council ratified the action taken by the Executive Sanitary Officer.

The Sanitary Sub Officer reported that the Notice referred to had been complied with.

Sanitary Sub Officers Reports

The record of Work Performed by the Sanitary Sub Officer since date of last Meeting was submitted and showed that 50 Houses Yards and premises had been inspected. That he found a broken Sewer at Mrs Finnegan's property High Road. A broken Sewer at yard of James O'Donnell's premises at Major's Lane and no water in W.C. of Charles Strains at Rosemount Terrace.

Ordered that Mr Finnegan be interviewed as regards the broken Sewer at High Road. That notice be served on the landlords regarding the broken Sewer at James O'Donnell's yard and that the Water Managers have the water restored to W.C. at Charles Strains premises.

The S. S. Officer reported that the Sanitary Notice served on Richard Collins respecting house occupied by James McDevitt at Main Street had been complied with.

Vaccination Defaulters

The Town Clerk reported that Hugh Brown against whom proceedings had been ordered under the Vaccination Acts had all his children vaccinated and that therefor no legal proceeding had been taken against him. That Summons had been issued against George Black Rosemount and Michael Blake Kilmacrenan Road that in Black's case the child was found to be dead and in Blake's the Vaccination had already been performed.

Ordered that the next three on the list of Defaulters be now proceeded against.

Shops Act Inspector's Report

The Shops Act Inspector reported that the provisions of the Shops Act were being observed throughout the District.

Re Appointment of Town Surveyor

There were two applicants for the position of Town Surveyor as advertised viz Mr John M Lutzke and Mr Michael Callaghan.

The Council discussed the advisability of re-advertising the position and fixing the remuneration for the person appointed for works carried out by the Council of Loan Capital at 2 1/2% on the outlay.

Councillor William Boyle proposed that the position be re-advertised at an Annual Salary of £30. with 2 1/2% remuneration for works carried out by the Council out of Loan Capital - Seconded by Councillor Patrick O'Donnell.

Councillor Edward McDaid proposed as an Amendment and Councillor William Gallagher seconded that the appointment be now made at the salary of £30 a year as advertised.

Water Managers Report

The Water Manager reported 3 feet of water in Glencar Reservoir 4 feet of water in Larnamuggagh reservoir that the town was being supplied with 95% Glencar water during the past month that the supply is on to the town for 7 hours daily that a Sludge Valve had been put on the main at Ballymacool Terrace when at Kilmacrenan last week repairing a water leak. He visited all the yards at Kilmacrenan and found a good supply every where except at the Parochial House.

That he found too much pressure put on by the bare takes which he reduced to about half all the services and street fountains there he found in good repair that the hose and necessary fittings for the Motor car washstand had arrived and he would have same fitted up as soon as possible that the consumption of the L & L.S. Railway Co from 1st February to 1st April was 2,730,000 Gallons. Messrs. Watt 44,000 that fire plugs and street fountains are in good order.

The Report was adopted

Ordered that quotations for meters to be placed on the Asylum and Town Mains to ascertain the quantity of water used by each be obtained

Gas Managers Report

The Gas Manager reported that during the month of March 376,210 CB of Gas were manufactured out of 47 tons of Coal. That on account of coal arriving 2 days previous week and being engaged one day at Kilmacrenan he was not able to complete the reading of the Gas meters in consequence of which the Gas Works for year ended 31st March 1924 could not be ready in time for the present meeting

That all the Gas plant is in good working order

The report was adopted

Gas Managers Collection Account

The Gas Managers Collection Account was submitted and the arrears of quarters previous to 31st March 1924 outstanding found to be £129:11:6

Housing Minutes

Cost of Housing Scheme.

Read letter No 4 362/35/1924 from Messrs Urban District dated 21st March 1924 drawing attention to letter of the 10th December last relative to total cost of Housing Scheme carried out by the Council under terms of the circular letter of the 16th March 1922 and requesting to be furnished with a reply thereto

The Town Clerk stated that he had furnished the particulars required

Fencing of Gardens & Back Road

In response to advertisement there was but one tender received for fencing of the gardens and field at Back Road in accordance with the specification of the Architect viz that of Mr James Johnston for the sum of £37:15:0.
