Determination of whether or not the Material Alterations would be likely to have significant effects on the environment, and on the consequent need for Strategic Environmental Assessment (SEA) in accordance with Section 20(3)(f) of the Planning and Development Act 2000(As Amended).

## Submitted:

Report and recommendation entitled 'Strategic Environmental Assessment (SEA) Screening Report of the Proposed Material Alterations to the Draft Letterkenny Plan and Local Transport Plan 2023-2029'

The report takes into account the criteria set out in Schedule 2A of the Planning and Development Regulations 2001(As Amended) and recommends that the Planning Authority determine that the Proposed Material Alterations of the Draft Letterkenny Plan and Local Transport Plan 2023-2029 are likely to have significant environmental effects and that a Strategic Environment Assessment of same is required. In addition, the report also recommended that the Chief Executive now specify a period of 9 weeks following the passing of the resolution to alter the Draft Plan as being required to facilitate said assessment (i.e. by the 12th of July 2023).

If accepted, the effect of the recommendation would be that the Planning Authority agrees that the proposed material alterations would be likely to have significant environmental effects (taking into account the criteria contained in Schedule 2A of the Planning and Development Regulations, 2001 (As Amended)), and therefore a Strategic Environmental Assessment of same is required in accordance with Article 3 of the SEA Directive<sup>1</sup> and a period of 9 weeks following the passing of the resolution to alter the Draft Plan would now be required to prepare said assessment (i.e. by the 12th of July 2023).
