C/63/20 TO FIX DATE FOR THE 2020 ANNUAL GENERAL MEETING OF DONEGAL COUNTY COUNCIL

Mr Joe Peoples, Meetings Administrator said that in light of the ongoing Covid-19 pandemic and the need to comply with public health guidelines a larger venue was needed to accommodate a meeting of all 37 members of Council and relevant Council staff. He recommended that the forthcoming Annual General Meeting and the July Plenary Meeting be held in the Aura Leisure Centre in Letterkenny.

On the proposal of Cllr Canning, seconded by Cllr Gallagher it was resolved to hold the Annual General Meeting on Wednesday 17th June, 2020 at 3pm in the Aura Leisure Centre and to hold the July meeting of Council at the same venue.

Cllr Mc Monagle expressed concern that there had been no facility to submit motions and questions for the May meeting and queried whether it

was possible to accommodate same on the day of the Annual General Meeting. A number of Councils, he noted, had continued to meet and were conducting business as normal. Many issues, he said, had arisen over the past few months and members needed to have a forum to facilitate discussion on a range of issues. Donegal County Council, he noted, had sufficient accommodation to enable meetings proceed in as normal a fashion as possible.

The Cathaoirleach said he could appreciate where Cllr Mc Monagle was coming from but that the CPG had agreed in light of Covid restrictions and social distancing obligations to deal with statutory business only at the May meeting.

Mr Joe Peoples, Meetings Administrator alluded also to the fact that the CPG had agreed at their last meeting that the May Council Meeting would deal specifically with statutory business. There was, he noted, a significant wish to move to normal business as soon as possible. Standing Orders, he added, had prevented the meeting today from being held in the usual way. He said that going forward it was planned to have briefings at Municipal District level and that motions and questions could be submitted in the normal manner for the July Council meeting. It was noted that there were significant public health considerations and that members concerns would be taken on board in order for the meeting to safely proceed.

Cllr Canning said that with smaller numbers it was easier to accommodate Municipal District meetings. Whist agreeing with Cllr Mc Monagle that a return to normality was needed; he said that caution was needed at plenary level.

Cllr Mc Gowan proposed on behalf of Cllr Brogan, seconded by Cllr Mc Monagle to adopt the following motion:-

"We the members of Donegal County Council propose that this Council write to the Minister for Health, Simon Harris T.D, and the Chief Executive Officer of the Health Service Executive, Mr Paul Reid and Ms Elaine Austin, Chief Executive Officer, Pieta House."

Cllr Mc Gowan said that if planned cutbacks went ahead services would not be provided this side of the Dublin /Galway line after June 2020. This, he contended, was unacceptable given that considerable time and effort that had gone into developing the Pieta House model. He asked for clarification in relation to the ongoing plans for Pieta House in the North West given that the Health Service Executive had committed to providing of €114,000 per month until year end.
