

The following Letters from the Local Government Board for Ireland and others, were read by the Clerk, and directions given him to answer them respectively, to the following effect (or, orders made on them respectively), as follows:—

Letter from Local Govt Board
no 33, 11574, date 17th July 1916 forwarding
a copy of the Report of the Auditor on his
audit of the accounts of the Guardians for
the half year ended the 31st March last with
abstracts of the accounts.

The Auditor mentioned that the total
expenditure for the half year under audit
was £1202-9-0 as against £1116-11-3 for
the corresponding period of the previous
year.

No observations were made on the report.
Dr Johnston wrote strongly recommending
a patient in the Infirmary named Mrs
Morgan, who is suffering from Large
vesicles vaginal, to be sent to an Hospital
in Belfast for special treatment.

Dr Boyd, Lifford also wrote stating
that he was unable to perform the necessary
operation and the Guardians should send
her to the Samaritan Hospital, Belfast or
the Ulster Hospital as he believes the
case curable, she is a fine young
woman and would have a life of misery
unless something is done for her.

The Clerk stated that he had communicated
with the Matron of the Samaritan Hospital, Belfast
who replied on the 23rd July that the patient
could be admitted but that it would be necessary
that she should be sent at once as the Surgeon
who performs operations, is going on leave. The
terms are £1.0 a week.

The Clerk continued that there was no meeting

of the Guardians on the 24th July to deal with the matter
and owing to the urgency of the case to look the
responsibility of sending the patient to the Samaritan
Hospital Belfast on the 25th July.

The Guardians approved of the action of the
Clerk and commended his conduct in the
matter.

Letter from LGFB no 34766 date 28th July 1916
forwarding the substance of a report which they have
received from their Inspector W. Robinson B.L.
consequent on his recent inspection of the Whouse
and requesting that the matters adverted to may
receive the attention of the Guardians.

The copy of report referred to
the workhouse grounds are neatly kept and
properly tilled. The crops on the Whouse farm
are the best I have seen about the country.
The condition of the Whouse is satisfactory.
The Guardians would expect a great improvement
if they would substitute latrine buckets for the wooden troughs
under the Fever Hospital closets. These troughs are on small
wheels and have to be dragged some way across a field to be
emptied. As all the slops of the Fever Hospital are
emptied into them, the contents are largely liquid and
in consequence splash about a great deal when the
trough is moved. The master informs me that,
generally speaking, the only inmates he has available
for this work are men who are more or less feeble
minded and who are so clumsy in their movements
that he is sometimes reluctant to put them to it, lest
they should become infected. The buckets would not
only be very much more convenient in this way
but they would be more sanitary than wood.
The Guardians considered the
report.

Satisfactory and directed ¹⁰ the cost of the latrine buckets to be ascertained.

The matron, Sister Lorewya and the Infirmary nurse, Sister Mary Joseph applied for one months leave of absence. Two other Sisters will discharge their duties during their absence - granted.

Miss Cassidy, temporary nurse in the Fever Hospital applied for 4 weeks leave.

Three weeks leave granted. The medical officers and sisters undertaking to have the duties discharged.

The Porter, John Quinn, applied for two weeks leave granted as the Master stating that he would discharge the duties.

The Guardians resolved to allow Mrs Bannon 10/- a case and car hire

Dr Gormley applied for 14 weeks leave of absence and nominated Dr W. Monahan as his substitute at £4. 14. 0 a week. Granted with Dr W. Monahan appointed for 14 weeks at £4. 14. 0 a week.

Sister M. Alacogue Sheerin wrote resigning her position as assistant nurse in the Infirmary.

The resignation was accepted and it was resolved to issue advertisements inviting Candidates for the position of assistant nurse in the Infirmary at £30 a year with milk and Potatoes.

It was also decided to appoint a Wardsman for the Infirmary at £4. a year & ration Day of Elections. This day two weeks.

The Clerk submitted the following Report.

"On the evening of the 5th inst at 7.06 P.M. an inmate of the Workhouse came to my house in Stranorlar and told me that the body of Sam Mescon, who disappeared from the Infirmary on the 3rd inst, had been discovered in a field of oats adjoining the Whouse farm. I went at once and instructed the P.O. to have the body removed to the Whouse Mortuary.

Owing to the decomposed state of the body, the lead being apart from it, the P.O. had great difficulty in getting any one to assist in removing the remains, he however succeeded in obtaining men, under promise of liberal payment and finally got the body conveyed to the mortuary. The expenditure incurred by the P.O. was

10/- I also informed the Police who communicated with the Coroner and an Inquest was held when the jury returned a verdict of "Death from Shock & Exposure".

I would like the Guardians to recognise, in some way the services rendered by the P.O. on this occasion, the trouble he had in securing help and personally assisted in bringing the body to the Whouse.

In my opinion he deserves every credit for his energetic action in carrying out such an unpleasant work.

The Clerk added that the steps he took was necessitated by the Master's absence.

The Guardians approved of the expenditure of 10/- under the circumstances described and unanimsly resolved to allow the P.O. the sum of one Pound for the services rendered by him.

The Chairman said the Guardians were getting a lot of blame by the death of this man, the Master apparently ignoring the G.P.O. and leaving the house without their permission.

The Master expressed his regret at his absence and promised not to leave the institution in future without the permission of the Guardians.

Consequently the matter was not pursued further.

This man, Nixon, was supposed to get out of the Infy by door at the rear of the ^{inlet side of the} infirmary ~~ward~~. He could also have gone by the gate of the men's yard (Healthy portion) which is kept open for men working on the farm. Sister M. Alcocke Keerin was in charge at the time of this occurrence. Nixon was missed about 2.30 P.M. when the Sisters and inmates made a search for him. His disappearance was reported to the master at 3.30 when he and the other officials made a further search without any result.

Nixon was able to walk about the grounds and associate with the other inmates, but within the last few weeks he showed some slight mental deficiency. On this particular day 2nd inst he had taken his dinner, as usual, and was the first to leave the table.

The body was discovered by a labourer who was removing deep and who was attracted to the remains by a strong smell which he traced to the body. According to the Porter's Book, the master left the workhouse on the 5th Sept at 7.15 A.M. and returned at 10 P.M.

Letter from L.G. Board no 59, 349 date 9th Decr 1916, sanctioning the payment of 10/- a week with rations to Margaret M^{rs} Garvey for her services as temporary Workmaid in the Workhouse.

Letter from L.G. Board no 59, 447, date 15th Decr 1916, forwarding a copy of a letter which they have received from Dr Johnston relative to the remuneration of the substitute appointed to discharge his duties during his absence at Belfast assizes on subpoena from the Crown and stating that in the Board's opinion a Medical Officer of a Dispensary District, when summoned to attend a law court as witness is bound to obey the summons and is, therefore, temporarily incapacitated from performing his duties by "other causes" within the meaning of article 22 of the Dispensary Rules and the Guardians must remunerate the medical practitioner employed to act as his substitute. The L.G. Board can, under article 24 of the Dispensary Rules authorise a deduction to be made in certain circumstances, from the salary of a Medical Officer to recoup the Guardians the expenses incurred by them in providing a substitute although the Board consider that the scale of remuneration fixed by the Treasury for a medical witness in a Crown case affords the medical officer reasonable personal remuneration, they are of opinion that it has not been framed on the assumption that it is also to cover the cost of the substitute. In these circumstances the

Board have hitherto declined in Crown cases to authorise deductions in pursuance of article 24 of the Dispensary Rules.

Dr Johnston in his letter to the Board pointed out that on the 4th inst he had to leave home on a Crown summons to attend Belfast assizes and notified the Guardians nominating Dr Kerrigan as his substitute. The Guardians appointed Dr Kerrigan, but passed a resolution that he must pay his substitute although the Clerk pointed out that under article 22 the Guardians were bound to pay. Dr Johnston declines on principle to pay for his substitute as he is compulsorily taken from home by the Crown. His substitute fee is £4.4.0 for four days work and he must ask the L.G.B. to call upon the Guardians to pay the fee.

Ordered " that the foregoing letter be brought before the Guardians at a special meeting to be held on Monday the 8th Jan'y 17 for their decision."
