Read letter from L.P.B. no 114, 115, date 24th Sept 1915 informing the Guardians that they understand from their Inspector, Mr Price, that the water supply of the Whouse is most unsatisfactory. He states that there is a well in the Fever Hospital yard from which the water is supposed to be pumped to a large cistern, but though there was water in the well, there was only two inches of dirty water.

The Report of the Visiting Committee was read, and Orders given them as follows:

in the cistern which also contained a dead crow which appeared to be there for water.

The Inspector reports that the Fever Hospital surroundings were very untidy and overgrown with weeds.

The Master stated that the cistern was now cleaned out, the water was only used for rough purposes. The surroundings of the F. Hospital were receiving his attention. There was no shortage this year, of the domestic water supply to the Whouse.

The Clerk stated that the next lowest tender was Mr. W. C. Lure, Ballybofey, at 1:14.0 per cwt, and he would supply sugar at this price provided the Government duty was allowed in addition.

The Guardians resolved to re-advertise for sugar and were of opinion that if any contractor, whose tender for an article is accepted, refuses to perfect his bond for all the articles accepted, that his tender for the other items accepted, be rejected.

"The drugs were received on the 23rd Inst. I met with an accident on 22nd Inst and in consequence of which was six weeks absent from duty."

The following letter was read from Dr Johnston, Medical Officer of the Workhouse. ^{Superintendent of the Home}
"For your information I enclose a letter from the Nursing Sister. The facts of the case are these. On the 28th Inst I gave the Master a usual order to procure an extra nurse for the Infirmary. This nurse was duly sent from Bury on the same evening and took up her duties and apparently was going to give every satisfaction to the Nursing Sisters and myself. On the following Friday this nurse was suddenly changed and another younger nurse put in her place. I wrote to the Superintendent complaining that such a step should be taken without any explanation to the Clerk or myself. The enclosed letter is the Superintendent's reply."

I taxed the Master by asking him what authority had he for making the statement "the Guardians expected him to obtain a R.O. for the Infirmary." He shifted his ground and had the opportunity to tell me that some years ago, I ordered him to do so. I most emphatically and indignantly deny that I ever gave any such order. I leave the matter in your hands but I would ask that you give the Master instructions that in future he is not to interfere with any nurse sent to the Union under the doctor's charge.

I have spoken to this new nurse about going to the Master's sitting room and I have peremptorily told her that she is not to do so, if she requires anything from the Master she is to send her requisition through the Sisters in charge. It is for the Guardians to say, if under the circumstances this new nurse should be retained.

In her letter to Dr Johnston, the Superintendent of the Nursing Home, Bury, stated that she got a wire from the Master on Tuesday to send an a nurse for the Infirmary.

that day and I expected you know that from the first Stranorlar has sent here for nurses they have requested that I should send an R.C. if possible. I had no R.C. free so I sent nurse Coothery and wrote the master that I had no R.C. nurse but if it was necessary I would change and send an any R.C. as soon as I could. The Master replied that he did not mind about the religion but that the Guardian's expected him to obtain an R.C. for the infirmary as the patients are mostly R.C. My reasons for writing to the master was simply because it was from him I got the view and this is the whole explanation.

The Master repeated that it was the Doctor who told him nearly three years ago to get a R.C. as a temporary nurse. He also stated that it was Sister Joseph who sent this view to him for things he wanted.

The following is a copy of Mr. Price's observations:—

Male sleeping ward upstairs, boarded floor, 4 bedsteads with ticks, four black rugs being the only clothing in the ward.

Female sleeping ward upstairs, floor dirty with birds dung and plaster, which were also on beds. 6 bedsteads with ticks, a black rug on each, no sheet.

Bed clothing not sufficient. No provision for washing in either ward. Males and females have meals together in a room for the purpose.

Accommodation in this Workhouse is very bad.

Ordered "that the Master and Matron be instructed to have proper and sufficient clothing supplied to these wards and to see that the Inspector's Complaints regarding cleanliness are removed. The accommodation for casual has always been the same and no objections have hitherto been raised.

Letter No 52650 date 19th Novr 1915, relative to the proposal of the Guardians to grant portion of the Probationary Ward in the Workhouse for a Tuberculosis Dispensary and forwarding the following copy of a report which they have received from Dr Stephenson on the subject.

The following is a copy of Dr Stephenson's Report:—
The Probationary Ward is a cold, damp room, and is altogether unsuited as a Tuberculosis Dispensary. A small ward situated on the ground floor of the male side of the Workhouse Hospital is however, in every respect suitable for the purpose.

The ward was set apart some years ago for the reception of cases of Pulmonary Tuberculosis but owing to its aspect, and the absence of lavatory accommodation, has not been utilized. It is a comfortable apartment provided with a fireplace and can be approached by patients without entering the Workhouse.

The Guardians have no objections to allowing this apartment mentioned by Dr Stephenson, to be used as a Tuberculosis Dispensary.

Letter No 61914, date 25th Novr 1915, stating that they will raise no objection to the payment of 6/6 expended by the Medical Officer of the Workhouse in connection with a pathological examination.

Contract letter from L.G. Board date 16th Novr 15 forwarding a copy of a statement issued by the Royal Commission on the Supply of Sugar.

Letter from L.G. Board No 177, date 26th Novr 1915, bringing under special notice the large number of Irish Medical Practitioners who are on temporary service in the war and in consequence there has been a marked dearth of candidates for Poor Law Medical appointments. The Board would suggest that the Guardians should defer filling up any further vacancies, and make the best possible temporary arrangements pending the return of normal conditions on the termination of the war.

The Clerk was directed to bring this letter before the Guardians should a vacancy for a Medical Officer occur in the Union during the war.

Letter from L.G. Board No 61914, date 25th Novr 1915, relative to the proposal to grant permission to the Master of the Workhouse to join the Army and to appoint the Clerk of the Union as his substitute. With reference thereto the Board desire to state that the same person cannot be allowed to hold the positions of Clerk and Master and that some other arrangements should be made.

The Clerk stated that this matter might not now be pursued any further as the Master had been rejected by the military authorities on "Medical Grounds".

At the same time the Guardians wish to point out that the Clerk acted as Master on former occasions, without any objection by the L.G. Board, and his temporary appointment is the only arrangement could be made with any advantage to the Workhouse management.

Payment was ordered to the Clerk of £1.1.0 for acting for one week as Master.
The Schoolmistress applied for and was granted one week's leave of absence, the Matron to attend to her duties.

The temporary Carpenter of the Workhouse, J. Diver applied for an increase of pay from 3/4 per day.

The Guardians considered that if he was not satisfied with his present wages, they will offer him, as an alternative, six pence per working hour.

The relieving officer reported¹⁰ that Dr. Kerrigan is suffering from an attack of Diphtheria and he was obliged to appoint Dr. Johnston to discharge his duties at £3.3.0 a week pending the meeting of the Guardians.

Dr. Johnston wrote stating that Dr. Kerrigan is laid up with a mild attack of Diphtheria since the 24th ult. His case is not serious but it is necessary that he be granted a fortnight's leave.

The Guardians approved of the action of the R.O. and appointed Dr. Johnston as Dr. Kerrigan's substitute for two weeks at £3.3.0 a week.

Letter no 68776, date 12th Jan'y 1916 forwarding the substance of a report which the Board have received from their Inspector Mr Kelly consequent upon his recent inspection of the Whouse and requesting that the matters adverted to therein may receive the attention of the Guardians.

The following is a copy of the enclosure referred to cleanliness is duly observed in the several departments particularly so in the Infirmary. An exception might be made in the case of the casual ward. The day room floor of these wards should be removed as it consists of damp earth and should be replaced by one of concrete, the old bath should be removed and the drains attended to.

The lavatory accommodation in the Infy is fairly good but is not so in the Fever Hospital, where there is neither water closet nor bath room.

The water supply is not satisfactory.

The general wards are heated properly. The laundry drying room is out of order, but it is about to be repaired.

The drain from the water closets in Infirmary had been obstructed for days before my visit, causing a most disagreeable odour. It should be carefully watched in future.

The children are not regularly taken out for exercise, and there seems no reason why they should not.

There have been no children sent to service during the past half year. There are two grown up boys, 16 years old, for whom work of some sort should be found.

There is at present no paid Wardsmaid in the Sick ward and I understand the Guardians do not intend to appoint one, which I think is a mistake.

The ambulance arrangements are not satisfactory, there are only two wheeled ones.

It is proposed that the Porter's Book is properly kept, but as the Porter drives the ambulance - him to prayers.

does farm work &c, it cannot be relied upon.

The Relieving officer reports in his diary that the condition of the children at nurse is satisfactory. Reports do not go to the L.G. Board.

The roof of the Kitchen is in very bad repair. The chimney shaft in the wash house is badly cracked. The Nursery windows require new frames, as they cannot be opened without danger of falling out. They all require painting badly.

The painting inside and out has not been done for twelve years.

The unoccupied wards are not kept clean. Rubbish should be removed, and old boots &c, sold or burned.

The Fever Hospital tanks should be cleaned periodically and a cover put upon it.

The cooking arrangements are very primitive and extravagant as regards fuel.

Ordered: That the floor of the day room in the casual ward be concreted and the old bath removed.

With regard to the want of lavatory and water closet accommodation in the Fever Hospl, the Guardians applied for a loan of £230 to carry out improvements and alterations in the Hospital, and the L.G.B. authorized the expenditure but the Commissioners of Public Works did not reply to the application of the Guardians for this loan.

This matter, the Guardians think, must remain in abeyance till the money market becomes easier.

Water supply. This matter ~~was~~ was adjourned for further consideration.

The Master was directed to take precautions against the drain from the W.C.s in Infirmary being again obstructed.

The Schoolmaster to be directed to take the children out for exercise in favourable weather.

With regard to the two boys¹⁰ in the house, one is deformed, and the R.O. was asked to see if suitable outside employment could be found for either of them.

The Guardians fail to see the mistake in not having a paid Wardmaster in the sick wards as no complaints have been received regarding the manner in which the pauper attendant does the work and the salary is saved.

The ambulance for conveyance of the sick is rather an unwieldy vehicle but the Guardians don't like the idea of incurring additional expenses at present. By getting new shafts, the infectious disease ambulance would meet the necessary requirements. The R.O. reports of the children at Messes to be sent to the Lep. B. in future.

The roof of the kitchen, chimney shaft and nursery windows are at present being attended to.

The question of painting the whole establishment was adjourned till spring (April). The Master to see that the Inspectors observations regarding the unoccupied wards and tanks at Fever Hospital are carried out.
