2. Re Inspector's Report on Casual Ward, &c. — "The old wooden beds in use are at best shabby. The clothing, bed-ticks, and blankets, altho' discoloured & somewhat fairly clean. The floors are washed fortnightly and clean sheets put on. The ventilation is confined to a portion of the window, 6 fans in frame on pivots, plus 2 perforated fans. The walls have since been limewashed. No proper accommodation for washing. The W.C. would require to be remodelled, also the W.C. in School Yard. The foregoing could in my estimation be best remedied by replacing the old stone Bull sewer leading from the Kitchen yard to the Road which passes thro' the Joiner's shop flushing the two W.C.s referred to and passing afterwards within about 10 yards of our water supply. This would require about 100 yds. of a 10" sewer pipe with 10 yds. of a 6" or 8" offset pipe and safety trap to the casual ward, and the two closets supplied with brulley, otherwise they could be flushed by erecting a tank of 70 or 80 gal. which could be kept filled from the well. A second trap in the Joiner's shop in connection with the bath washing, 6 yds. of an offset pipe to the main end. A partition thro' the Joiner's shop some pictures and light admitted, and the old underground reservoir in the Kitchen yard filled up would go far to improve the drainage and sanitation of the male side and front buildings and save our well from organic - oozeings."

"The Gen. are satisfied that cleanliness is strictly observed; Ventilation satisfactory; W.C. to be cleaned weekly, or oftener if required; latter part referred to V. Committee."

The amts. were (1) £380.13.2, and (2) £40.7.11, making a total of £421.1.1, or an average of £84.4.3 for each year of the 5.

As we are at this question I may point out that Infirmary patients are not being billed for more than 9d a day. This is far below the average cost there, and as many well to do people avail of the Infirmary, and would be paying a 2s. for attendance if at home, the Board would do well to order that the full average cost be charged in all cases, to be reduced by the Board in any case where consideration reasonable to do so.

Next week each Infirmary patient consumed food to the value of 5/11 on an average, as against 2/10 1/2 in the body of the House. Add to 5/11 the cost of fuel, light, washing, clothing, repairs, and it will be found that 1/6 a day would be a reasonable charge for Infy. patients and 2/- a day for poor patients. To pay 10/6 a week in the Infirmary is much cheaper than staying at home and paying for food and comforts, drugs and doctors' bills.

As the food of each inmate in the body of the House costs only about 2/10 1/2 a week on an average, and as they get no butter or eggs, I don't see that any good would come out of producing their present dieting without an injurious to the aged and infirm whose fare is scarcely enough as it is.

"It has come to the knowledge of the Board that an Inmate was admitted on the 2nd inst, and died same day, and his remains taken away the following day without being reported."

The Imperial Hotel, Donaghadee, was advertised for sale by private treaty on July 1st last but without effect, and since then it has been put into liquidation for the benefit of the Imperial Hotel Co, Belfast, and all other creditors concerned, myself being served into the bargain with an ultimatum (being in possession) to come off at the Northbrook Auction in Oct., and I can assure you I have not received any benefit whatever from the Receiver appointed by the Court in charge of this matter, or had expect to do so. Respecting my father, he has never had any interest in the concern further than being the holder of five shares in it from which he never receives any consideration, and he looks on this investment now as lost money, and during his stay in the Imperial Hotel he always paid his board & keep in the ordinary way. The bath never belonged to him and it is at present in the hands of a Mortgagee who is about to foreclose for his own interests. If necessary I can make an affidavit on oath what I have stated is true, and any other particulars I will be glad to give if necessary on being from you."
