From Secretary Congested Districts Board Dublin date 19th inst referring to the resolution of the District Council, the Secretary states that the Board regret that owing to the state of their funds they cannot undertake the work this year. The Secretary however states that if the Board learn in due course what the County Council would be prepared to expend on the project, the Board might be disposed to give a contribution next year.

D<sup>r</sup>. Hamilton Medical Officer of Health of the District reported that he inspected the sewers in Bachelor's walk which has been opened for inspection, and he recommends that it be cleaned out from end to end and traps put on it instead of the present open gratings.  
The sewer to be cleaned out as instructed by D<sup>r</sup>. Hamilton

Hamilton also reported that on 28th inst he visited the premises of James Kern in ~~Bunclough~~ and found same in a most unsanitary condition, owing to the overflow from a pigstye and privy, and he recommends the immediate removal of the nuisance and the construction of a proper nuisance tank which can be emptied when necessary.

The following Letters from the Local Government Board for Ireland, or others were read, and directions given thereon as follows:—

Dr. Hamilton Medical Officer of Health of Ballyshannon Dist. reported: that the yards in the rear of houses on East side of Buck. St are in a filthy condition owing to stagnant water lying in them none of the houses having ashpits of any description, the owner has not carried out the directions given him some months ago.

The Medical Officer suggests that whitewashing both inside and out, should be made compulsory in these weekly rented houses.

The owner of the property referred to in Dr. Hamilton's report to be noticed to have the several premises put into a proper sanitary condition.

Dr. Hamilton also reported that he found a drain in a field in Bundoran in rear of houses occupied by Mr. Johnston, in an unsanitary condition owing to the sewage matter not having a proper course to run, covering a right of way from the houses to the sea, and Dr. Hamilton recommends that the drain pipes be continued from Mr. Johnston's garden to a cesspool about 10 yards below the pathway.

The Councillors for Bundoran Division to be requested to examine the nuisance complained of, and report as to the means to be adopted to abate it.

Dr. Hamilton recommends that a grating be put on the end of the sewer recently cleaned in Bachelor's Walk, Ballyshannon, as he found the outlet built up with stones, when he visited it lately.

Dr. Condon J.P. proposed Mr. W. Ward seconded and it was agreed to unanimously.

That this District Council respectfully direct the attention of the Local Government Board to the inequality of the representation of No 1 Rural District on the Board of Guardians, as compared with the representation thereon of Nos. 2 & 3 Rural Districts, in view of the fact that No 1 District has a valuation nearly equal to Nos. 2 and 3 combined.

No 1 District with a valuation of £25,000 has only 20 Guardians whereas No 2 with a valuation of £17,000 has 22 Guardians, and No 3 with a valuation of £9,724 has 20 Guardians, or a representation equal to No 1 which has a valuation almost three times great. The Council also desires to point out that in several of the Electoral Divisions comprised in Districts Nos 2 & 3 the Electorate does not exceed 25 or 30 votes and in view of the inadequate representation of No 1 Dist. on the Board of Guardians and the fact that the Board as at present constituted cumbersome and unwieldy the Council would suggest that the smaller Divisions in Rural Districts No 2 & 3 should be amalgamated.

The following Letters from the Local Government Board for Ireland, or others were read, and directions given thereon as follows:—

From Local Govt Board date 25<sup>th</sup> July 1899 acknowledging receipt of the forms A & B in connection with the loans of £4500 and £500 sanctioned to provide a water supply for Bundoran in Ballyshannon, Rural District, and stating that it appears from the return that the whole of the loan of £4500 was not required and the same applies to the loan of £500 which was for extensions. The expenditure according to the returns under the original loan was £4220:13:6 and under the loan of £500 for extensions £454:16:8, thus making the total expenditure £4675:10:2. The Board then state that they are prepared to recommend the issue of a further instalment of £175, but before doing so they would be glad to be informed whether any additional sum will be required to defray all expenses for the completion of the works.

M<sup>r</sup> Perry & Co. to be requested to state if any extra expenses will be incurred.

From Local Government Board date 25<sup>th</sup> July 1899, stating for the information of the Dist Council No. 1. that they have had before them representations made with regard to the chargeability of special expenditure to be incurred in connection with Bundoran Water Supply (and that they had before them ~~representations made with regard to the chargeability of~~) and that the Board have given attention to the views of the District Council on the subject and they consider that the District Council have shown some hardship will be inflicted by the operation of the General order of 15<sup>th</sup> May last, under which this expenditure is liable over the Ballyshannon Dist. District. The Board have therefore issued a further order (copy enclosed) which will take effect from 1<sup>st</sup> Oct

next exempting the works referred to from the operation of the order of 15<sup>th</sup> May, and directing that the area of charge for all expenses incurred in connection with these works shall, from 1<sup>st</sup> Oct next, be the special area declared by their original order. The area fixed by order of 15<sup>th</sup> May will therefore be only assessed for the amount of the charge included in the current halfpence rate.

Board date 11<sup>th</sup> Aug 99 stating that they have received the report of Dr. Gibbon their Medical Inspector relating to the sanitary condition of the Union and enclosing Extract therefrom and the Board request that the several recommendations made by the Inspector may receive the earnest attention of the District Councils concerned, a further extract relating to the Clerk's failure to put up to date the Sanitary Report Book is also enclosed and the Board state that they will take serious notice of any similar neglect of duty on his part in future.

The extracts from Dr. Gibbon's report relating to Dist. No 1 are as follows.

Hallinacreep. Dist.

Both water and sewerage of Hallinacreep are defective subject has been brought regularly under notice of Sanitary Authority by Medical Officer and your Inspector up to this nothing has been done to remedy this state of affairs. Hallinacreep village in town Rural Dist. Journals, Bonygal and Ballyshannon, Bonygal Station has a pump in it which is constantly out of order, on the day of my inspection it was.

A good water supply could easily be obtained.

Sanitary Authority should see to this.

The Clerk was directed to communicate with the Bonygal District Council in order to ascertain whether they would join with this Council in providing a water supply for Hallinacreep.

From Mr Lewis D. Lippitt Solicitor date 2<sup>nd</sup> Sept. 1899 thanking the Dist. Council for appointing him as their Solicitor for carrying out a scheme for the erection of Labourers Cottages. Mr Lippitt then states that the first step to be taken will be the preparation of maps plans & estimates of the probable cost of the whole scheme, this will necessitate the appointment of an Engineer and it is desirable that the appointment should be made as soon as possible.

The Clerk was directed to communicate with several professional gentlemen asking them if they will undertake the work in connection with the preparation of an Improvement Scheme, and on what terms.

From Congal District Council in reply to the Clerk's letter of 16<sup>th</sup> inst relative to the water supply of the village of Ballintra stating that the Congal Council considers that the Congal portion of the village is fairly supplied with water, and that they do not believe that the pump there has been out of order recently or that it was so on the occasion of the Inspecting (Dr. Plubman) visit.

From Local Govt. Board date 30<sup>th</sup> Aug. 99, forwarding to the Clerk before the Council in their observations thereon a communication received by the Board from Mr Geo. Clarke relating to

the sanitary condition of the village of Ballintra

Mr Clarke in his letter to the Local Govt. Board date Aug 8<sup>th</sup> 99, draws the attention of the Board to the fact that nothing has been done in reference to the sanitary condition of yards in Ballintra although it has been repeatedly reported on, these yards are in a very unsanitary state although a contract was taken for their repair before the new Council met, they have had it up again and again and every Councillor has a scheme of his own for remedying the nuisance and some of them agree either with the Medical Officer or their Engineers report on the matter in conclusion Mr Clarke says, we know the water as the yards are plowed all round the winter.

Proposed to ascertain whether the sewer in the street could be unaided up to carry off the water without constructing a new one.

From the Medical Officer of Health for the Dist. of Wallyshannon, reporting for the information of the Council the outbreak of Enteric fever in Wallyshannon Dist. Dist. Owing to the Sanitary Notification Act not being in force in the District, he has found it impossible to get any information as to the probable source of the disease and the Medical Officer recommends that the Act be put in force.

The Council did not think it necessary to put

the Diseases Notification Act in force in the District.

From the Medical Officer of Health of Ashamu  
Slip. Slip stating that as directed by the  
Council, he had inspected the yards where the  
slaughtering of sheep and cattle is carried on  
and that the yards in Chapel St. and the Well  
are in good condition. The houses in Hall St.  
are kept as well as they can be taking in  
consideration the manner in which these yards  
are drained.

The Medical Officer of Health also reported that  
a sewer in Buncrana between Miss Pearson's &  
Mrs Williams's premises is in an unsanitary state

Council and the reply to the communication was that the original portion of the mains was sufficiently supplied with water, and that the pump was in good order although Dr. Gibbons reported to the contrary. Mr. Thompson's letter was corroborated by Dr. Gibbons' report.

This Council would respectfully suggest that an inquiry should be ordered by the Local Government Board as to the water supply.

The following report was received from Dr. Gordon F.R.C.S.J. Consulting Sanitary Officer and Dr. Hamilton Medical Officer of Health, date 14<sup>th</sup> inst.

In accordance with instructions we have this day made an inspection of part of the town of Rathfriland. We found that the sewerage of Rockville empties itself into the Brook the water of which is used for watering cattle and probably for domestic purposes, and we recommend that it be walled in or covered over, or that the sewerage be intercepted by a tank or drained directly into the river, and in the former case that a drinking trough for cattle and a fountain be provided.

We further recommend that several ashpits and manure heaps at houses on East Rock be immediately removed.

We conducted an enfit in habitation the following houses Pat. Murray, Mrs. Kaye, and Pat. Kelly, Landlord, Nichol. Bonohue and Mrs. McLarty, and Miss Murray. We also recommend the

immediate removal of a greenhouse by Mr. [unclear] and unless he provides a back entrance and yard by the house owned by him and occupied by Miss Miss [unclear] and the house next to it, which have unemptied cesspools opposite their doors we condemn them also as unfit for habitation.

We recommend that the space to the East side of Mr. McEntee's be cleaned and a wall built 5 feet high to prevent the deposit of refuse there. The house next this space is in a dangerous condition but is uninhabited.

We beg further to state that the houses occupied by Anne Gibbons, Swollen, Sally and Mully are in a very bad state of repair, and the work requires to be immediately remedied by removing ash pits and emptying cesspools.

We recommend that the yard occupied by James Monahan be immediately cleaned.

The row of houses owned by Mr. [unclear] on East Dock have no sanitary accommodation whatever being without back doors or yards, and we do not consider them habitable.

We will report on another portion of the town for next meeting of the Council.
