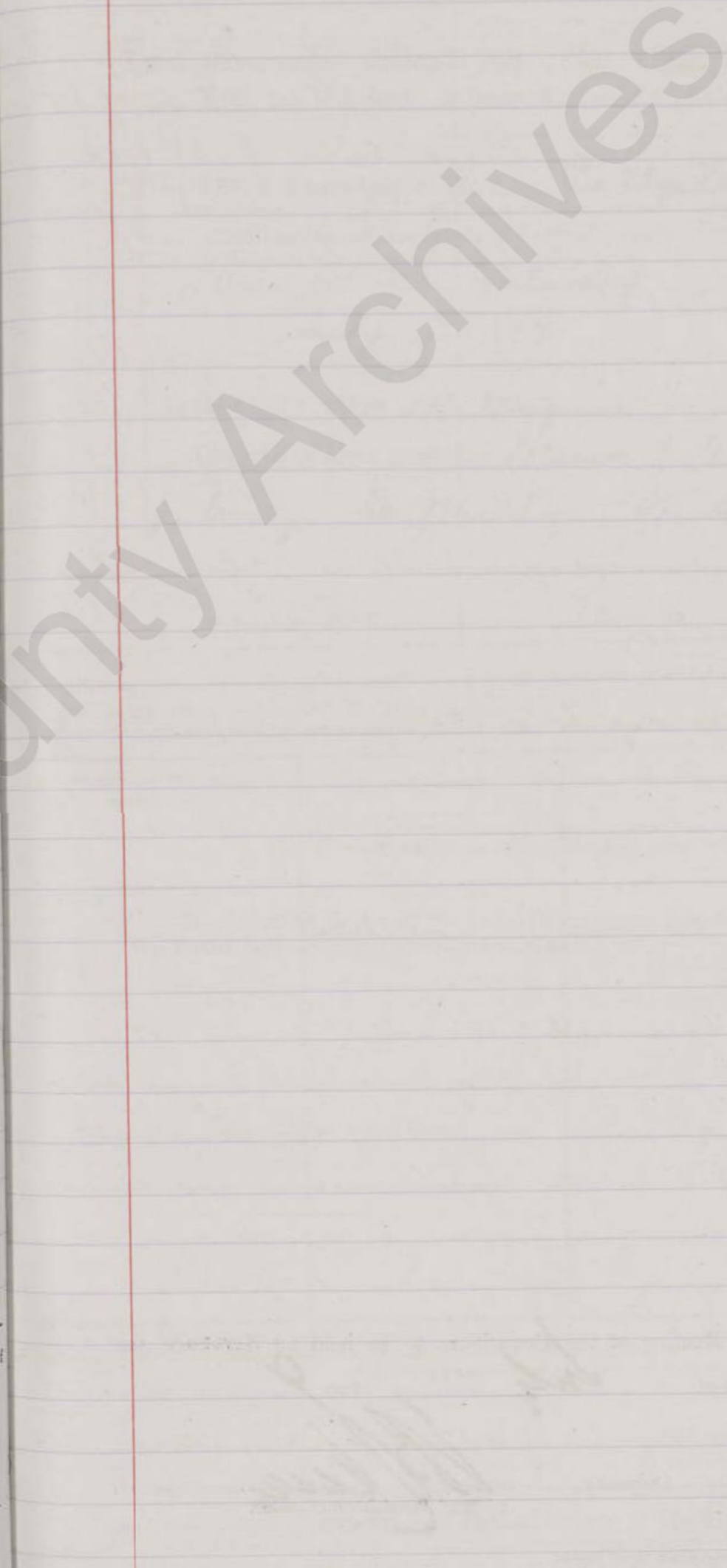

The following Letters from the Local Government Board for Ireland, or others, were read, and directions given thereon, as follows:—

From Local Government Board date 14<sup>th</sup> July 1909, stating that they observe in Councils' Minutes of 3<sup>rd</sup> Inst. an entry of the Boards letter of 26<sup>th</sup> Ult. forwarding an extract from the Medical Officers Form "h" Return for the half year ended 31<sup>st</sup> March last relating to the Sanitary condition of Ballyphannon Dispensary District, and with reference to the Order made thereon the Board point out that the absence of a sewerage scheme is indicated with sufficient clearness by the Medical Officer of Health and the Councils' proper course would be to obtain plans for a Sewerage System from an Engineer.

As regards the insanitary condition of the cowsheds and the defects in the housing of the labouring classes the Board have requested the Medical Officer to report particulars to the District Council.

Consideration of the letter was postponed -

From Mr. F. G. Townsend C.E. date 17<sup>th</sup> July 1909, stating that he had that day examined as far as possible the drainage at foot of the West Rock. One main outlet to the river is completely stopped up and the other gratings appear to be choked. Without having the drains opened in places it is impossible to make a proper report, and if the Council authorize him to have a few openings made he will be in a position then to advise the Council as to what should be done.

Mr. Townsend then points out that to leave the

drains in their present condition may be fraught with the gravest consequences, as in drains of this class any slight stoppage causes the drain to block completely. The street is too flat for masonry drains to work properly.

Mr. Townsend was authorized to have the drains opened where he considered it necessary.

The Chairman and Mr. John Gowan were appointed as a Committee to visit and report on the condition of the Workhouse Burial Ground at Mullinashce -

Proposed by Mr. Maguire, seconded by Mr. Cassidy and passed unanimously

"That having this day further considered the application of John Gavigan of Tullyherk for an exchange of site in Legation Townland and the letter of the Local Government Board on the subject date 23<sup>rd</sup> April 1909 and having considered all the circumstances we have decided, subject to the sanction of the Local Government Board to do what is necessary to change the site provided the Local Government Board permit the Council to acquire Gavigan's entire plot on the South side of the road in exchange and as the former site acquired contains only two roods and the alternative site contains three roods and thirty seven perches the Council have further decided to ask the Local Government Board to confer such powers on the Council as will enable the Council to increase the compensation awarded in respect of the original plot to such an amount as will be agreed on as compensation for the new plot.

As the completion of the exchange is a matter of urgency the Council will esteem it a favour if the Local Government Board will consider the matter at an early date -

The Engineer has been instructed to prepare a map and Estimate of the value of the extra land.

Saying the facts of this matter before the Council so that they may instruct him or write to the Local Government Board on the subject - In the Arbitrator's Award of 9<sup>th</sup> March last, James M'Intyre is described as owner and occupier of a plot in Townland of Kilbarroon containing 2 roods and is awarded £12..10..0 as compensation for same -

The Land Commission are described as chargees and awarded the sum of £11- compensation. From the Abstract of Title James M'Intyre it appears that the lands of which said plot forms a portion, although agreed to be purchased under the Land Purchase Acts by Agreement dated 1<sup>st</sup> Oct 1906 have not yet been vested in James M'Intyre consequently the landlord (the Messrs. Frederick of Camlin) are still the Owners

of said Lands, and they have refused to be any party to assisting the Council in any way in obtaining title to said lands.

Under these circumstances Mr. Reid says he is of opinion that the Land Commission are not Charge-ants at all until the advance under the Land Act is actually made, and in view of the decision of the Omagh District Council V. Henderson, he considers that at present the Council can <sup>not</sup> acquire a good title to this plot. The difficulty could be got over by either the Council waiting until the land is actually vested in James McIntyre provided he makes a good title, or to again adopt the prescribed procedure for compulsorily acquiring land under the Labourers Act. Mr. Reid requests the Council's instructions in the matter.

From Mr. R. H. Reid, Solicitor to the Council date 28<sup>th</sup> Sept. 1909, referring to the Council's instructions to take steps to procure a Provisional Order for the purpose of ~~procuring~~<sup>raising</sup> a loan for the completion of the Bundoran Sewerage Scheme—

Mr. Reid states that he has looked into the matter and having regard to Sec. 238 of the Public Health Ireland Act 1878, Sub Section 2, as far as he can see, the Council are not entitled to obtain a Provisional Order for the purpose of borrowing above the amount authorised by said Section. Mr. Reid then says he has corresponded with the Local Government Board on the subject, and they have replied as follows. "That the Board are not aware of any statutory enactment which would authorise them to make the Provisional Order applied for."

Mr. Reid in conclusion says that he is taking further advice in the matter and will write the Council again on the subject.

Notice of Claim for Malicious Injury for the sinking of a boat in Lough Melvin, the property of Henry Langtry, was received from Mr. Orr, Solicitor, Ballyshannon.

From Local Government Board date 25<sup>th</sup> Sept. 09 forwarding to be laid before the Council a copy of an Account furnished by the Reps of late Mr. J. W. O'Malley, the Arbitrator appointed for the

purpose of Ballyshannon Rural District Labourers Order 1908. The Council make no objection to the account.

From Local Government Board date 29<sup>th</sup> Sept. 1909, stating that they will recommend the Irish Land Commission to issue to the District Council a further instalment of £2500 out of the loan of \$8670- granted to them under the Labourers Acts—

From Local Government Board date 23<sup>rd</sup> Sept. 1909 calling the Council's attention to Sec. 29 of Labourers (Ireland) Act 1906, whereby the Council are required to make Regulations with respect to the letting of Cottages and allotments provided by them under the Labourers Acts and for preventing any undue preference in the letting of thereof and generally for carrying the provisions of the Act into effect. The Board also forward draft regulations with the view of facilitating the Council in the matter.

The matter to be considered at a Special Meeting on 16<sup>th</sup> Inst.

From Mr. J. G. Townsend, Architect of Labourers Cottages date Oct. 1<sup>st</sup> 1909, stating that he finds it is hardly practicable to build the four Cottages on Ed. Knox's lands in Ballyshannon in two pairs, by plots one gable of one pair tight up against the existing house, and the gable of the other pair tight up against the fence, a space is left between the two pairs of only 2 ft 8 inches. This space is practically useless, and the further gable can only be plastered by trespassing on the adjoining Owner—

By putting the houses in one block the space is increased to five feet and there is practically no difference as concerning the tenants between 2 pairs 2.8" apart and 4 in one block.

The Engineer in conclusion recommends the Council in their own interests to permit these 4 houses to be built in one block. The plots are detached from the houses, consequently no possible inconvenience can be caused.

The Council agreed to carry out the Engineer's recommendation and build four cottages in one block.

Mr. Michael Flanagan, Ballyphannon, wrote date 2<sup>nd</sup> Oct. 1909, withdrawing name as security for payment of the rent of the Cottage occupied by Bernard Keenan, in Smivres townland.

The Council cannot release Mr. Flanagan till all arrears of rent due by Bernard Keenan are paid off.

From Mr R. H. Reid, Solicitor to the Council date 11<sup>th</sup> Oct 1909, informing the Council that the claim of W. G. Morrow, of Bundoran for £50 for Malicious Injury was dismissed at Quarter Sessions—

The following report on the Sanitary condition of Ballyshannon was received from Dr. Gordon—

"I have examined and beg to report to you, the Sanitary Authority, the condition of Milltown, the Port, East Rock and Pig and Cattle Markets—There are other parts of the town in which the <sup>houses</sup> are defective, but the sanitary condition of the Districts named need your urgent attention—

Milltown = This Street is situated on the South side of the river—There are in it about twenty houses built very much below the level of the fields at the back and in consequence liable to be flooded with surface water—The place is very defectively drained, a rude stone drain rises at the back of the houses, which communicates at intervals with in the street by branches which run under the houses—The yards are narrow, low lying and too small—The houses with three exceptions, consist of one apartment, having no ceilings with defective roofs, allowing rain in—The windows and air space is insufficient and houses very dirty—

Port = Near Milltown in the Port were four or five houses which are in every respect the same as the above—

East Rock—This Street is situated between Military Barracks and the Port—The site of the houses

near the Barracks is not at all bad, the elevation, natural provision for good drainage, and for free access of good air show this—The houses with the exception of those occupied by Miss Morrow and Miss Dolan are very defective & unsanitary—The roofs are defective and allow rain in, the window and air space is insufficient in most cases the houses have one apartment only, no yards, no drains, no sanitary conveniences =

Pig and Cattle Markets = The houses in every case except one, hovels like the above consisting of one apartment, having no ceilings, defective roofs allowing rain in, and insufficient window and air space, with defective or no drains—The above is as nearly as I can give in a general report the state of affairs in the area above mentioned—

The Council will perceive what a grave state of affairs exists in the town in regard to sanitation—The prevalence of tuberculosis renders this a matter that the Sanitary Authority cannot overlook, I would advise the Sanitary Authority to at once close up the houses in the areas reported, as the houses are all in my opinion unfit for habitation—My reasons for this are insufficient room and air space, light or window space, defective drains, no sanitary conveniences, and the dangerous condition of the roofs—The following yards are in a very unsanitary condition—J. Gibbons yard, Market St. J. McNulty's Back St. Francis Dalys, Back St—Gibbons keeps a horse in his yard. The manure is too near his dwelling house and is causing a grave nuisance—Mr. McNulty's yard is full of manure, is defectively drained and he keeps cattle & horses too near his dwelling house—

Francis Daly keeps cattle and kills cattle in a very unsanitary Cow house near his house -

Gibbons should have instructions to clean his yard at once, to cease putting manure there, and to lime-wash his outhouses and yard - Mr. McNulty should be asked by the Council to have a proper drain constructed in his yard to have the manure removed and to cease keeping cattle so near his house - Daly should not be allowed to keep cattle in the house mentioned, and should not be allowed to slaughter cattle in his yard until the following conditions are fulfilled - A proper slaughter house with a well flagged smooth floor having a good drain, with walls which are kept constantly washed - No skins should be kept to putrify in the house and a good tap in the house with hose which must be used freely after each animal is slaughtered -

Mr. Reid then says that unless he receives instructions in the matter immediately it will be impossible to put through this Provisional Order till next year as the necessary advertisements must be inserted in the Papers either in the months of September, October or November—

In conclusion Mr. Reid says that in case the Council decide to take a small portion of land as above mentioned, a map of the same will be required and it is essential that the owner of the land should not contest the Council's right to the taking of it—

From Local Government Board date 15<sup>th</sup> Novr. 1909, stating that the Board have had before them the entry on Council's Minutes of 6<sup>th</sup> Inst. relative to the question of the Area of Charge for the Bundoran Sewerage Scheme—

As the Council are aware, the difficulty in connection with the completion of the Scheme is due to the fact that there is no available margin of borrowing power on the restricted Area of Charge for the Works in question—

The Board note that the Council have taken legal advice with a view to surmounting this difficulty and they have been advised to adopt one of two courses—

One course suggested by Council is that the present area of charge should be extended, and the Board desire to inform the Council that they will be prepared to give effect to the suggestion by making an Order under Sec. 1 of Public Health (Ireland) Act 1900 extending the Area of Charge when the consent of the Council to such extension is forthcoming—

With regard to the other course suggested viz "to take by Provisional Order a small quantity of land for Sewerage purposes, and to attach to the Order a Clause giving the Council power to borrow notwithstanding the limitation in Sec. 238 of Public Health (Ireland) Act 1878, the necessary money on the present Area of Charge": The Board state that in the event of the Council adopting this course

before making a Provisional Order authorising the compulsory acquisition of land in question, the Board will require to be satisfied that the land in question is necessary for the execution of the Scheme. It should moreover be clearly understood that, as pointed out in their letter of 27<sup>th</sup> Sept. last, the Board are not empowered to make a Provisional Order increasing the statutory borrowing powers of the Council— The Board are however aware that in similar cases clauses have been included in the Provisional Order Confirmation Bills authorising the necessary extension of Parliamentary Powers.

The Board further say that if the Council decide to apply for a Provisional Order authorising the compulsory acquisition of land in this case it will be necessary for them to give immediate directions to have the requirements of Sec. 203 of Public Health Act complied with, and it will be observed on reference to this Section, that the preliminary advertisements must be published at latest in three consecutive weeks in the current month in some newspaper or newspapers circulating in the District—

The Council had under consideration the telegram and letter from the Local Government Board dated 15<sup>th</sup> Inst. As regards the extension of the Area of Charge for sanitary purposes under the Public Health (Ireland) Act, the Council are of opinion that such a course is impracticable, as any move in the direction of an extension would meet with determined

opposition. The alternative course of proceeding for acquiring land for Sewerage works by Provisional Order and Parliamentary sanction was also considered. The Council decided after much deliberation to take no action at present. The acquisition of land would be troublesome and likely to be strongly opposed. The time for the statutory advertisements is too short between this and the end of the month. Altogether the Council consider the wisest course to be adopted is to postpone further consideration of the entire matter for the present and to respectfully ask the Local Government Board to give further advice with the view of having Bundoran drainage made complete and effective.

From Mr. R. H. Reid, Council's Solicitor, date 19<sup>th</sup> Novr, 1909, with reference to plots for cottages taken on the Dickson Estate, stating that the owners having failed to make title to the land in the Abbey he had to lodge the compensation in Court, and enclosing a Deed Poll for execution by the Council -

The Deed Poll was executed by the Council.

Mr. Reid also forwarded for execution a similar Deed in the case of Edward McDermott for sites acquired in the Townland of Ballyhanna but the execution of it was postponed.

from Dr. Gordon, Medical Officer of Health, relating to a case of Enteric Fever which recently occurred at the Pig Market Ballyshannon, together with a copy of a further communication received from Dr. Gordon from which it appears that the Sanitary Sub Officer failed to bring under the notice of the Medical Officer of Health the unsanitary condition of the premises in which the patient resided prior to the outbreak of the disease, and the Board request that the Council will be good enough to require the Sanitary Sub Officer concerned to furnish an explanation of his omission referred to -

The Board further request to be informed of the Council's reasons for not taking action on the representation made to them as the Sanitary Authority by Dr. Gordon, to which he makes reference in his letter of 25<sup>th</sup> Inst.

Dr. Gordon's letter referred to by the Local Govt. Board date 25<sup>th</sup> Inst. is as follows.

" I beg to acknowledge receipt of your letter of 22<sup>nd</sup> Ult. - No 138,584.  
In answer to your query I beg to state that the Sanitary Sub Officer did not report the unsanitary condition of the house in which the fever occurred prior to its outbreak.  
For the information of the Local Government Board I would like to state that I reported the sanitary condition of all the houses in the Fair Green together with the houses in Milltown and East Rock, Ballyshannon giving every detail size, situation, number of

inmates and apartments to the Ballyshannon District Council -

I recommended the Council to close all these houses, that they were unfit for habitation - The Board will find the report in the Minutes of the District Council for October 1909."

The Sanitary Sub Officer to be called on for an explanation as to his neglect to report the insanitary condition of the house occupied by Edward Nolan, who died recently of Enteric Fever -

With regard to the alleged failure of the Council to take steps to carry out the recommendation of their Medical Officer of Health in the case of Nolan's house, the Council never had a special report on the house before them - It was included the Council believe in a report which dealt generally with the whole sections of the town -

As has already been pointed out to the Local Government Board, the new houses being erected under the Labourers Acts will to some extent meet the requirements of the Medical Officer of Health and notices have been served on owners and occupiers to <sup>render</sup> ~~sanction~~ their premises sanitary - A house for Edward Nolan (deceased) was in course of completion by the Contractor under the present Labourers Act Scheme at the time of his death -

The members of the Council are aware that no tramps frequented Nolan's house -

From Local Government Board date 3<sup>rd</sup> Decr. 1909, stating that the Board have had before them returns form "L" furnished by the Medical Officer of Health of the Ballyshannon and Ballintra Dispensary Districts for half year ended 30<sup>th</sup> Sept. last, and the Board forward Extracts from the reports for consideration by the District Council.

"Ballyshannon has no system of sewerage - Old square stone drains, rudely constructed are used as sewers in most instances - Examined the cowsheds, the houses in which horses and cattle are kept, and yards in town and reported the condition of those, that in my opinion are not in a sanitary condition, to the District Council -

Consideration adjourned.

From Local Government Board date 12<sup>th</sup> April 1910 enclosing for the Council's observations thereon, a letter received by the Board from Mr. Patrick Connolly relative to his application for a Cottage in the Rural District under the Labourers Act.

Mr. Connolly in his letter date 31<sup>st</sup> March 1910 asks to be informed why he did not get a cottage, he applied for one two years ago and one was granted by the L. G. B. Inspector at the inquiry at Ballyshannon. 18 Cottages were built at Bundoran, and men that did not apply for cottages were the first to get them.

Patrick Connolly's Representation was rejected by the District Council and did not come before the Inspector at all.

The grounds of objection were.

"The applicant is a shoemaker and resides in a good house which can be improved and made perfectly sanitary."

From Local Government Board date 15<sup>th</sup> April '10 informing the District Council that an Order for the payment of £34..8..8, being the Exchequer Contribution for the year ended 31<sup>st</sup> March 1910 has been forwarded to the Board of Works towards the repayment of outstanding loans under the Labourers Act charged on the Rural District.

From Local Government Board date 13<sup>th</sup> April 1910, referring to an entry of a Notice of Motion to make Tuberculosis a notifiable disease in the Rural District and in connection the Board forward for the Council's information and guidance a copy of their explanatory memorandum relating to the Tuberculosis Prevention Act (Ireland) 1908 and the Board refer the Council especially to the Procedure for adoption detailed on Pages 5 and 6 thereof.

Consideration adjourned.

It was ordered that Mr. Steadman C. E. be asked to take the necessary steps to have the unpaid balance of Ritchie's Contract expended on the completion of the Contract, and the pipes finally tested.
