**Description and Extents**

Donegal County Council proposes to carry out development at the Údaras Industrial Estate in Derrybeg as described below.

The proposed development is located in the Údaras Industrial Estate in Derrybeg, in the Glenties Municipal District. This development seeks to provide a bring bank facility for recycling glass, cans and textiles and storage for waste prevention and management with appropriate access, parking, signage and fencing.

The project will be carried out in accordance with the drawings associated with this application and will include:

- New concrete area on which to locate the bring banks and provide safe access for the public and service vehicles
- Fencing to the side and rear of bring bank
- Signage relating to access
- Storage unit for waste prevention and management in the Glenties Municipal District
