### NOTES

1. An application for a Casual Trading Licence to engage in casual trading in County Donegal shall be made on the attached form and sent to Donegal County Council, County House, Lifford, Co. Donegal
2. The onus is on the applicant to ensure that they are familiar with the relevant Bye-laws, and that their stall does not exceed the dimensions of the Casual Trading Area.
3. An application for a Casual Trading Licence shall be made **not less than 30 days** before the first day on which it is intended to engage in the casual trading area to which the application relates.
4. Where an application is made to renew a licence the subsequent licence will run from the day following the expiration of the old licence
5. It is an offence to give false information to a local authority in relation to an application for the grant of a Casual Trading Licence
6. The fees for licences are as follows:-

5. The Council may refuse to grant a Casual Trading Licence to a person if:-
  - (a) The person fails to furnish a completed application form for a casual trading licence.
  - (b) The person fails to pay the appropriate fee with the said application form.
6. The Council may refuse to grant a casual trading licence to a person who has been convicted of an offence in relation to the importation, possession or sale of goods committed while he was the holder of a casual trading licence or an offence under the Casual Trading Act, 1995, (other than an offence under Section 5 thereof) during the period of 3 years before the date of application for the licence.
7. The Council shall not grant a Casual Trading Licence to a person who was convicted of two or more offences (each offence being either an offence in relation to the importation, possession or sale of goods) committed while the person was the holder of a Casual Trading Licence or an offence under the Casual Trading Act, 1995, (other than an offence under Section 5 thereof) if two, at least, of the convictions occurred less than 3 years before the first day on which the person proposes to engage in casual trading to which the application for the licence relates.
8. The Council shall not grant a Casual Trading Licence unless the application for the licence contains the applicants tax reference number.
10. A Casual Trading Licence, if not previously revoked, shall continue in force for such period not exceeding 12 months as may be specified in the licence
11. Upon the grant of a Casual Trading Licence the Local Authority shall furnish details of the licence to the Minister for Social Welfare and to the Revenue Commissioners.

N.B. IT SHOULD BE NOTED THAT IT MAY NOT BE POSSIBLE TO FACILITATE TRADERS AT LOCATIONS WITHIN DESIGNATED TRADING AREAS DUE TO PLOTS ALREADY ASSIGNED

**An application for an events trading Licence will not be granted if it has not been applied for, 30 days before the first trading day**
