ROAD TRAFFIC (SPECIAL SPEED LIMITS) (COUNTY OF DONEGAL)
(AMENDMENT) BYE-LAWS 2015

Donegal County Council in exercise of the powers conferred on them by Section 9 of the Road Traffic Act 2004 (No.44of2004) hereby makes the following bye-laws in respect of the particular roads in the housing estates described herein comprised within part of the administrative County of Donegal.

1. These bye-laws may be cited as above and with the Road Traffic (Special Speed Limits)(County of Donegal)Bye-Laws,2011-2012 (“the Principal Bye-laws”) may be collectively cited as the “Road Traffic (Special Speed Limits) (County of Donegal) Bye-laws 2011-2015”.
2. These bye-laws shall come in to operation on the 1st day of December 2015.
3. The Principal Bye-laws and these bye-laws shall be construed and read together as one.
4. The First and Fifth Schedules of the Road Traffic (Special Speed Limits) (County of Donegal) Bye-laws 2011 are amended as follows –

FIRST SCHEDULE

Paragraph 1 (Ailt An Chorrain) – sub-paragraph (c) is deleted.

Paragraph 31 (Clonmany) – sub-paragraph (e) is deleted.

Paragraph 32 (Convoy) – “, Milltown, Oldpark and Town Parks” is amended to “and Milltown” in sub-paragraph (a).

Paragraph 35 (An Craoslach) – “, Birch Hill, ” in sub-paragraph (g) is deleted.

Paragraph 61 (Killybegs) – “Emerald Drive” in sub-paragraph (g) is deleted.

Paragraph 67 (Lifford) – “Beechwood Grove, ” in sub-paragraph (h) is deleted.

Paragraph 72 (Manorcunningham) – “Abbey Park, ” is deleted in sub-paragraph (g).

Paragraph 78 (Muff) – “Craig Park and” is deleted in sub-paragraph (i) and in the same sub-paragraph “Estates” is amended to “Estate”.

Paragraph 86 (Raphoe) – “, Meadow Hill” in sub-paragraph (a) is deleted and in the same sub-paragraph “Estates” is amended to “Estate”.

Paragraph 93 (Stranorlar/Ballybofey) – “Glenpatrick, ” in sub-paragraph (a) is deleted.

FIFTH SCHEDULE

Delete "None" and insert the following –

"The service roads (i.e. those other than private access roads/driveways within the curtilage of each dwelling) in the following housing estates –


