#### **TEMPORARY CLOSING OF ROADS**

# Dungloe Saturday 26<sup>th</sup> July – Sunday 3<sup>rd</sup> August 2025

Notice is hereby given that Donegal County Council intends to make an Order to close the following roads to traffic on the dates and times indicated to facilitate events being held for the Mary from Dungloe Festival:

**26/07/2025** (**4pm to 12pm**) Lower Main Street Dungloe from Carnmore Road junction to Car Park entrance at Bridge Inn.

**27/07/2025** (**11.30am to 5pm**) Upper Main street Dungloe from Chapel Rd junction to Quay Rd junction

(6pm to 10pm) Lower Main Street Carnmore Rd Junction to Car park entrance 28/07/2025 (6pm to 22.30pm) Lower Main Street Dungloe from Carnmore Road junction to Car Park entrance at Bridge Inn.

29/07/2025 (7pm to 11pm) Lower Main Street Carnmore Rd Junction to Car park entrance.

30/07/2025 (6pm to 10pm) Carnmore Rd Junction to Quay Road Junction

**31/07/2025** (**12.30pm to 10pm**) Lower Main Street Carnmore Rd Junction to Car park entrance

01/08/2025(11.30am to 10.30pm) Lower Main Street Carnmore Rd Junction to Car park entrance

**02/08/2025** (**3pm to 12pm**) Lower Main Street Carnmore Rd Junction to Car park entrance **03/08/2025** (**12pm to 16.30pm**) Full Main Street Closure including the link from Main street to the Mini roundabout and the R259 to the Waterfront Hotel

(4.30pm to 11.30pm) Lower Main Street Carnmore Rd Junction to Car park entrance

### **Diversion Routes:**

Sat 26<sup>th</sup> July, Sun 27<sup>th</sup> July, Mon 28<sup>th</sup> July, Tues 29<sup>th</sup> July, Thurs 31<sup>st</sup> July, Fri 01<sup>st</sup> Aug ,Sat 2<sup>nd</sup> Aug and Sun 3rd August 2025 (Lower Main Street Closure during the prescribed times)

Traffic from Burtonport to be diverted onto the L1533-1 at Meenmore, then onto the L1543-1 at Sheskinarone and onto the N56 via the L1543-2. Traffic from Upper Main Street destined for Burtonport will be diverted onto Carnmore Road – N56 Northbound - L1543-2 – L1543-1

(Sheskinarone) and L1533-1 at Meenmore. N56 Northbound Traffic destined for Burtonport will be diverted onto the L1543-2 – L1543-1 and the L1533-1.

**Sun 27<sup>th</sup> July 2025 (Upper Main Street Closure during 18.00 – 22.00 pm)** Traffic from lower main street will be diverted onto Carnmore Road (R259) – N56 – Chapel Road (L15831). Traffic from Upper Main street will be diverted onto Chapel Road – N56 – Carnmore Road (R259).

**Wed 30<sup>th</sup> July 2025 (Part of Main Street Closure during 18.00 – 22.00 pm)** Traffic from lower main street will be diverted onto Carnmore Road (R259) – N56 – Chapel Road (L15831). Traffic from Upper Main street will be diverted onto Chapel Road – N56 – Carnmore Road (R259).

Sun 3<sup>rd</sup> August 2025 (Full Main Street Closure including the link from main street to the mini roundabout and the R259 to the Waterfront Hotel – 12 noon until 16.30 pm) Traffic from Burtonport to be diverted onto the L1533-1 at Meenmore, then onto the L1543-1 at Sheskinarone and onto the N56 via the L1543-2. Traffic from Upper Main Street destined for Burtonport will be diverted onto the N56 Northbound - L1543-2 – L1543-1 (Sheskinarone) and L1533-1 at Meenmore. N56 Northbound Traffic destined for Burtonport will be diverted onto the L1543-2 – L1543-1 and the L1533-1.

**Sun 3<sup>rd</sup> August 2025 16.30pm – 11.30pm (Lower Main Street Closure)** Traffic from Burtonport to be diverted onto the L1533-1 at Meenmore, then onto the L1543-1 at Sheskinarone and onto the N56 via the L1543-2. Traffic from Upper Main Street destined for Burtonport will be diverted onto Carnmore Road – N56 Northbound - L1543-2 – L1543-1 (Sheskinarone) and L1533-1 at Meenmore. N56 Northbound Traffic destined for Burtonport will be diverted onto the L1543-2 – L1543-1 and the L1533-1.

Persons wishing to object to the closure should submit objections in writing to Roads Central, Donegal County Council, County House, Lifford before 4.30pm on **Tuesday 8th July 2025.** 

In the event of objections to the granting of any of the proposed roads closures, the Council reserves the right to make details of the objections available to the licence applicant where it considers this necessary in order to fully consider the validity of any of the objections received.
